Minutes of a Meeting of Bleadon Parish Council that was held in the Coronation Hall Coronation Road Bleadon on Monday 9<sup>th</sup> July 2007 that commenced at 7.30 pm when the following business was transacted.

Prior to the formal meeting Mrs Beryl Davis gave a short presentation on the Weston Dial-a-Ride service. This is a door-to-door bus service which greatly assists pensioners and disabled villagers, and enables them to visit the town and other places which would otherwise be inaccessible to them. It is a valuable service which needs support. The Chairman thanked Mrs Davis on behalf of the PC.

Before opening the meeting the Chairman explained that the Clerk was unable to attend as he had been at an SLCC Meeting in London and was not able to return in time. The Chairman expressed her thanks to Councillor Clive Morris who had agreed to take the minutes on this occasion.
