The Parish Council noted that the proposals contained in the application would bring improvements to the property and to the area in general. However the Parish Council were also of the view that the windows on the front elevation were not in keeping with other properties in the area and the design contained in a previous application (11/P/0025/F) is preferred.

Subject to the above comment Bleadon Parish Council recommends approval of this planning application but requests that the following conditions be applied by North Somerset:

- It is recommended that further consideration should be given to drainage as the site is on a slope and the condition of the existing septic tank is unknown.
   Furthermore, the siting of the existing septic tank should be reviewed because of its proximity to nearby houses.
- 2. Because Roman Road is relatively narrow it is recommended that any approval should be subject to a condition that materials must be kept on site and that trades vehicles should not park on the highway.
