Unless requested, do not send any additional documents to your external auditor. Your external auditor will ask for any additional documents needed.

Once the external auditor has completed the limited assurance review and is able to give an opinion, the Annual Governance and Accountability Section1, Section 2 and Section 3 – External Auditor Report and Certificate will be returned to the authority by email or post.

Publication Requirements

The AGAR was not accurately completed before submission for review. The AGAR had to be sent back for amendment.

The smaller authority has confirmed that it amended the response to Internal Control Objective H in the Annual Internal Audit Report as, in their separate report, the internal auditor recommended that the smaller authority review the risk assessment report. The internal auditor confirmed that this was actually in relation to Internal Control Objective C. This does not follow proper practice, as only the Internal auditor should be completing the Annual Internal Audit Report.

We note that the smaller authority did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as amended by SI 2020/404 the Accounts and Audit (Coronavirus) (Amendment) Regulations 2020 as it failed to make proper provision during the year 2020/21 for the exercise of public rights, since the correct information was not published on the website.
