At the commencement of the public session, the Chair invited members of the public to speak.

A member of the public asked for an update on the status of the parish website and how much the cost of this website was per month; the Chair confirmed that an update would be given by the new clerk during the meeting and that the Council would look at how the parish may work together with another website run by a parishioner.

Clive Morris, previously Councillor at Bleadon Parish Council, welcomed the new clerk and councillors. He wished Mr Poole, previous clerk, well in his future and thanked him for his service. The Chair confirmed that thanks would be expressed in a tangible way to Mr Poole.

Prior to the formal meeting commencing District Councillor Terry Porter explained what the current position was with the District Council's proposed Core Strategy and future budgets. There will be another challenging few years ahead budget-wise with up to £7-8m to save again in the coming year. Planning is a real concern; North Somerset lost its recent court case. There was to be a briefing the following day with officers but anticipating having to build another 21,000 houses and a backlog of 1,200. NSC is awaiting further reports on ecology which will then go for assessment. There are proposals which are contrary to NSC Core Strategy; the inspectors are independent but under pressure from developers. There is also a great deal of work going on in respect of the Spatial Strategy to take us towards 2036 including B&NES, Bristol and NSC. More legal advice is being sought as planning is the area most people are concerned about. Councillor Hartree asked Cllr Porter whether NSC would revisit its strategy regarding empty properties. Cllr Porter confirmed that NSC gets charged for empty properties and he hopes there will be some imaginative solutions to the issue. He then departed from the meeting

All were thanked by the Chairman for their contribution.

(5) Neighbourhood Watch and Community Safety

Cllr Findlay reported that the group now had a full set of representatives. She commented on community safety in that there had been a spate of crimes with an attempted burglary. There have been attempts at dealing drugs to children in the park, garages have been broken into, criminal damage to cars, noticeboards and toilet rolls have been set alight and a young lad has been seriously assaulted by the group. The group is known to the police and the police know who the culprits are in respect of the drugs and assault. Cllr Findlay has contacted the police and will chase but all incidents must be reported to them to effect some action. Cllr Gibson reported that the back of the hall had been cleared so it is now less appealing for people to hand around.

Crimes are happening at other times; it is not just the Youth Club times. There is an effort to get the cctv up and running again with costs to be shared – approximately £200-£300.

The Youth Club will be asked to obtain quotations and submit to the Finance and Personnel Committee as a planned and costed item. Terms of use need to be agreed e.g. the share of responsibility

Land at Bleadon Hill Bleadon

It was agreed that as this application was considered to be a major application it would be reviewed by the full council. Parish Councillors in attendance were Mrs P J Skelley Council Chairman Mr Miles Orme Planning Committee Chairman supported by Mesdames I D Clark M E Sheppard Messrs R House C Morris K Pyke and the Parish Clerk Mr B Poole

The Parish Council strongly objects to this proposed planning application on the following grounds :

- ➤ The proposed development is outside the development boundary of both Bleadon Parish Council and that of Weston-super-Mare Town Council
- ➤ It is in an AONB Area of Outstanding Natural Beauty
- It is an SSSI Scientific Site of Special Interest
- The access to the land is extremely difficult with very poor visibility and on a road where it is almost impossible for two cars to pass
- Inadequate public transport facilities which will only increase and be exacerbated by a further housing development
- No immediate local facilities such as shops school doctor or indeed employment which will by necessity see a daily migration of vehicles and thus increase carbon pollution
- > There are no footpaths within the vicinity of this proposed development thus increasing the potential hazard for pedestrians
- > This proposal if allowed would destroy the current green belt lung between the community of Bleadon and that of Weston-super-mare which has always been clearly different in its individual identity.
- The Hamlet of Hilcote would be badly effected by this unnecessary proposal
- > It is clearly overdevelopment of the site
- There is no street lighting at present and further lighting from a development of this size would increase light pollution
- Because of the current agricultural nature of the land it has a natural fall off which would be adversely effected by additional hard landscape areas which would then impact on a drainage system which is not currently fit for purpose
- Any proposed development would destroy the much valued fauna and flora currently situated in and on this agricultural land
- Due to the proposed development location it would be highly visible and therefore detract from the current views of the Mendip Hills
- ➤ The developer states that this development will help towards the much needed housing in the locality. Bleadon already has an approved application for 49 houses on a Brown Field Site and it is not therefore necessary to take much valued agricultural land.
- Site of an ancient burial ground
- Church Commissioners covenant on part of the land which states only 5 properties per acre are permitted to be built. This proposed development far exceeds that restriction

(h) Neighbourhood Watch & Community Safety

Cllr Findlay expressed disappointment that there was no PCSO report available. Cllr Sheppard said that the PCSO will be patrolling on a nighty basis. Cllr Clarke asked whether the saddle stones can be replaced to stop people driving on the area formerly covered by them. The Open Spaces Committee will look into this.

A question was raised regarding the degradation of the new white lines in the car park and the clerk was asked to look into this asking Mr Bruce Poole of the outcome.

Cllr Clarke asked whether the new top of the wall could be treated to make it look in keeping with the rest. Cllr Gibson advised that it will weather in time.

The village plant up was discussed – this is in this year's budget. It was resolved that the plant up would take place on 24th October at a cost of £206
