The Clerk pointed out that following an ordinary election should there be insufficient persons nominated to fill the all the available seats the parish has 35 days from the date of the election to co-opt persons to fill those vacancies without the necessity of advertising for a potential bye election. Following the recent announcement in the "Bleadon News" where an article had suggested that volunteers were needed to fill the spaces a number of people as listed offered their services.

(Section 39(4) Representation of the People Act 1983 and section 21(2) Representation of the People Act 1985)

It was pointed out by Councillor Findlay that due to insufficient members being elected to the Parish Council it will as a consequence be debarred from using The General Power of Competence and at the same time would have lost Quality Council Status. As to the latter the Parish Clerk indicated that due to changes to this award scheme the Parish Council qualified as a Foundation Awardee which would expire on the first of January 2016 when it would be necessary to re-apply for accreditation under the new scheme.

As a result of these discussions and the seemingly apparent uncertainty M/s Georgina Peacock indicated that she no longer wished to be considered for co-option. The clerk also indicated that he had received an indication of an offer to volunteer which had been received after the circulation of the agenda from Mrs Maureen Reynolds.
