Minutes of a Meeting of the Planning Committee of Bleadon Parish Council held in the Coronation Hall Coronation Road Bleadon on Monday 11th January 2016 which commenced at 7.15 pm when the following business was transacted:

PRESENT

Councillors I Gibson Council Chairman Mesdames I D Clarke C Findlay C Gutsell & M Sheppard , Cllr S Hartree and the Clerk Miss H Brinton

There were 12 members of the public, Cllr Terry Porter, Becky Parker from Weston Mercury

Before the meeting commenced, the Chair asked if any members of the public would like to speak.

Mr Mike Marsh from Gorselands on Roman Road, owner of Goreslands Camping and Caravan Club spoke regarding an application submitted to North Somerset Council – he is the owner of access to the property and is interested in the North East corner of the plot. He wished to object to the application for the Marley House alterations which includes rooflights overlooking his site. Mr Marsh felt he resolved this orally but this had proved not to be the case. He is a chartered architect and believes the application to be a gross over development of the roof with an attic and trusses ostensibly for storing paperwork. He is very concerned looking at the plans as he feels that the proposal will turn into a house in its own right one day. There used to be a simple lean to which was raised without the necessary permissions and a 1.5 storey building became a two storey one – he prevailed upon council to reject the plans.

The Chair thanked Mr Marsh for his contribution and brought forward item 56.4 15/P/2795/F. He commented that the premises had been visited by members of the council today and council was going to recommend a major objection to the proposal based on overdevelopment of the property and this would be the council's recommendation to North Somerset Council.

Mr Roger Cook also addressed the meeting briefly commenting that he felt the same as Mr Marsh and his interest covered the North West corner of the site.

He further commented that his worry also surrounded the application for retrospective planning permission as the parish council should have the opportunity to comment before the application was made.

Cllr Findlay agreed with the observation but felt that the traffic had already increased – she did agree with Cllr Hartree's comments however.

Resolved to object to the application on the grounds of a permanent increase in traffic flow rather than seasonal as is current
