# Covid Shots Kill And Injure Hundreds

55 in the US, 22 in UK and 29 in Norway known to have died after taking the shot

**While the world's governments, corporations and media system are all guns ablaze pushing the experimental drugs from Pfizer, Moderna and AstraZeneca/Oxford Group, the injuries and deaths occurring within hours, days or weeks after receiving the injections should make people pause for thought before getting the shots themselves.**

Despite covid-19 deaths including anyone dying of anything at all within 28 days of a positive PCR test result, all reports referring to the pharma deaths include press releases from the multi-billion pound corporations making them which invariably state: 'it is not known yet whether the vaccine is responsible' - this despite perfectly healthy people like Dr. Michael Gregory of Florida dying after receiving the Pfizer shot. He was a 56-year-old medical worker at Mount Sinai Medical Center in Miami, and was injected on Dec. 18 last year. 16 days later, he died.

Michael's wife Heidi Neckelmann said on Facebook that her husband was "very healthy" before being injected. She said he was admitted to an intensive care unit with a diagnosis of acute idiopathic thrombocytopenic purpura, a blood disorder, caused by a reaction to the shot. "Do not let his death be in vain, please save more lives by making this information news," she said.

At The Commons on St. Anthony nursing home in Auburn, New York, 21 residents have died at the home and three in the hospital, but there had been no nursing home covid-19 deaths in Cayuga County at all until the first three deaths at the Commons were reported Dec. 29. They began injecting on Dec 22nd.

In Ireland, Doctor Kershav Sharma a respiratory consultant who practiced in Wexford hospital, took the shot on Tuesday 5th of January. Five days

later he was found dead at his home.

Legendary baseball player Hank Aaron died 18 days after receiving the Moderna injection, in an attempt to encourage black Americans to take it.

In India, a 52-year-old hospital worker in Moradabad, Uttar Pradesh died a day after receiving the injection. The man's son told local media that he believed his father had a "bit of pneumonia, cough and cold" before taking the shot, but "started feeling worse" after the injection. The man later complained of congestion and chest pain and was rushed to the hospital, where he was declared dead.

A second death was reported in Bellary in Karnataka. The 43-year-old male was injected on Saturday and died on Monday. The government says the man suffered from cardiopulmonary failure. It's unclear which drug he was given. India granted emergency approval to two variants of the covid-19 drug earlier this month: Bharat Biotech's Covaxin, and Covishield, a jab based on the AstraZeneca/Oxford formula and manufactured by the Serum Institute of India. A 46-year-old healthcare worker named Mahipal Singh also died on the 17th of Jan. just 24 hours after being administered the Covishield coronavirus vaccine shot according to [BusinessToday.in](http://BusinessToday.in).

29 people are known to have died in Norway within days of receiving their first dose of the Pfizer covid-19 shot, with 13 of those deaths apparently related to the side effects, health officials admitted. All 13 were nursing home patients and at least 80 years old.

Specialists from Germany's Paul Ehrlich Institute are looking into the deaths of 10 people who passed away soon after having received shots, Brigitte Keller-Stanislawski, the head of the institute's department of safety



of medicinal products and medical devices, stated.

In Britain, 22 people at a care home in Basingstoke, Hampshire run by Avery Healthcare all died after receiving the shot since Jan. 5th. There is no rational reason why the MHRA and all concerned are not linking the deaths to the shots, but they insist on denying it instead.

Stockton-on-Tees nurse Demi Lambe reported being paralysed after receiving the shot, unfortunately she

was still in this condition at the time of going to press.

Julie and Jerry Christensen suffered the tragic loss of Julie's mother, writing on social media: "My mother was exactly one month from her 80th birthday, had no underlying health conditions, and like a light switch, became unresponsive. I'm broken-hearted that we were separated for the past ten months due to senior care home covid regulations and now we are forever physically

separated. I don't even know how to share this with my family and friends. It is so alarming, shocking, and hard to swallow for all of us. I can't hide it any longer."

Janette Brown's father took seriously ill after receiving a covid shot. She wrote on Facebook, after the tech giant had removed her original post: "he has had a serious reaction to it like many others I have spoken to now around the world; his body can not stay still for one second to allow him to rest - it's agony as it's constantly jerking, like convulsions. I have never in my life seen anything like this, the hospital said they can't help as they don't know what this injection causes yet so we are stuck."

Gibraltar had suffered relatively little from covid before the 9th January this year, with only 17 deaths for the whole period. Since then, 'covid deaths' per million have rocketed to 3rd place on the Worldometer site. 36 more deaths in little over a week after the RAF flew in nearly 6,000 Pfizer shots, cooled to -70C by dry ice. They were put to use quickly to avoid the risk of degradation. Once again a clear relationship between roll-out and increased 'covid deaths.'

Zachary Steiber reports in the Epoch Times, 55 deaths following covid injections in the United States: "In some cases, patients died within days of being vaccinated."

A 66-year-old senior home resident in Colorado, was sleepy and stayed in bed the day after getting Moderna's injection. Early the next morning, he "was observed in bed lying still, pale, eyes half open and foam coming from mouth and unresponsive." The VAERS report states: "He was not breathing and with no pulse."

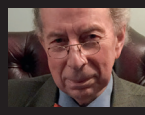

# First Mask Discrimination Case Settled For £7,000

**A disabled woman assisted by Kester Disability Rights has been paid £7,000 in compensation by a service provider who refused her access to a service because she was unable to wear a face mask.**

The pay-out was achieved through negotiation as there was no dispute that access had been



denied, or that the Claimant had a disability exemption. The only thing to be agreed was the amount of compensation, not whether it was due or not.

Refusing access to people unable to wear face coverings due to disability is direct discrimination—no different to denying access to a black or gay person for example.

Disabled people are now routinely harassed in public for not wearing face coverings—frequently given the impression that confidential medical information must be publicly disclosed to justify exemption. The fact that shops and hospitality businesses routinely display “no mask no entry” signs shows how deeply disablist attitudes are embedded in society. If premises displayed “no blacks” or “no gays” notices there would be outrage.

Several supermarkets began vigorously challenging those exempt from wearing a face mask last month as the Johnson regime ramped up its fearmongering through compliant and

unquestioning channels such as the BBC and Sky News.

Emails received back from their head offices and shared widely on social media reminded staff that it was illegal to question why someone was exempt, and refusing entry or service could well result in a prosecution and hefty fines for which staff themselves were personally liable.

Fortunately the official government position does not endorse any of this as nobody exempt from wearing a mask is expected to go around justifying themselves. Saying “I’m exempt” is enough. If the response to that can be proved to be discriminatory then compensation is due. Any such interaction, altercation and blatant discrimination should be video recorded for evidence, as the Kester case proves there is remedy in law for those who are offended against.

# Children No Longer Matter - Open Schools NOW

**A Private school headmaster in Newbridge, Edinburgh has hit out at the government’s wrecking of education.**

Taking to the Clifton Hall School Facebook page, Rod Grant wrote: “Children no longer matter. In 31 years of teaching, I don’t think I’ve ever felt so despondent and so concerned at the same time. Our world is in the grip of a pandemic and governments across the globe have poured billions of pounds into fighting it and in trying to support the lockdown strategy. Makes me wonder why we couldn’t tackle other issues globally and so ferociously in terms of spend.

What about the climate emergency? The obesity pandemic? The fact that in 2021 we still have people living on the street; that it takes an international footballer, Marcus Rashford, to shame the British government into feeding

children during school holidays. And what does that also tell us about the current levels of poverty in the UK?

What about the 1500 people that die every day in the UK from the big three: heart disease, strokes and cancer-related illnesses. Why haven’t we taken these issues as seriously as we have a virus which is likely to end up with a mortality rate of well below 1%, and which, according to the Office for National Statistics has an average age of death in the UK of 83. Meanwhile, in Glasgow, Scotland’s largest city, men have a life expectancy of 71.

I’m not a conspiracy theorist; I’m not some radical on the fringes of a fringe,” he added, “I’m just a teacher and this is what I see: In the last three months, in my school and in schools like it, I am witnessing mental health

issues unlike anything I’ve seen in my career. This is not me trying to be dramatic or to overplay what lockdown actually does to children.

I am seeing children being diagnosed with clinical depression, increasing rates of self-harm (even in Scotland, where we already had the highest rate of self-harm in 15-year-old girls anywhere in the world, bar one), suicidal ideation and, something I haven’t seen for at least 20 years, a resurgence of eating disorders.

Add to this, those students who are displaying worrying levels of stress and anxiety; the same students that describe online learning as stress inducing.

Anyone that has been involved in a Zoom meeting knows how stressful it can be and yet the great solution to our educational recovery is online learning. Well, I’m an educator and I think, at best, it’s a horribly poor

substitute for in-school learning.

Right throughout this pandemic, the needs of our children seem to be at the bottom of every Government’s priority list. The cynic in me might suggest that it is because they can’t vote. Fortunately, I’m not cynical. To me, it’s actually just as worrying though to suggest that kids don’t really matter that much if they are not dying.”

The frustrated teacher continued: “At the moment, there seems to be no alternative voice; no political party willing to stand up for children’s plight, no media criticism; merely, more nodding in agreement that lockdown is the only solution.

Well, just remember in our attempts to suppress a virus and ‘to save the NHS’ that the price we pay is the downward spiral in the mental well-being of our children and a legacy of under-achievement as a result.

Last summer, individual children were the lowest priority in Government as seen in the examination results fiasco. As of the 2nd January, there is not one single hospital bed available for any young person suffering from mental health issues anywhere in Scotland. The current waiting time for a mental health appointment with CAMHS in the Lothians is six months. Utterly disgraceful.

Children need to be with their friends. They need to play. They need to develop their social and academic skills. How dare we have created an environment where a 5-year-old can say, ‘I can’t play with Freddy because he’s not part of my bubble’. It is the stuff of nonsense and it is our children who will end up being this lockdown’s ‘collateral damage’.

Schools need to be OPEN and they need to open NOW.”

In another case, a 93-year-old South Dakota man was injected with the Pfizer-BioNTech drug on Jan. 4 around 11 a.m. About two hours later, he said he was tired and couldn’t continue with the physical

therapy he was doing. He was taken back to his room, where he said his legs felt heavy. Soon after, he stopped breathing. A nurse declared a do-not-resuscitate order.

Pfizer stated: “The number of

incidents so far is not alarming, and in line with expectations.”

It is saying something when a company can accurately predict deaths from its products and be championed by governments and

media outlets. This is more a grand marketing campaign than a health epidemic. What is most alarming is the very real potential for the ‘vaccine’ marketing campaign to indeed cause a very real health crisis,

## From Science To Dogma

**How did we reach a stage where unprecedented dystopian measures are justified in the name of one of man's noblest pursuits?**

The greater closeness between science and technology in modern times is not in itself directly responsible. Rather, the quality of this closeness, and hence the orientation of European science, were highly influenced by the perspective of profit maximisation within which it developed. As stated in its first charter, the Royal Society aimed at "promoting the sciences of natural things and of useful arts", and its ranks included prominent merchants with no scientific or technical background. Science, technology, and commerce were thus officially made into interconnected ventures from the outset.

Conversely, the first stage of the shift from merchant to financial capitalism was enabled by both science and mathematics. Principia Mathematica, as explicitly stated by Newton, was as much motivated by astronomical concerns as by desires to improve machinery. Alongside, chemistry played a prominent role in bringing science closer to industry. Efficient mechanisation contributed to expanding industries, extensive colonies, civilian and military transport back and forth, as well as population growth. These required increasingly more energy.

The new field of thermodynamics - the study of the conversion of heat into work - was born in the early 19th century, motivated by the need to improve the steam engine. Electrodynamics, the other major scientific achievement of the time, stemmed as much from the desire to understand a natural phenomenon as from the necessity to magnify the efficacy of the transformation of kinetic energy into work.

The study of electricity contributed to a major change: the integration of

research within industrial settings, with little to no connection between research and management, research being subservient to the latter. In the framework of the anonymous shareholder system, it must incessantly aim for a maximum amount of ever more profit. In other words, a capitalism where the aim is not just profit, but its maximisation, was now in place.

This influenced science as a whole, even within academic institutions. Not only was the goal of science transformed into the sustenance of profit making but it was itself transformed into a wealth-generating activity. The notions of intellectual property and of patents were elaborated at this time, and had begun to be actively exploited by scientists. The value of a scientific piece of work was now given by the amount of money it occasioned. It is not that science is above or below money, it simply has no relation to it. Hence, the choice of an inappropriate criterion for science opened the path towards its distortion.

Indeed, science, being the reasoned study based on reproducible and sufficiently reproduced observation of properties describable through comparison of the sense-perceptible world - a study encompassing interactions with natural surroundings - must at any given time conform to all known data. It thus warns us when the gap between our theories and reality becomes too significant. It indicates when the impact of our actions on our environment generates alterations to natural conditions that may be harmful for us, at least once this impact is detectable by existing means.

Hence, an economic system can no longer be sustained or justified by science once it induces inordinate alterations. Incessant and increasing

material growth must perforce rely on advanced research, generating incessant and increasing alterations to our environment, which become less and less suited to human life. So there must come a point where to maintain course this research loses its scientific nature and refutes science itself.

As profits kept soaring, this point was crossed unnoticed. Thus science, the opposite of dogma - always open to the modification or abandonment of its theories in view of later data, powerful precisely because it recognises its limits, was distorted into a new creed, scientism - a set of tenets which claim to be science, yet do not display its characteristics, in particular which do not rest on sufficiently reproduced and reproducible observation-based reasoning. They must therefore be taken on faith.

Deviating from a scientific path was eased by the shortcomings science is riddled with. The complexity of nature is beyond human comprehension, forcing us to simplify and thus to found our theories on approximations and assumptions. We may be guided by the quest for truth but we can never know whether our ever-evolving scientific understanding is taking us towards any truth. What it does is guide us away from untruths.

Accepting untruths in the name of truth for more than a thousand years has left profound traces on European science, especially as the latter never got sufficient space and time for a serene development away from religious or political pressures. All too rapidly institutions of learning, which had been under Church control, were brought under that of centralised governments.

Belief in divine miracles was replaced by belief in a miraculous science that would better (indeed, has bettered) material life, as well

as provide the answers to the basic questions of life; belief in the objectivity of religious dogmas became belief in an objective science whose sayings are indisputable. All signs to the contrary were ignored until quantum mechanics forced their consideration. However, the damage was already done, and any reassessment has largely gone unheeded.

Science is a search for unity underlying diversity and recognises its own subjectivity, while scientism cloaked with characteristics mistakenly attributed to science formerly, seeks to uniformise under one world view as it professes to mirror the truth, which must therefore be enforced on all. In the name of Christianity distorted into dogma, the full repressive power of the Church was unleashed on cowering populations. In the name of science distorted into dogma, the full repressive power of the State is now unleashed on cowering populations.

Like spiritual aspirations formerly, scholarly ones are now enmeshed in moneymaking. Research has become fully entrenched in the global marketplace. Its subservience to the economic ideal or simply conformism is maintained by funding policies and by a culture of prize, initiated by a forefront industrialist of the then nascent military-industrial complex, Alfred Nobel, precisely when monitoring research became essential.

When the content of research is closely monitored, when the watchwords are competitiveness, efficiency and standardisation, when a self-appointed coterie heap congratulations on each other, when those pretending to speak in the name of science have forgotten to question, the consequences on the nature and quality of knowledge are evidently most serious

As for the uninitiated, they are

kept in awe and made to realise that doctrinal discussions are a matter of experts, just like the spiritual world was once said to be only knowable through the Roman Church's priesthood, so the sense-perceptible world is now said to be only knowable through the new priesthood. The edicts of scientism are shrouded in the mysticism of mathematics, the latter having replaced Latin as the language of the Cognoscente. Thereby the simple is made to look complicated, the absence of solid foundations of a theory is obscured, and attention is diverted from the basic questions.

This is not to say that science is not fighting back. In spite of consequences to themselves, like their predecessors in other sombre periods, scientists are displaying admirable integrity and courage to continue work when it clashes with approved conclusions.

However, by systematically ignoring their warnings and having recourse to outright distortions to keeping to the path of incessant profit, a stage has been reached where resources have nearly been squeezed to their limits and can no longer sustain yet more financial profits. This has resulted in the virtualisation not just of the economy, but of increasing aspects of human life, regarded as a huge computer whose underlying programs can be transformed at will, and which can be merged with the machine.

There is however a basic fallacy with a machine-made virtuality that denies our given reality. It will break in sooner or later. God, if there be one, might or might not 'play dice'. But by attempting to change the basic unalterable principles of life, thereby pretending to be gods, we are certainly playing dice with our own fate.

# Face Masks: What We Can Learn From Proxemics

**Pro-mask? Just wearing one to be polite or because the telly says you must protect your mate? Forced to don at work unless exempt?**

Government mandating of face coverings, ostensibly to mitigate against covid-19 transmission, has proved divisive. Supporters highlight their efficacy as ‘source barriers’ in trapping SARS Cov-2 virions. If masks truly block the ‘rona’, why not keep them to suppress other seasonal viruses like flu? Certainly, Jonathan Van Tam, England’s deputy chief medical officer, considers mask wearing to be a beneficial ‘habit’ that ought to continue. So remind us why we’re still in lockdown?

On the other hand, detractors question the ‘science’ behind mask use. First, SARS Cov-2 aerosol virions, at less than micron in size (one millionth of a metre), are too small to be contained by a fabric weave. Many doctors have compared it to trying to keep out mosquitoes with a chain-link fence. Secondly, thanks to recent randomised control trials, especially the celebrated Danish study of 6000 participants, there is a lack of correlation between masking-up and reducing covid-19 infection.

Finally, if we accept that masks impede viral spread, then might the accumulation of particles render

cloth surfaces unhygienic? Dr Vernon Coleman has alerted readers of *The Light* to the potential hazards: sore throats, chest infections, not to mention shortness of breath and hypercapnia (a build up of carbon dioxide in the bloodstream).

Such discussions are binary, either you believe face coverings work as practical non-pharmaceutical interventions or you don’t. If we are to challenge official messaging around face coverings, we must problematise the debate. Proxemics enables us to do so.

What is proxemics (pronounced proxeemics)? Essentially it is the study of how humans organise surrounding space with respect to other people. It was theorised in the 1950s by Edward Hall, an American anthropologist tasked with training diplomats to avoid faux pas when engaging with different cultures.

To achieve this, Hall recognised that human beings on the whole – albeit with slight cultural variations – prefer to manage social interaction over set distances. He formulated four zones; public space where people are comfortable encountering strangers at around 2-4 metres, social space for formal interactions

at 1.2-2 metres, personal space for conversing with friends at 0.5-1.2 metres, and intimate space up to 0.5 metres—reserved for contact with close family or romantic partners. Hall’s model may be proscriptive, nevertheless it has contemporary application, for example in human / robot collaboration or in virtual reality simulation.

Proxemics is equally relevant to the mask debate; people don’t like getting close to one another, and certainly refrain from breathing heavily in each other’s direction. Is there something evolutionary at play?

The theme was explored earlier in 2020 within fascinating interdisciplinary work by Colin Axon, an engineer at Brunel University and the sociologist Robert Dingwall, which deserves to be better known. Writing in the *British Medical Journal*, both argued how the physical and social sciences could contribute towards the understanding of airborne viral transmission, something lost in the scary graphics shown on TV—you know the simulated manikin exhaling toxic plumes laden with deadly pathogens. Yikes cover your face!

Axon and Dingwall took issue with the imaging, largely because it misses the temperature differential between the human body and its

surroundings. As such, exhausted air travels at most 20-30cm from the mouth or nose, yet it egresses upwards, since the body’s internal heat, around 37C, is warmer than most outdoor or indoor temperatures. (Think breath condensing on a frosty day). Convection currents surround our faces. These protect us from respiratory mixing short of Hall’s personal space, where most human contact occurs.

Admittedly SARS-Cov-2 virions might remain suspended to ensnare the unwary, although the inoculum size would have to be sufficient to induce serious illness, something that matters more within hospitals; covid-19 is nosocomial.

Yet within public indoor settings, where the law enjoins mask use, particle suspension may not be an issue. This can be attributed to the ‘stack effect’ in buildings, where cold air creates buoyancy for warmer air to trickle through natural ventilation. Commercial buildings, such as supermarkets, restaurants, cinemas (all now mask zones) and offices utilise air conditioning, which is purposefully designed to extract dust and bad odours; while virions follow the direction of travel. Modern trains are similarly equipped. TfL recently found no traces of coronavirus in air

tests along its bus and tube networks

Research on the effects of airflow on SARS-Cov-2 virions is ongoing. However, from the perspective of proxemics, face coverings seem a superfluous intervention, more so if—as we know – only one percent of the UK population is infected. What are the chances of an infectious person crossing into your personal space?

Government messaging around masks is disingenuous. Masks hinder everyday social interaction and they were deliberately intended to achieve this. A return to normality means communicating freely. Take off your mask.

# Gene-Edited And GM Crops ‘Highly Unlikely’ To Make Food System More Sustainable

**Will genetically modified gene-edited crops, foods and animals improve the sustainability of food and farming?**

A comprehensive new scientific review addresses this question by investigating the record of old-style transgenic GM crops and the potential and reality of newer gene-edited crops and animals.

The review, by Dr Allison Wilson of the Bioscience Resource Project in the US, is titled, “Will gene-edited and other GM crops fail sustainable food systems?” and forms part of a forthcoming Elsevier book, *Rethinking Food and Agriculture*. It takes in GM golden rice, GM herbicide-tolerant (HT) crops, and GM Bt insecticidal crops, and looks at the unintended effects of both old-style GM crops and new gene-edited crops.

It finds that “the widespread use of Bt and HT crops has led to the problematic development of pest resistance, superweeds, and secondary pests. In response to these problems, “farmers increased both insecticide

and herbicide use. Some also increased tillage and other mechanical methods of weed control.”

The review notes that attempts to develop GM golden rice have been plagued with technical difficulties. These include unintended effects such as defective growth and performance and low levels of beta-carotene, the substance that is intended to be converted to vitamin A in the bodies of the malnourished people targeted for the rice.

Other GM crops show a wide variety of unintended traits. Research on large populations of transformants – cells or organisms, such as plants, into which foreign DNA has been introduced – reveal frequent “defects in basic agronomic traits such as yield, height, stem, and leaf morphology” (structure).

Contrary to claims by the GMO lobby that plants with unintended traits are screened out before they are brought to market, Dr Wilson points

out that even commercialised GM crops contain many unintended traits, many of which have implications for sustainability. MON810 maize, for example, has numerous compositional differences compared with the non-GM parent crop, including increased lignin (which makes cell walls more



rigid), the presence of an allergen, and increased moisture content. MON810 also has negative impacts on beneficial soil organisms. A table in the review lists examples of some of the many unintended traits that have been identified in commercial GM crops.

Will gene editing increase the precision and thus effectiveness of genetic engineering technologies? Dr Wilson writes that the evidence thus far shows that gene editing is “also prone” to introducing unintended effects. This is partly because virtually all gene editing protocols utilize standard GM techniques and also because “new evidence from both animals and plants indicates that gene editing itself can result in unintended mutations at or near the target site”. Numerous studies cited in the review “support the conclusion that plant gene editing outcomes are imprecise and unpredictable, and that, depending on the combination of techniques used, gene editing can be highly mutagenic” (causing DNA damage).

As with older-style GM, Dr Wilson notes, the number and type of unintended effects introduced using gene editing will depend in part on the new trait being introduced and in part on the unintended effects wrought on the genome by the techniques themselves. So contrary to the messaging of pro-GMO lobby groups and organisations, Dr Wilson says that there can be no shortcuts when it comes to regulating these techniques: “All benefits, hazards, and risks must therefore be assessed experimentally on a case-by-case basis for each independently derived nGM trait and crop... This should include whole genome sequencing comparisons with an isogenic line and -omic [molecular profiling] analyses.”

Dr Wilson concludes, “While in theory it might someday be possible to create a GM crop that meets the broad requirements of sustainable agriculture, in practice this seems highly unlikely to ever happen.”

# What Exactly Do The WHO Do?

**The World Health Organisation (WHO) is the embodiment of an organisation whose policy and strategy is directed by the pharmaceutical corporations it apparently regulates and not the citizens it supposedly serves.**

This is unsurprising when 76% of WHO funding is from voluntary contributions—notably foundations and pharmaceutical companies who wield unimaginable influence over world health policy. This cosy financing relationship between the regulator and the regulated has resulted in one man alone, the anodyne Bill Gates, being crowned the Tsar of international public health. Why not? Gates contributes 20% of WHO funding through the Bill and Melinda Gates Foundation (BMGF) and GAVI—The Vaccine Alliance. It is no secret that money buys influence.

This corporatised takeover of world health policy bears many hallmarks of the Fabian-envisaged world run by a ‘body of experts’. Only this time, the ‘qualified rulers’ are multinational pharmaceutical corporations and billionaires and the role of intergovernmental organisations like the WHO is to help them sell patented drugs.

Not much has changed then since the days of rule by royal dynasties, where the richest and most powerful bloodlines ruled the land. The difference nowadays is that the wealth of billionaires like Gates and the influence of pharmaceutical corporations buys the necessary political influence to set public policy and agenda. In her brilliant documentary, *Trust WHO*, filmmaker Lilian Franck reveals the unhealthy ties between the WHO and big lobbying firms.

For example, it was not until the late nineties that new regulations began to emerge around the dangers

of smoking. This was largely down to big tobacco’s lobbying the WHO since the 1950s to downplay the public health risks associated with smoking. This gave rise to the iconic cigarette advertising campaigns of the eighties and the smoking epidemic that followed, despite the dangers of smoking being long understood by health professionals, especially the WHO.

Likewise, the nuclear industry has been a strong lobbying force behind the WHO around events like Fukushima and Chernobyl, to

effectively gloss over the effects of radiation poisoning, in support for the feasibility of nuclear energy.

To fully understand the strategy of the WHO throughout SARS-CoV-2, it is important to note the agency’s erroneous declaration of the Swine Flu pandemic in 2009. Following unorthodox relaxing of rules around the definition of a ‘pandemic’. Specifically the ‘severity of illness’ and ‘mortality rate’.

Swine Flu brought about a new culture of disease classification where you could now have a pandemic with zero deaths. These amendments took place following secret deals

between European governments and pharmaceutical giants GSK, Sanofi and Novartis. Resulting in a paycheque for Big Pharma in the region of \$18 billion dollars for a vaccine that was not required, for a pandemic that did not happen. Later, The Parliamentary Assembly of the Council of Europe (PACE) held an emergency inquiry into the “influence” exerted by drug makers over the WHO, for a disease that it transpired killed between one third to one tenth the rate of seasonal flu.

In 2020 the WHO crowned China the global pacemaker for a new phenomena known as lockdowns.

Unsurprising when Tedros Adhanom became the WHO’s first non-doctor Director-General, amid allegations of heavy lobbying by CCP diplomats. Adhanom was effectively China’s dog in the fight, despite an appalling track record on public health and human rights.

In 2017 Adhanom was accused of covering up three cholera epidemics as Ethiopian Health Minister, when he had served as a central committee member for the Tigray People’s Liberation Front—a marxist political party accused of crimes against humanity.

Preceding his appointment at the WHO, Adhanom was Chair of The Global Fund to Fight AIDS, Tuberculosis and Malaria (an international financing organisation established in 2002 with seed funding from Gates’ BMGF. Later he served as a board member of GAVI, another BMGF public health hydra. Prior to 2020 the WHO’s reputation was blemished by multiple controversies, with calls from the international community to rethink global health policy and especially the role of the Specialised Agency of the UN.

The Lancet published an independent report calling for the WHO to be stripped of its role in declaring disease outbreaks, and the journal Nature called out their poor response to the Ebola outbreak of April 2014, when it took the agency until August of that year to declare a global emergency.

Later In 2017, the WHO were criticised for allocating \$200 million a year for executive travel expenses—exceeding the agency’s combined budget to combat AIDS, tuberculosis and malaria. Reminiscent of how the Red Cross raised half a billion dollars for Haiti, and built just six houses.



## War On Truth

**After waking up in May to the lies being fed to us from the government, my husband and I started attending some of the pro-freedom protests in London.**

I told them I had said that “I am going to the war memorial as usual, to pay my respects and to observe the two minute silence, in protest that the service was cancelled”. I added that it was a public post and to go look at it if they needed any other information.

One of the officers then returned the next night with a Community Protection Notice (CPN). Reading

through it he stated that I was encouraging people to break the upcoming lockdown. When I said that the lockdown hadn’t even been announced when I was delivering the leaflets, he said that it didn’t matter.

An uncle of mine informed me about Rebel News and their “Fight The Fines UK” campaign. I filled in the form on their website, not really expecting help, because I hadn’t actually received a fine. I had a solicitor get in touch with me within a week, who was employed by Rebel News. They said it was an important case because it was a misuse of the legislation and involved freedom of

speech. They took a statement from me, consulted a barrister and then wrote the letter that was sent to Essex police.

I then had a phone call from my solicitor on Saturday 19th December to say the CPN had been rescinded, and received the letter, including an apology from the police, later the following week. I cannot thank Rebel News enough. Like the *Light Paper*, they are reporting on the real issues and are helping the people standing up to the tyranny and lies.

# The Covidian Totalitarian Cult

**O**ne of the hallmarks of totalitarianism is mass conformity to a psychotic official narrative.

Not a regular official narrative, like the “Cold War” or the “War on Terror” narratives. A totally delusional official narrative that has little or no connection to reality and that is contradicted by a preponderance of facts.

Nazism and Stalinism are the classic examples, but the phenomenon is better observed in cults and other sub-cultural societal groups. Numerous examples will spring to mind: the Manson family, Jim Jones’ People’s Temple, the Church of Scientology, Heavens Gate, etc., each with its own psychotic official narrative: Helter Skelter, Christian Communism, Xenu and the Galactic Confederacy, and so on.

Looking in from the dominant culture (or back through time in the case of the Nazis), the delusional nature of these official narratives is glaringly obvious to most rational people. What many people fail to understand is that to those who fall prey to them (whether individual cult members or entire totalitarian societies) such narratives do not register as psychotic. On the contrary, they feel entirely normal. Everything in their social “reality” reifies and reaffirms the narrative, and anything that challenges or contradicts it is perceived as an existential threat.

These narratives are invariably paranoid, portraying the cult as threatened or persecuted by an evil enemy or antagonistic force which

only unquestioning conformity to the cult’s ideology can save its members from. It makes little difference whether this antagonist is mainstream culture, body thetans, counter-revolutionaries, jews, or a virus. The point is not the identity of the enemy. The point is the atmosphere of paranoia and hysteria the official narrative generates, which keeps the cult members (or the society) compliant.

In addition to being paranoid, these narratives are often internally inconsistent, illogical, and well, just completely ridiculous. This does not weaken them, as one might suspect. Actually, it increases their power, as it forces their adherents to attempt to reconcile their inconsistency and irrationality, and in many cases utter absurdity, in order to remain in good standing with the cult.

Such reconciliation is of course impossible, and causes the cult members’ minds to short circuit and abandon any semblance of critical thinking, which is precisely what the cult leader wants.

Moreover, cult leaders will often radically change these narratives for no apparent reason, forcing their cult members to abruptly forswear (and often even denounce as ‘heresy’) the beliefs they had previously been forced to profess, and behave as if they had never believed them. This causes their minds to further short circuit, until they eventually give up even trying to think rationally, and just mindlessly parrot whatever nonsensical gibberish the cult leader

fills their heads with.

Also, the cult leader’s nonsensical gibberish is not as nonsensical as it may seem at first. Most of us, upon encountering such gibberish, assume that the cult leader is trying to communicate, and that something is very wrong with his brain. The cult leader isn’t trying to communicate. He is trying to disorient and control the listener’s mind. Listen to Charlie Manson “rapping.” Not just to what he says, but how he says it. Note how he sprinkles bits of truth into his stream of free-associated nonsense, and his repetitive use of thought-terminating clichés, described by Robert J. Lifton as follows:

“The language of the totalist environment is characterized by the thought-terminating cliché. The most far-reaching and complex of human problems are compressed into brief, highly selective, definitive-sounding phrases, easily memorized and easily expressed. They become the start and finish of any ideological analysis.” — Thought Reform and the Psychology of Totalism: A Study of “Brainwashing” in China, 1961.

If all this sounds familiar, good. Because the same techniques that most cult leaders use to control the minds of the members of their cults are used by totalitarian systems to control the minds of entire societies: Milieu Control, Loaded Language, Sacred Science, Demand for Purity, and other standard mind-control techniques. It can happen to pretty much any society, just as anyone can fall prey to a cult, given the right set of circumstances.

It is happening to most of our

societies right now. An official narrative is being implemented. A totalitarian official narrative. A totally psychotic official narrative, no less delusional than that of the Nazis, or the Manson family, or any other cult.

Most people cannot see that it is happening, for the simple reason that it is happening to them. They are literally unable to recognize it. The human mind is extremely resilient and inventive when it is pushed past its limits.

Ask anyone who has struggled with psychosis or has taken too much LSD. We do not recognize when we are going insane. When reality falls apart completely, the mind will create a delusional narrative, which appears just as “real” as our normal reality, because even a delusion is better than the stark raving terror of utter chaos.

This is what totalitarians and cult leaders count on, and exploit to implant their narratives in our minds, and why actual initiation rituals (as opposed to purely symbolic rituals) begin by attacking the subject’s mind with terror, pain, physical exhaustion, psychedelic drugs, or some other means of obliterating the subject’s perception of reality.

Once that is achieved, and the subject’s mind starts desperately trying to construct a new narrative to make sense out of the cognitive chaos and psychological trauma it is undergoing, it is relatively easy to “guide” that process and implant whatever narrative you want, assuming you have done your homework.

And this is why so many people — people who are able to easily recognize totalitarianism in cults and

foreign countries — cannot perceive the totalitarianism that is taking shape now, right in front of their faces (or, rather, right inside their minds). Nor can they perceive the delusional nature of the official “Covid-19” narrative, no more than those in Nazi Germany were able to perceive how completely delusional their official “master race” narrative was. Such people are neither ignorant nor stupid. They have been successfully initiated into a cult, which is essentially what totalitarianism is, albeit on a societal scale.

Their initiation into the Covidian Cult began in January, when the medical authorities and corporate media turned on The Fear with projections of hundreds of millions of deaths and fake photos of people dropping dead in the streets. The psychological conditioning has continued for months.

The masses have been subjected to a constant stream of propaganda, manufactured hysteria, wild speculation, conflicting directives, exaggerations, lies, and tawdry theatrical effects. Lockdowns. Emergency field hospitals and morgues. The singing-dancing NHS staff. Death trucks. Overflowing ICUs. Dead covid babies. Manipulated statistics. Goon squads. Masks and all the rest of it, which does not matter in the least, not to the members of the Covidian Cult.

Facts do not matter to totalitarians and cult members. What matters is loyalty to the cult or the party.

## Evidence-Free Mask Marauders Targeting The Exempt

**T**hey’re coming for us, warned Peter Hitchens. Covid fanaticism is reaching a new level of hysteria, with sceptics such as Toby Young and Emma Kenny relentlessly attacked on mainstream and social media.

A distinguishing feature is the mask, which lockdown zealots want to enforce everywhere but the home. Health academic Trisha Greenhalgh, for example, is urging runners and cyclists to cover their faces for the public good.

A bone of contention for the mask morality brigade is the legal exemption for people with physical or mental health conditions. The criteria are broad and subjective: stress or discomfort qualifies. Despite the occasional warnings from retailers, there is no need for medical certification. Furthermore, anyone (including a police officer) demanding personal details of

illness or disability is infringing the Equality Act.

This is all very disrupting to the covid cause. Tory MP Simon Hoare was angered by actor Laurence Fox posting a photograph of himself with a mask exemption badge:

“I hadn’t realised that being a first class, ocean going, chateau bottled, nuclear powered prick was an exemption from wearing a mask. What a selfish loathsome tool this man is.” Society is being encouraged to treat free-faced citizens as antisocial germ-spreaders. But mask enforcement is a radical and disproportionate response to a disease of mortality risk similar to influenza, and is based on scant evidence. How did we get here?

As the covid-19 outbreak reached Britain, official guidance focused on social distancing and handwashing. In April deputy chief medical

advisor Jonathan Van Tam asserted that masks were unnecessary for the general public. However, after the World Health Organisation recommended masks as one of several ways to reduce risk, on 15th June the government mandated masks on public transport, and then in September in shops.

Yet research shows that masks offer little protection. Indeed, manufacturers issue a disclaimer on the packaging. Droplet infection from coughing or spittle are preventable



without reliance on masks, but aerosol particles are so minuscule that the mask defence is like wearing a string vest to stop mosquito bites.

Some studies supporting mask use have appeared during the pandemic, but the findings are dubious due to design flaws, peer review prone to group-think and a rush to publish. A Danish study producing results that clashed with the consensus was rejected for publication by three prominent journals. Henning Bundgaard and colleagues eventually published in the Annals of Internal Medicine. In their large population study, comprising 3030 surgical mask wearers and 2994 wearing no mask, 42 (1.8%) of the former and 53 (2.1%) of the latter caught covid-19, a statistically insignificant difference.

The Danish study has been ignored because it did not measure transmission. However, most countries have not reduced

incidence of covid-19 after mandating masks. In the UK the rate has surged despite widespread use of masks indoors and outdoors.

In March last year, deputy chief medical officer Jenny Harries warned that masks could ‘trap the virus’, causing the person wearing to breathe in germs that might otherwise have passed by. In a 2015 study of masks to prevent flu, McIntyre and colleagues remarked that ‘moisture retention, reuse of cloth masks and poor filtration may result in increased risk of infection’. Poor practice includes habitual face-touching and improper discarding of potentially contaminated masks. Masks are a concentrated source of disease and could increase transmission.

Instead of inciting a lynch mob mentality, perhaps covid zealots should do something about the used masks strewn on our pavements. On-the-spot fines, perhaps?

# Murder Of The Innocent

**The now almost entirely corrupt mass market media, led by the sexist, ageist, treacherous and traitorous BBC (now the official mouthpiece for fascist nutters, communitarianism and Agenda 21) has spent much of the last year showing us photos of people who allegedly died of covid-19.**

Most of them died of something else, of course.

The entirely absurd and grotesquely unscientific ploy of claiming that anyone who died within 28 or 60 days of a positive PCR test must have died of covid-19, means that around the world hundreds of thousands who died of undiagnosed or untreated cancer or heart disease were wrongly added to the false total constantly promoted by sick politicians, corrupt advisors and sycophantic journalists (who, let us never forget, deliberately avoid interviewing anyone, however qualified, who might have been able to produce facts that didn't fit well into the Great Lie).

As a corollary, it will have probably not escaped your notice that there has been virtually no flu anywhere in the world for a long time now.

In an average sort of year, there are around a billion cases of flu every season (considerably more than the total to which they've managed to manipulate the number of covid-19 cases) but in 2020, the WHO recorded no cases of flu whatsoever in Central

America or South America, sporadic cases in India and a smattering of cases in some countries in the Northern Hemisphere. You'd have to be suffering from a severe shortage of brain tissue not to see a pattern here.

Inevitably, however, all the flu victims were added to the covid-19 death total.

It's difficult to be precise, because of all the lies which have been told by the Government, but I am willing to bet a reputation built up over half a century (take a look at my website for a collection of some of my accurate forecasts, assessments and warnings over the years) that the number of deaths listed as covid-19 deaths consists of two groups: the number who would have normally died of the flu and the people who have died because of the lockdowns, the closure of many hospital departments and the effective absence, in many areas, of any real medical care.

To be precise, I believe that covid-19 has been carefully marketed for a specific purpose. It is similar in many ways to the ordinary flu. The mortality rate of covid-19 is much the same as the mortality rate associated with the flu – though worldwide the number of people affected by it is considerably less than would be expected in a normal year.

The flu can, and does, kill 650,000 people in a six month flu season. It is claimed that covid-19 has killed two million people in around 15 months. It isn't difficult to do the maths and see how much of a fraud this is.

And here's a prediction: in 2021 there will be notably more deaths than there are in an average sort of year.

Some of the people who die will die of the flu virus known as covid-19, or of some mutation of it. Whatever it is called and wherever it comes from, the flu kills a good many

people every year.

Then there will be the thousands who will die of bacterial pneumonia – caused by the masks they've been wearing for hour after hour and day after day. There is already an epidemic of bacterial pneumonia deaths caused by mask wearing. It's going to get a good deal worse. And it will, inevitably, be a while before the average doctor wakes up, does a little research and cottons on to the link between masks and pneumonia.

And there will be many thousands of deaths caused by the vaccine. The manipulative politicians and their wretched advisors will try to claim that deaths after vaccination are coincidental. That's like claiming that it's just a coincidence if someone gets drunk, crashes a car and dies.

The experimental covid-19 vaccine (and yes, I know there is a strong argument that it shouldn't really be called a vaccine but let's concentrate on the big stuff here) is dangerous. It has already killed a lot of people and it's going to kill a good many more. I've had a bet that by the end of 2021 more of us will know someone who was made seriously ill or killed by the vaccine than someone who was killed by covid-19. I am constantly sickened by celebrities who are wheeled out to claim the vaccine is 'safe', without knowing anything about it. The Archbishop of Canterbury seemed to join the queue of celebrities airing their ignorance when he allegedly told the BBC that the vaccine was safe.

But most of this year's deaths, and next year's deaths too, will be a direct result of the lockdowns. And since the lockdowns and hospital department closures have all been unnecessary and deliberate, I have no qualms about describing these deaths as murders. None of these deaths

was accidental or a surprise. I take no pride in the fact that I repeatedly warned back in the spring of 2020 that there would be more deaths caused by the lockdowns than the coronavirus.

During the first lockdown, cancer referrals fell by 75% and breast cancer diagnosis fell by over 50%. Cancer didn't go away. Doctors just stopped bothering to diagnose it. Deaths from bowel cancer, prostate cancer, diabetes and many other diseases doubled in the first six months of the lockdowns and closures. Most, if not all, were put down as 'covid-19' deaths because anyone who had a test and died afterwards was a covid-19 death. Suicides rose dramatically – probably quadrupling.

Since the BBC in particular and the media in general spent much of 2020 showing us photos of people who allegedly died of covid-19, I want to devote a few words to those who died unnecessarily because hospital departments were closed or because the lockdowns filled them with unbearable despair. These people need remembering too. Let this be their Remembrance Day. They were killed by the UK government and the NHS just as surely as the soldiers we remember on Remembrance Day in November were killed by our enemies.

A disabled man in south London starved to death because he obeyed the government's message that he stay at home.

Sherwin Hall was just 27-years-old when he died. He visited a hospital in Leeds in March 2020 complaining of pain. He visited the hospital 14 times in four weeks but it wasn't until the end of May that he was given the scan for which he had begged.

Daniel Furniss, who was 34, killed

himself because he couldn't cope with the isolation. Emily Owen, who was 19, killed herself for the same reason. And so did 14-year-old Sam Tyler. Kian Southway was 15 when he died. Corey Liversedge was 16 when he committed suicide because of the lockdown. Beth Palmer was 17 when she killed herself. Matthew Mackell was 17 when he killed himself.

Dorothy Ashworth refused medication, food and fluids and she died of despair in a care home. Coronavirus restrictions meant that she thought her family had abandoned her.

This hasn't just been happening in the UK, of course. I have details of people all around the world who killed themselves. In India, 66 children committed suicide within 100 days of the covid-19 lockdown. If there is a pandemic of anything it's a pandemic of suicide.

In Adelaide, Australia four newborn babies died after being denied transport to a hospital where they could have had life-saving heart surgery. They were denied transport because of covid-19 lockdown restrictions.

There were, of course, thousands more who died unnecessarily because of the wicked, stupid, pointless and eternally damaging lockdowns.

My heart goes out to all those people who have lost relatives and friends as a result of this war on mankind. Most of the deaths allegedly caused by covid-19 were caused by the inappropriate treatment devised by the Government and delivered by the NHS.

They were killed, in cold blood, by the Government and the NHS.

# Smart Technology: Is It As Safe As We're Told?

**M**att Hancock MP memorably stated “we are fighting against an invisible enemy...” He was referring to the coronavirus but is it possible that ‘electrosmog’, something we cannot see, but that permeates our environment 24/7, could be having serious effects on our health?

Campaigners accept that this is one step in the right direction but it is still inadequate to protect populations from escalating levels of RFR. Two recent multi-million dollar studies, from the US and

systems.

As the UK ‘guidelines’ do not cover either long-term exposure nor the above-noted low-intensity effects, they are inadequate to protect public health.

Furthermore, the 2018 European Commission Scientific Committee on Health, Environmental and Emerging Risks (SHEER) lists 5G electromagnetic radiation as an emerging risk to public and environmental health.

**Vested Interests?**

Should we be asking why successive UK governments choose to accept radiation levels set by a small, private group, the International Commission on Non-Ionising Radiation Protection (ICNIRP)? Its guidance has varied little since 1998.

ICNIRP continues to the present day to make the same assertions, in spite of growing scientific evidence to the contrary. Moreover, it appears that the regulators have deliberately excluded the scientific evidence of harm; their hypothesis that any dangers would only result from thermal effects is at best out of date. ICNIRP have been repeatedly exposed as having ties to the telecom industry.

Meanwhile, Lloyds of London “exclude any liability coverage for claims, directly or indirectly arising out of, resulting from or contributed to by electromagnetic fields, electromagnetic radiation, electromagnetism, radio waves or noise”.

Is the desire for profit blinding decision makers to the true facts? In the opinions of many publications that give clear evidence of industry capture, it is.

**History repeating itself?**

In the 1930s scientists were aware that asbestos caused cancer and many companies were aware of the connection between asbestos and cancer. However, as late as the 1970s, household products made of asbestos

continued to be sold and, tragically, research was altered to hide these findings from the public.

Is the asbestos story repeating itself, with companies avoiding facing the truth about the threats caused to human, animal and plant life caused by EMRs, especially 5G?

**What Action is Being Taken?**

Legal cases that identify harm are being won and some of the facts are being recognised by governments.

On December 20th 2020 a Dutch Court ruled that an increase in health risks cannot be ruled out even at exposures of 1 V/m, which is well below the government’s “safety” ICNIRP guidelines.

Similarly, the Court of Turin has found ICNIRP cannot be trusted. The Brussels Environment Minister declared last year that she would not allow her citizens to be ‘guinea pigs’ to an untested technology and Switzerland has placed an indefinite moratorium on 5G due to health concerns as a precautionary measure.

Increasing numbers of concerned citizens across the world are lobbying their local governments and with some success. Installing 5G’s untested beam-forming technology, without consent is a clear violation of human rights.

**Any Successes?**

Activists have stopped 56, 5G masts in Bristol and London, although not on the grounds of pollution, only on visual and technical matters. Wells in Somerset and eight other towns across the South West voted against 5G. “This Council has a responsibility to protect the public and environment from exposure to harm, albeit unpredictable in the current state of scientific knowledge, and therefore opposes the roll-out of 5G in the Parish of Wells City Council – based on the Precautionary principle – until further information is revealed.”

Experts raising the alarm include Frank Clegg, former CEO

of Microsoft in Canada and the highly respected scientists and medical doctors who have called for a moratorium on the rollout of 5G. “We, the undersigned scientists, recommend a moratorium on the roll-out of the fifth generation, 5G, for telecommunication until potential hazards for human health and the environment have been fully investigated by scientists independent from industry. 5G will substantially increase exposure to radio-frequency electromagnetic fields (RF-EMF) on top of the 2G, 3G, 4G, WiFi etc. for telecommunications already in place. RF-EMF has been proven to be harmful for humans and the environment.” (5gappeal.eu)

The 2018 European Electronics Code now transposed into UK law requires competent authorities to reconcile the health and environmental risks; Matt Hancock has yet to establish who they are.

Court action is being pursued by [www.actionagainst5g.org](http://www.actionagainst5g.org) led by Michael Mansfield QC. This case is very much needed as 5G masts are currently being erected at speed in the UK. The government is failing to act on the evidence and is ignoring public opposition.

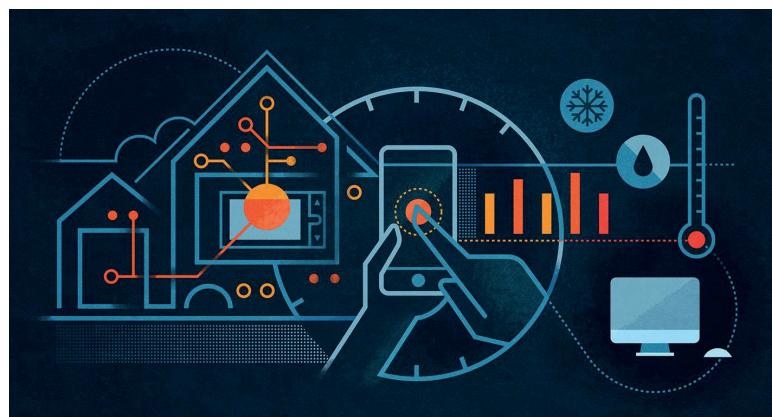

### Operation Paperclip

### Operation Mockingbird

Operation Mockingbird was a CIA project to infiltrate and covertly control the media. It began in the 1950s under then CIA director Allen Dulles. 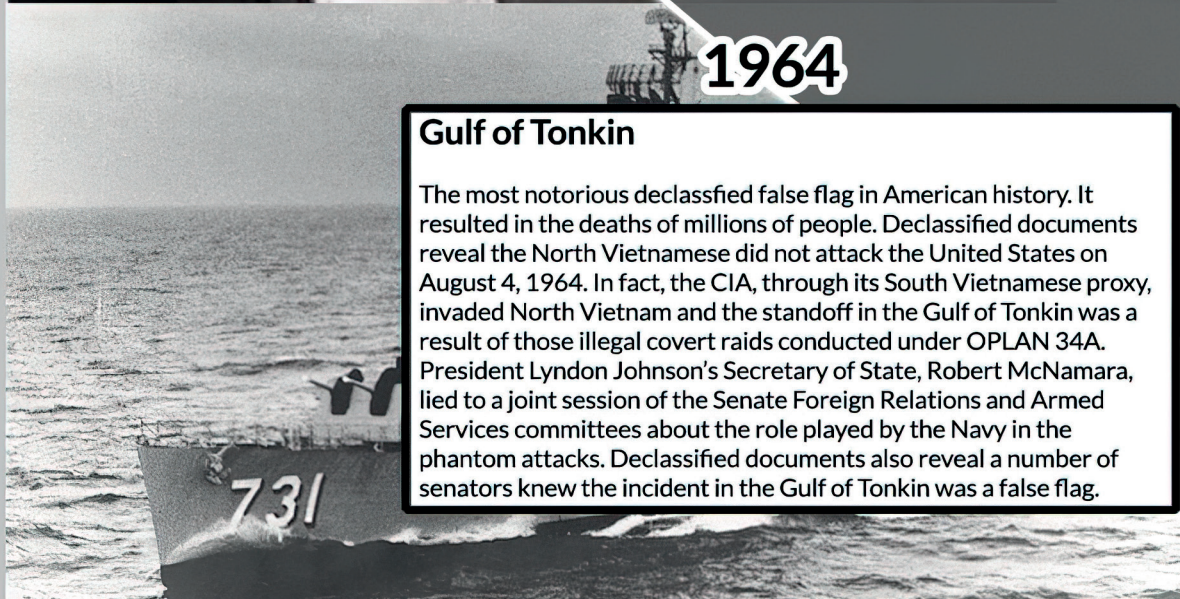

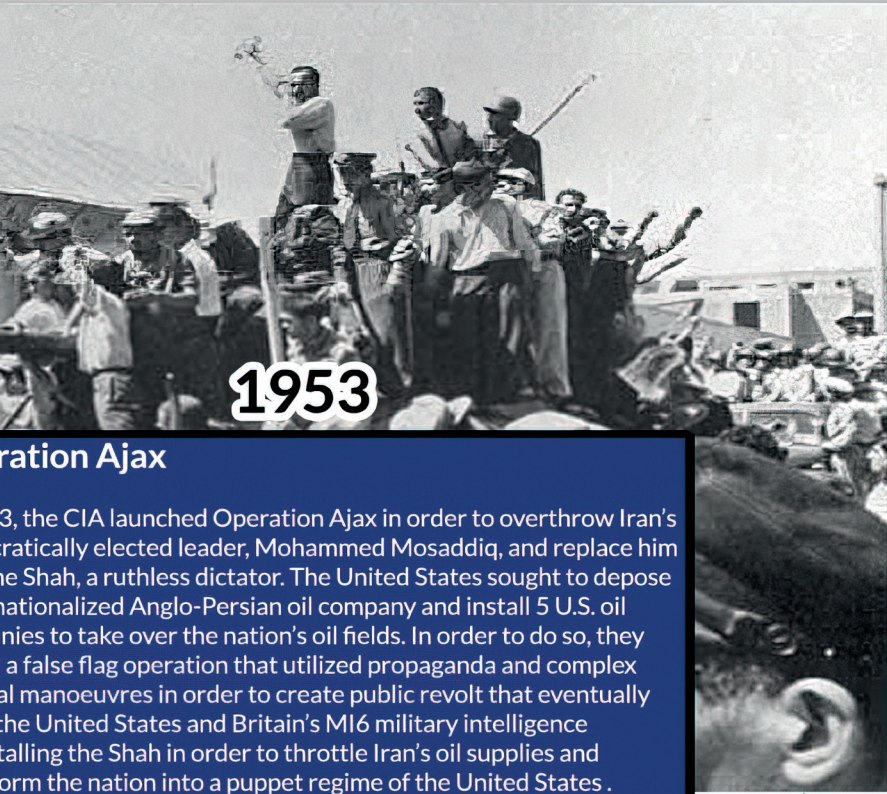

# German Court Declares Lockdown Measures Unconstitutional

**A district judge in Weimar has acquitted a man ordered to pay a fine for breaching the covid contact ban by celebrating his birthday with at least seven other participants from a total of eight households – six guests too many, according to the Thuringia covid regulation.**

The judge's verdict is damning: the covid regulation is in breach of the constitution and can be appealed against in material law. This is the first time a judge has engaged intensively with the medical facts, economic consequences and effects of specific policies.

Part of the Rechtsstaat Principle, the principle of the state acting in accordance with the rule of law, is the imperative of precision in legislation. According to the Federal Infection Protection Act (IPA), the "relevant authorities" are to impose "the requisite safety measures". In normal times, this means that spreaders or persons suspected of spreading an infection may be isolated, or contaminated areas closed off.

The IPA does not envisage a general ban on contact also extending to healthy people. However – and this is the interpretation made by many administrative courts so far – it may be permissible to go beyond the

purview of the IPA in the case of an "unprecedented event" that was so new that the legislator would have been unable to pass the necessary regulations in advance.

The judge rejects this pretext. As early as 2013, the Bundestag had access to a risk analysis conducted with the participation of the Robert Koch Institute, concerning a pandemic caused by a "SARS-type virus", which described a scenario of 7.5 million dead in Germany over a period of three years, and discussed anti-epidemic measures during such a pandemic (Bundestag publication 17/12051). The legislator was therefore able, in regard to such an event that was considered at least "conditionally probable" (occurrence probability class C), to study the provisions of the IPA and if necessary adjust them.

This political failure, as a result of which Germany went into the pandemic virtually unprepared – without legal instruments governing control of the virus, without stocks of masks, PPE and medical equipment – cannot now lead to politicians' simply closing a gap in legislation as they see fit.

Particularly given that an epidemic situation, i.e., the basis for the expansion of the routine infection protection provisions, simply does not exist (or no longer exists). The numbers of those infected and showing symptoms were already falling in the spring (way back in

2020!) The lockdown thus came late and was generally ineffective.

At no time, therefore, has there been a concrete danger of the health service's being overwhelmed by a 'wave' of covid-19 patients.

As can be seen from the DIVI ICU register newly established on March 17th 2020, an average of at least 40% ICU beds in Germany were free at all times. In Thuringia, 378 beds were registered occupied on April 3rd, 36 of these with covid-19 patients. Meanwhile there were 417 beds vacant.

On April 16th, two days before the issuance of the regulation, 501 beds were registered occupied, 56 with covid-19 patients, and 528 beds were vacant... Thuringia registered its highest number of notified covid-19 patients in spring at 63 (on April 28th). Thus, at no time did the number of covid-19 patients reach a level that could have justified fears of the healthcare system's being overwhelmed.

This estimate of the actual dangers from covid-19 in the spring of 2020 is confirmed by an evaluation of settlement data from 421 clinics belonging to Initiative Qualitätsmedizin, which found that the number of SARI cases (severe acute respiratory infection) treated as in-patients in Germany in the first half of 2020 was 187,174 – lower than the figure for the first half of 2019 (221,841 cases), even though this figure included those SARI cases

caused by covid. The same analysis showed the numbers of ICU and respirator cases lower in the first half of 2020 than in 2019.

The judge concluded that there were no "unacceptable gaps in protection" that could have justified recourse to across-the-board regulations against the Federal Government. It is striking how coldly the Weimar judge concluded the months-long discussion:

**"A general ban on contacts is a severe intervention on civic rights. It is among the fundamental liberties of the individual in a free society to determine for himself or herself with whom (on presumption of consent) and under what circumstances he or she will make contact. Free encounter among people for all imaginable purposes is also a fundamental basis for society. The obligation of the state here is categorically to refrain from all intervention that purposefully regulates and limits this. Questions of how many people a citizen may invite to his home or how many people a citizen may meet in a public place to go for a walk, play sports, shop or sit on a park bench are categorically of no legitimate interest to the state."**

Much of the public has now almost come to terms with the new abnormal. However, as the judge points out, the life that was previously considered 'normal' has now been reinterpreted as a crime.

"Although it appears that a shift in values has taken place over the months of the covid crisis, with the consequence that many people find procedures that were formerly considered absolutely exceptional more or less 'normal' – which of course also alters perspectives on the constitution – there should be no doubt that by imposing a general ban on contacts, the democratic Rechtsstaat has broken what was previously seen as a self-evident taboo.

"It must also be noted – as an aspect worthy of special consideration – that the state, in imposing its general ban on contacts with the aim of protection against infection, treats every citizen as a potential threat to the health of third parties.

If every citizen is seen as a threat from which others must be protected, that citizen is also robbed of the possibility of deciding what risks to take – which is a fundamental freedom. A citizen's choice of visiting a cafe or a bar in the evening and running the risk of a respiratory infection for the sake of social interaction and pleasure in life, or of exercising caution because she has a weakened immune system and therefore prefers to stay at home, is removed under the provisions of a general ban on contacts."

- 3. Farm Services Act, 2020, and the Essential Commodities (Amendment) Act 2020**

Superficially, these seemingly benevolent laws aim to modernise and liberalise India's agricultural industry. But they have a nefarious underbelly.

Realistically, it will put the power into the hands of large corporations with zero allowance for court intervention to protect any violation of contracts and farmer's rights. They are essentially draconian bills to nourish billionaires under the guise of farmer welfare, which will eventually

give corporations a complete monopoly on trade and agricultural produce, extinguishing farmer's Minimum Support Price (M.S.P.) to further impoverish them, which could lead to increase in farmer suicide as well as driving them off their land.

## Twitter Refused To Remove Child Porn Videos Despite Repeated Requests By Trafficking Victim

**A** lawsuit filed in the Northern District of California, Wednesday 20th January by the victim and his mother, alleges Twitter made money off the clips, which showed a 13-year-old engaged in sex acts and are a form of child sexual abuse material, or child porn, the suit states.

According to the New York Post: 'The child - who is now 17 and lives in Florida - is identified only as John Doe and was between 13 and 14 years old when sex traffickers, posing as a 16-year-old female classmate, started chatting with him on Snapchat, the suit alleges.

Doe and the traffickers allegedly exchanged nude photos before the conversation turned to blackmail: If he didn't share more sexually graphic photos and videos, the explicit material he'd already sent would be shared with his "parents, coach, pastor" and others.

Doe, acting under duress, initially complied and sent videos of himself performing sex acts and was also told to include another child in his videos, which he did, the suit claims.

Eventually, Doe blocked the traffickers and they stopped harassing him, but at some point in 2019, the videos surfaced on Twitter under two accounts that were known to share child sexual abuse material, court papers allege. Over the next month, the videos would be reported to Twitter at least three times — first on Dec. 25, 2019 — but the tech giant failed to do anything about it until a federal law enforcement officer got involved, the suit states.

Doe became aware of the tweets in January 2020 because they'd been viewed widely by his classmates, which subjected him to "teasing, harassment, vicious bullying" and led him to become "suicidal," court

records show.

While Doe's parents contacted the school and made police reports, he filed a complaint with Twitter, saying there were two tweets depicting child pornography of himself and they needed to be removed because they were illegal, harmful and were in violation of the site's policies.

A support agent followed up and asked for a copy of Doe's ID so they could prove it was him and after the teen complied, there was no response for a week, the family claims.

Around the same time, Doe's mother filed two complaints to Twitter reporting the same material, but she also received no response.

Twitter eventually replied on January 28th and said they wouldn't be taking down the material, which had already had over 167,000 views and 2,223 retweets, the suit states.

"Thanks for reaching out. We've

reviewed the content, and didn't find a violation of our policies, so no action will be taken at this time," the response reads, according to the lawsuit.

In his response, published in the complaint, Doe was shocked. "What do you mean you don't see a problem? We both are minors right now and were minors at the time these videos were taken. We both were 13 years of age. We were baited, harassed, and threatened to take these videos that are now being posted without our permission. We did not authorize these videos AT ALL and they need to be taken down."

He even included his case number from a local law enforcement agency, but still the tech giant allegedly ignored him and refused to do anything about the illegal child sexual abuse material — as it continued to rack up more and more views.

Two days later, Doe's mother was

connected with an agent from the Department of Homeland Security through a mutual contact, who then successfully had the videos removed on Jan. 30 2020.

"Only after this take-down demand from a federal agent did Twitter suspend the user accounts that were distributing the abusive material and report it to the National Center on Missing and Exploited Children," states the suit, filed by the Center and two law firms.

"This is directly in contrast to what their automated reply message and User Agreement state they will do to protect children."

The disturbing lawsuit goes on to allege Twitter knowingly hosts perverts who use the platform to exchange child pornographic material and profits from it by including advertisements interspersed between tweets advertising or requesting the material.'

# What Can We Learn From China's Social Credit System?

**China's Social Credit System, which ranks people on their behaviour, sees millions blacklisted and blocked from travelling each month because of outstanding debts and petty crimes.**

People are named and shamed on public screens for receiving fines or acting out of line. Many Chinese citizens don't see it as surveillance; they see it as a way of increasing honesty, security and convenience, even if it is at the expense of their privacy.

Facial recognition technology catches citizens breaching regulations and immediately deducts a fine from their bank balance. It is largely accepted because people trust the government and enjoy perks for good behaviour. China suffers with social trust issues and the public seem reassured that the system will encourage greater responsibility and better etiquette.

There are many small schemes, both government and private, which make up the whole and cover every aspect of conduct. People are judged on criteria such as wealth, security, compliance, social connections and consumption behaviour. The more you buy, the better you do. If your friends are well-behaved, you will

fare well too. As long as you comply, there is no need to worry.

This hasn't happened overnight. China's Social Credit System was first announced in 2014 and was due for full implementation by 2020. With all the restrictions and enhanced police power last year, surely it has been easier to remove rights, force compliance and introduce radical changes to social systems worldwide.

2020 showed us the overbearing power of the government and the media. We have been pitted, baited and trapped. Freedom of speech has been eroded online by censorship and 'fact-checking', and offline by police crackdowns on any protest, march or public opposition. Stealth tactics edge us closer to what looks and feels like the Social Credit System. How far are we in Britain away from sanctions and rewards? ## Defiance Grows Across Europe

**While public resistance grows to lockdown measures and other tyrannical edicts by regimes in lockstep with each other, you would hardly know it from watching the broadcast media or reading most of the mainstream press.**

Over 10,000 marched in Vienna, Austria on Sat. 16th Jan. while 50,000 businesses in Italy co-ordinated to open on the same night, encouraging customers to visit their favourite bars and restaurants.

On the same day in Amsterdam, thousands of protesters waved flags and carried signs that read: "Freedom: stop this siege" while chanting: "What do we want? Freedom!"

They were met with riot police, dozens of horses charging and water

Further rioting erupted across dozens of Dutch cities on Sunday including a testing centre being burned in Urk, with resistance to disproportionate lockdown measures continuing as we went to press.

The protests were in response to tighter lockdown restrictions similar to here in Britain, with schools and 'non-essential' businesses ordered to close.

In the Polish highlands, businesses have decided to come together and successfully re-open, given that they were going out of business with another lost season.



# How Lockdowns Damage Our Immunity



**T**hroughout the covid crisis, Boris Johnson has always said that he is ‘following the science’.

The Prime Minister has no scientific background and relies entirely upon the advice he receives from members of the Scientific Advisory Group for Emergencies (Sage). In reality he is following the opinion of a small group of scientists while ignoring the opinion of all scientists with an alternative view.

Therefore, the important question becomes: are members of Sage following the science? I intend to demonstrate that the answer to that question is: No, they are not.

The advice of Chris Whitty, Patrick Vallance and their team has been consistent. They want to prevent or slow down the spread of the virus with social distancing, closures, restrictions and lockdowns. They originally said there was only very weak evidence for wearing masks but in June, when the virus was at its seasonal low point, face coverings became mandatory.

We are now in January, and despite strict lockdowns or tiers since early November, Chris Whitty is telling us that hospitals are about to be overrun with surging covid-19 cases. He and other members of Sage are blaming the public for not being fully compliant with the restrictions.

We are also told that a mutation of the virus is much more transmissible, and we need harder and longer lockdowns. A worldwide search of relevant scientific literature paints a different picture.

Dr Sheldon Cohen is a Professor

of Psychology at the Carnegie Mellon University in Pittsburgh. He has spent over three decades studying the connection between psychological stress and its impact on viral respiratory diseases. [1]

His research involves a thorough psychological assessment of his volunteers before they are placed in quarantine and exposed to viruses causing influenza or the common cold. The severity of the symptoms suffered by each individual are measured and compared with their pre-infection status. Professor Cohen consistently finds that people with the highest levels of long-term stress suffer more extreme symptoms than those with low levels of stress. He also finds that smoking and low vitamin levels are linked to poor outcomes.

Factors associated with decreased risk included social integration, social support, physical activity, adequate and efficient sleep, and moderate alcohol intake. Many may be relieved to know that teetotalism and excessive alcohol intake were both linked with worse outcomes. This may be because a drink or two tends to make us more relaxed and relieves stress for a time.

Professor Cohen says, “Social integration refers to the degree to which an individual participates in a broad range of social relationships and is generally defined in terms of the number of social roles one plays (e.g. spouse, parent, friend, fellow employee, volunteer, church

member). Social integration has been found to predict lesser mortality as well as lower risk for cardiovascular disease onset and disease progression.

These associations are thought to occur because social integration tends to boost positive psychological states that have beneficial effects on a range of disease-relevant physiological pathways. In contrast, a particularly low level of integration is viewed as social isolation, which is experienced as a stressful event.”

Social support refers to the amount of help you receive from family and friends. It can range from practical help with basic chores, to a phone call to say ‘hello’, and all the way through to a shoulder to cry on when something sad has happened.

Whatever form it takes, it improves our sense of self-worth by confirming that we are loved and other people care about us. Our social interactions are vital to our humanity and Professor Cohen’s research shows they are vital for our immunity to disease.

The use of draconian lockdowns and severe restrictions, which have been in place in one form or another for ten months, have utterly devastated our social integration and social support.

The deliberate use of fear by the Sage committee and the daily reports on covid-associated deaths by the media have put everybody under prolonged psychological stress. The ‘science’ clearly shows that this is the wrong approach.

Chris Whitty is currently telling us that the new variant of

the coronavirus is much more transmissible than the original. I propose that he may be mistaken and it only appears to be more transmissible because his stress-inducing, anti-social lockdowns have rendered every man, woman and child in the country considerably more susceptible to infection.

In March and April 2020, when infections were peaking, healthy people under the age of 60 were minimally affected by the virus. This may no longer be true because of the wilful destruction of our social networks.

It would appear that Chris Whitty, our Chief Medical Officer, is unaware of Professor Cohen’s work. If that is true, he is negligent in his duty to the nation.

However, it would not be the first time he has failed to take account of relevant information.

• There is a considerable body of evidence to show that optimum levels of Vitamin D reduce the severity of viral infections. [2]

He has never suggested we should supplement our diets during the winter months despite the fact there is no downside to an ideal level of this essential nutrient.

• He has made no mention of the fact that 95% of deaths have occurred in people with pre-existing metabolic disease. These conditions are frequently caused by a diet which elevates blood sugar. Research has shown that people with raised blood sugar suffer more severe infections than those with normal levels. [3]

• Throughout his tenure as Chief Medical Officer he has made no attempt to tackle the enormous problem of obesity and all its associated diseases. He is the top doctor in a country where 65% of people are overweight and he has no solution for it.

The only option he offers to tackle covid-19 is to repeat and intensify lockdowns. He does not seem to realise they do not work. [4]

We cannot expect Boris Johnson and Matt Hancock to ‘follow the science’ when even their advisers refuse to follow it.

# Marie Curie, The 1939 Cancer Act, And The Legacy Of Raymond Rife

**We've all heard of Marie Curie and her prize-winning contributions to science but not so many of us know who Raymond Rife is. Perhaps that is because the Cancer Act of 1939 made it illegal for treatments and cures to be advertised, offered or discussed outside of official circles, unless by state-approved mouthpieces.**

The 1939 Cancer Act was partly designed to guarantee that the nation had adequate provision for cancer treatment with radium-based radiotherapy. Marie Curie had discovered an effective method for treating tumours with gamma radiation but the radium required for the therapy was rare, a chore to extract and very expensive.

Supplies were squandered and the government of the day wanted to ensure sensible, appropriate use. A Royal Charter was established to provide funds for radium procurement and the Radium Trust (along with others) was appointed treasurer and trustee.

In the early twentieth century, radiation was all the rage; it was promoted as healthful and healing and appeared in fashionable lotions and potions. It wasn't known at the time just how harmful it could be.

Curie knew that Emil Grubbe had successfully treated cancer with x-rays and speculated that gamma rays could also be beneficial. She was right, and by 1930 radium centres were commonplace but suspicions arose about the toxic effects of the new treatment.

Senator John D. Works had raised concerns in the US Senate in 1915. He stated that radiation had the effect of making cancers worse and that many doctors thought the belief that radium could be used to cure cancers was a delusion.

In the early 1920s it emerged that women working closely with radium in a clock factory had become severely ill and disfigured due to radiation-induced tumours.

In 1932, American Billionaire Industrialist, Eben Byers, was a famous casualty of Radithor, a radium-infused elixir. He suffered terribly with multiple cancers and died within five years of his first dose. He had drunk the potion three times daily and the poison accumulated to a fatal extent. An autopsy showed that there was enough radiation in his body to kill three men.

Both Grubbe and Curie met their demise through excessive exposure to radioactive materials. Grubbe made it to 85 riddled with tumours but Curie died of Leukaemia at the age of 66 in 1934.

In the same year, Raymond Rife successfully cured 16 terminally ill cancer patients in a hospital trial. Rife's treatment used electronic frequencies to kill disease. Such was his talent that he built a microscope capable of 60,000x magnification and was able to observe how bacteria and viruses behaved unlike ever before.

He discovered that each microorganism had its own frequency and that, like an opera singer shattering a glass with her voice, the frequency emitted by each microorganism would be obliterated by a strong blast of a corresponding frequency. Since the frequency only affected the microbes it resonated with, other cells were left unharmed and there was no danger of overdose. It was ground-breaking. There was a huge banquet held in his honour to hail the 'end of all disease'.

Insurance companies were happy to fund Rife, provided that he gained approval from the International Cancer Foundation. The secretary of the foundation stipulated conditions that Rife considered distracting so the treatment wasn't approved. Rife's team flourished regardless and he found sponsorship from a local businessman. They worked hard to find irrefutable evidence and solid statistics, as they knew they were up against massive resistance from the mainstream medical moguls.

In 1938, Morris Fishbein of the American Medical Association made Rife an offer. The offer was turned down and within weeks, Rife's laboratories were burned to the ground.

In June that year, Rife was indicted on charges of medical fraud. During the trial, Rife's network were contacted and told that if they didn't stop using their machines, they would lose their medical licenses.

One doctor had his license revoked but most of them handed their equipment in and turned their backs on Rife and his invention. Two were found dead in suspicious circumstances and the others would later claim that they didn't even know who he was.

It's a similar tale to that of Stanislaw Burzynski and his anti-neoplaston treatment. Burzynski chose to work with some of the hardest tumours to treat – childhood brain tumours – and had remarkable results.

At a young age he discovered a naturally occurring peptide that was present in healthy people but absent in cancer patients and developed a successful treatment from his findings. In 1983 the FDA sought an injunction to stop Burzynski

from using anti-neoplastons in his practice; it was turned down and Burzynski continued his work, perpetually harassed by the looming spectre of the FDA.

Like Rife, he had patient files confiscated and suffered constant interference in his work. He has been in and out of the courtroom, supported by many witnesses who are living testament that his methods work. People who had been failed by the orthodox medical system found healing with Dr. Burzynski.

This brings us to the double-edged sword of the only remaining part of the Cancer Act of 1939.

While the government no longer needs to ensure the supply of radioactive material for the treatment of cancer, the advertising clause of the Act still applies: there can be no advertising of cures or remedies or offers of treatment for cancer outside of government-permitted channels. While this protects us from charlatans, it also prevents us from hearing about alternative remedies from knowledgeable, experienced practitioners.

Perhaps we'd like to hear about methods of healing other than the traditional 'cut, burn and poison'. The difficulty is that not enough official statistics exist for different approaches because they are rarely subject to huge, expensive trials and results tend to vary from person to person.

Not only did Rife cure cancer but he also found the Mortal Oscillatory Rates (MOR) for polio, tuberculosis, bubonic plague, anthrax and 20 other microorganisms.

Scientists today are piecing his work together from the scant remains of his research and Rife machines do exist though they are not freely available.

It's tough to filter through all the information available but as usual, we should discern for ourselves and be allowed access to information other than that which governments and authorities wish to spoon-feed us.

# Indoctrination Meets Inoculation: Interrogating Mass Vaccination

**W**ith the covid drugs now being ‘rolled out’ across the world, how might the mass-injection juggernaut conceivably be halted? Answer: philosophically at the level of “the science” itself, and also by challenging the tell-tale propaganda assault of the pro-vax establishment?

The individual effects of being, or not being, injected are central, as are the totality of effects upon the whole human ecosystem of mass-experimentation programmes.

Where, for example, is the ‘scientific research’ on the impact on natural immune systems of the relentless mass injection of children?

For decades, American children’s natural immune systems have been blitzed with scores of shots – detailed in Dr Mateja Cernic’s recent book *Ideological Constructs of Vaccination* (Vega Press, 2018); yet is any link being made between this fact, and the US being the world’s worst-affected nation in relation to covid-19?

Predictably, none – because neither our positivistic scientists nor Big Pharma dare look into such quintessentially scientific questions. And we all know why.

Celebrated Philosopher of Science Paul K. Feyerabend (1924–94) wrote prophetically about the authoritarian tendencies of modern science and technology in *Science in a Free Society* (New Left Books, 1978) and in *The Tyranny of Science* (Polity, 2011).

With any voices challenging the unctuously uncritical mainstream narrative on covid experimental injections today being systematically silenced, Professor Feyerabend must be turning in his grave. For democracy depends upon the open-

minded discussion of a rich diversity of views – and it just isn’t happening.

In his famous 1974 talk ‘How to defend society against science’, Feyerabend said: “Science has now become as oppressive as the ideologies it had once to fight... Heretics in science are still made to suffer from the most severe sanctions... Science has become rigid, [and] it has ceased to be an instrument of change and liberation... [It] inhibits freedom of thought” – adding that “Scientists quite often just don’t know what they’re talking about”. Prophetic words indeed.

Mainstream medicine’s uncritical support of mass injection is firmly rooted in a positivistic technocratic worldview; yet a mounting groundswell of dissent has other ideas, with technocratic ‘modernity’ and scientism being decisively undermined by holistic ‘New Science’ thinking.

Massive commercial vested interests (aka “Big Pharma”) also perpetuate vaccination ideology; and following Michel Foucault and Georges Canguilhem, the role of power in determining which ‘science’ is granted legitimacy is clear for anyone who looks for it.

Feyerabend again: “An independent science has long ago been replaced by the business science which lives off society and strengthens its totalitarian tendencies... The aim is no longer to find truth... but to keep the money coming in... [with] the show rigged in science’s favour... The superiority of science is not the result of research, or argument; it is the result of political, institutional, and even



military pressures”.

As Mateja Cernic shows, peer-reviewed case-study accounts show a considerable number of families whose children have been permanently harmed by vaccination.

The research claiming vaccines to be safe is routinely based on aggregative statistical (“ecological”) reasoning which conveniently “hides” individual impacts, rather than upon detailed and painstaking individual case-studies of actual children.

Empirical research can also only monitor immediate or, at best,

medium-term effects; it’s quite impossible for narrowly specified positivistic research to reveal the total collateral effects of mass vaccination, including its life-long effects.

Yet many people have a deep intuitive sense that there’s something fundamentally wrong with mass vaccination for diseases which are only very rarely life-threatening – and such intuitive wisdom should never be condescendingly dismissed by the medical establishment as “unscientific”, “ill-informed” lay-prejudice.

Why do we never hear medical science trumpeting the deaths from Adverse Drug Reactions? – which peer-reviewed studies quoted by Cernic show to number over 100,000 per annum in the USA, and nearly 200,000 in the European Union (conservative estimates).

And if the vaccines are ‘completely safe’, as we’re constantly being told, why are manufacturers and administrators of vaccines granted legal immunity from any harmful effects?

Dr Cernic writes: “Claims that vaccines ‘undergo rigorous and extensive testing’, that they ‘are held to the highest standard of safety’, etc. are utter lies. The fact that these claims [are] made by distinguished state institutions, charged with vaccine safety surveillance and monitoring, makes these lies absolutely inexcusable.” This is no rhetorical diatribe – people don’t get awarded Ph.D.’s for unevenced rants!

Technocratic scientism’s manic attempt to silence any systematic criticism of vaccination ideology is fundamentally anti-scientific, and we must fearlessly call it out wherever we see it. And Feyerabend’s devastating critique of scientism complemented by Cernic’s exhaustive academic study of vaccination ideology are excellent places to start.
