Gates Top Virologist: Vaccines Threatening Humanity

Dr. Geert Vanden Bossche PhD, DVM is a world-renowned vaccine developer, headed projects for Glaxo-Smithkline and Novartis, worked for the Bill & Melinda Gates Foundation and GAVI, was Head of the Vaccine Development Office for the German Centre for Infection Research (DZIF) and had a vaccine consultancy business from 2012 to 2019.

With over 30 years' experience in the field Dr. Bossche can hardly be described as an 'anti-vaxxer', but nevertheless has issued a dire and urgent warning about the serious dangers of creating uncontrollable pandemics due to the way in which the new covid experimental genetic drugs being pushed hard around the world actually work. He writes:

"Immediate cancellation of all ongoing covid-19 mass vaccination campaigns should now become THE most acute health emergency of international concern.

I don't see how mass vaccination campaigns would not lead to a disastrous aggravation of the covid-19 pandemic. However, no one else seems to realise; instead, vaccinologists, clinicians and scientists are merely focusing on the (positive) short-term results and impact at an individual level. Nobody seems to be looking at the consequences and risk at a human population level (which, according to my understanding, will become manifest quite soon).

Why is nobody worried about 'immune escape' whereas covid-19 has already escaped people's innate immunity as reflected by multiple emerging, much more infectious, viral variants (most likely due to the

global implementation of infection prevention measures)?

Vaccine deployment in the ongoing mass immunisation campaigns are highly likely to further enhance (adaptive) immune escape as none of the current vaccines will prevent replication/transmission of viral variants. **The more we use these vaccines for immunising people in the midst of a pandemic, the more infectious the virus will become.** With increasing infectiousness comes an increased likelihood of viral resistance to the vaccines. It's not exactly rocket science, it's a basic principle taught in a student's first vaccinology class: One shouldn't use a prophylactic vaccine in populations exposed to high infectious pressure (which is now certainly the case as multiple highly infectious variants are currently circulating in many parts of the world). To fully escape selective immune pressure exerted by vaccinal antibodies, covid-19, a highly mutable virus, only needs to add another few mutations in its receptor-binding domain.

I am beyond worried about the disastrous impact this would have on our human 'race'. Not only would people lose vaccine-mediated protection but also their precious, variant-nonspecific, innate immunity will be gone (this is because vaccinal antibodies outcompete natural antibodies for binding to covid-19, even when their affinity for the viral variant is relatively low).

As a dedicated virologist and vaccine expert I only make an exception when health

authorities allow vaccines to be administered in ways that threaten public health, most certainly when scientific evidence is being ignored.

The present extremely critical

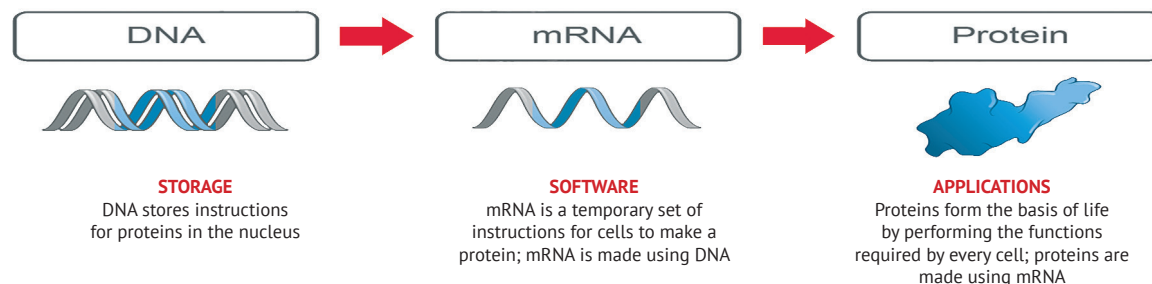

What Is An mRNA Vaccine?



People believe that the covid-19 vaccine will use our immune systems to attack proteins that our cells make and that's it.

Once our cells have released the covid-19's 'harmless protein', our immune systems will magically just focus only on that and we are safe from covid forever.

This is lies and trickery!

A sleight of hand magic trick, based in the world of make-believe that most people seem to be living in right now, as they cling onto anything that seems positive without questioning it at all. I'm going to call it an 'ignorance spell'.

All of us are affected because, to be honest, living in ignorance is how many find bliss. But this is too important to blissfully accept the nonsense and pseudo-science any longer.

The covid-19 vaccine mRNA forces cells to make a genetically sequenced 'harmless' spike protein, or so they claim. The immune system creates an immune response to the spike protein and gets rid of it and only it. The immune system then builds immunity from the spike protein, when a virus appears similarly constructed.

Many questions should be asked: If our cells are making a spike protein that our immune systems do not like, then why should we believe that our immune systems will not start attacking the cells that make it?

Surely our adaptive immune system will respond to this spike protein and the abomination cell that created it?

Our immune systems will consider those cells as damaged or genetically corrupted cells and initiate a cytokine storm. The damaged cells are seen as a poison, stimulating an attack to destroy the spike protein.

The vaccine is using genetically engineered exosomal membrane coated with polyethylene glycol (PEG) for extra protection to transfer artificially sequenced RNA into our cells for reverse transcriptase:

"Using cell derived enzymes to snip away our original DNA and replace it with the GMO sequence".

We have to understand how exosome mRNA works and what happens when cells use this mRNA to instruct cells to change DNA and perform a task like making the

abominable spike protein.

When our healthy cells receive an mRNA instruction, it overrides the original DNA instructions and then alters that cell's DNA by recombination via reverse transcriptase, using the enzymes from major histocompatibility complex (MHC) after creating the spike protein.

That cell will then make vesicles to carry that abomination spike protein from the ribosome into the cytoplasm and out of the cell.

During this process, that cell will make a new mRNA instruction from the creation of that abomination spike protein, which leads to DNA recombination and it will insert it into an endosome.

Then this endosome will go through exocytosis where lots of exosomes will bud out of the cell carrying this new synthetic genetically modified mRNA sequence from the covid-19 vaccine, and will go on to instruct more cells to make yet more abomination spike proteins and more exosomes with the same mRNA from the covid-19 vaccine.

All these cells will divide and multiply with the new transcribed DNA.

So in essence, we have damaged our healthy cells on purpose with the covid-19 vaccine. They are now recognized by our immune system as foreign. And people are begging and demanding this?

The mRNA used is a foreign body so why would our immune system not attack the cells that make it? Because of this the immune system will start attacking more and more cells that have been instructed to make these abomination spike proteins, which will lead to more and more cytokine storms. This happens naturally when DNA is damaged and produces autoimmune diseases like type 1 diabetes for example, or cancer cells which convert into senescent cells.

All I hear is people shouting that 'we need to prime our immune systems to protect against this virus! It's better to do something rather than nothing!'

This is simply more ignorance. We are ignoring the reality of what viruses actually are. Viruses

are actually those exosomes that carry mRNA around to other cells to cause immune responses and stimulate other functions. They clean cells (collect cell junk), heal DNA by recombination, and they are packaged with lots of healing proteins such as the so-called spike protein to interact with ACE-2 receptors and cause chemical reactions. They create antibodies for many different antigens.

They can carry junk DNA and RNA around in and out of cells but they do this as garbage collection, not to infect cells. These little nanoparticles show pure unconditional obedience to the DNA that programmed it. That's why we should never inject ourselves with one programmed from a eugenics laboratory.

The biogenesis of the naturally made exosome membrane is different from the biogenesis of the covid-19 vaccine exosome membrane; this residual code manipulation will signal to the T-cells that some trickery has been done, so it will respond by causing apoptosis (cell death) and will remember this to kill all these abomination cells.

If these abomination cells get infected by common antigens they will break down the antigens and create antibodies using the covid-19 vaccine sequence instead of the original one. This will cause more confusion for our immune systems. as now the proper polymorphism reaction has occurred and will instead create antibodies only for the spike protein on exosomes instead of the actual toxic antigens, due to the wrong RNA sequence being present in the DNA coding instructions.

We are officially told by the manufacturer that the covid-19 vaccine has artificially sequenced mRNA inside of it. The vaccine company admits to this because the virus was never fully isolated or purified. Worldwide Rallies For Freedom

Hundred of thousands of people across the world demonstrated against the extreme, draconian year-long overreach of their governments on Saturday 20th March 2021, as they peacefully rallied in major cities across Argentina, Australia, Austria, Belgium, Brazil, Britain, Bulgaria, Canada, Croatia, Denmark, Finland, Germany, Ireland, Italy, Japan, Netherlands, Poland, Portugal, Romania, Serbia, Sweden, Switzerland and the U.S.

They all know from actual evidence there is no contagious pandemic, and therefore no justification for the tyrannical measures. Preparing Our Children For Totalitarianism

I'm a child of the 1980's. In terms of school, I left in the morning, had lessons, had a break, had some more lessons, had dinner, had a few more lessons and it was suddenly 3.30pm. The only thing I had to worry about was negotiating my way home, which due to there being a few other schools clustered together in the same locale, was often like the movie 'Warriors'. There were a few psychopathic teachers who'd be facing jail nowadays, and we were made regularly aware of the possibility of nuclear holocaust at the hands of the 'dastardly' USSR. We knew where we stood back then.

Since having children of my own, it's impossible not to notice the huge difference in the school 'experience'. In the plus column, you don't get your head kicked in by mentally unstable teaching staff for committing the cardinal sin of missing church on Sunday. Bullies seem to be a lot thinner on the ground and getting to and from school is (for the most part) free of violent incident. However, despite all of that, there's something truly sinister going on that's gone from lurking in the shadows to hiding in plain sight as a result of the 'boiling frog' effect.

A few weeks prior to my eldest son's starting secondary school back in 2018, we received an information pack containing all manner of information relating to dress code,

behavioural expectations and basic 'do's and don'ts'. However, it was a segment relating to school dinners which raised my eyebrows, as it mentioned biometric finger-scanning in order to pay for food and drink. It stated that unless we contacted the school, it would be assumed that consent was given. I emailed the school and told them that I preferred our son to pay for his dinners by either cash or a swipe-card that we could allocate funds to, via an app called 'School Gateway'. To be fair to the school, they were fine with it.

The following year, we received another information pack from the school, this time relating to the HPV vaccine, which they were keen for my son to receive. After a lengthy debate with my wife, it was agreed to refuse consent. A few weeks later, I was contacted via a local NHS 'Immunisations Team' member, who (politely) challenged our decision to refuse consent. I asked them who made the vaccine and what was in it. They didn't know. Luckily, I'd boned up on the subject and told her. I then asked how effective it was for boys, considering they don't have cervixes and what harm it could cause. They told me that they wouldn't know for ten years. I then asked what number of HPV related cancers in males had prompted a roll out of the vaccine for

boys in the first place. Again, they didn't know, which led me to state that if they didn't know who made it, what was in it, and what data there was to support having it, they had no business contacting me. A few weeks later, they sent me a document from the Joint Committee on Vaccination and Immunisation (JCVI), which outlined the decision to roll out the HPV vaccine for boys. In there, it stated that the driver behind making it available to them was 'equality' and 'herd immunity'. There was no evidence at all to support its necessity. Suffice to say, we stayed clear of it.

Fast forward to September 2020 and my son's return to school after the first 'lockdown'. Again, we

were contacted by the school, this time with a list of restrictions and behaviours expected by the pupils that would have put Guantanamo Bay to shame. I emailed the school expressing my concerns, asking to see risk assessments in relation to mask-wearing and stating that the school would have to take full responsibility for any physical or mental impediment to my son, arising from any of the measures they'd put in place. I received a phone call from the head teacher, who told me that she disagreed with what was going on, blamed the local authority for everything and backed off.

After the second lockdown and planned return to school in March 2021, we were informed of measures

put in place and the need for testing and mask-wearing. This time, I got straight to the point, refusing consent for testing and telling the school that my son wouldn't be wearing a mask and that I didn't want him to be forced or coerced into wearing one. I received a cordial "that's absolutely fine" in response. As of writing this, my son has been sent home for the umpteenth time, because one of his friends has tested 'positive' for coronavirus.

Life at my son's secondary school in 2021 consists of their being locked inside the building, needing a 'pass' to go to the toilet, being watched by CCTV, paying for dinners by biometric scan, being pressured into taking unnecessary, experimental vaccines, being swabbed twice a week and pointlessly masked-up in class. I swear, if the government insisted on pupils having a toe amputated in order to return to school, there'd be barely a whisper of opposition.

This is neither progress, following 'the science', protecting children nor saving lives. This is totalitarian control, fascism and tyranny writ large. War has been well and truly declared on our children and unless parents stop complying and start pushing back defiantly against this madness, the world we'll leave behind for them will be an abomination that we stood by and enabled.

Public-private partnership and stakeholder capitalism are the euphemisms for the wholly unaccountable, private running of the entire country, where board directors set public policy and the complaints department has no obligation to listen to your grievances, or ever get back to you.

Imagine a not-so-distant future where your transport, refuse collection and police force are run by Serco for example, who are under no obligation to treat you fairly or humanely in any situation. If you choose to use their services, and there probably won't be any alternative, you consent to their terms and conditions. They really won't work for you, but the shareholders.

The world has become a corporation under the hidden guidance of the 'big club' – central bankers and giant corporations,

the military-industrial complex, even more established today than when Ned Beatty boomed it across the boardroom at Peter Finch in the 1976 film Network - and now there is little anyone can do about it. Maybe you can complain to their company officials, go to the company press outlets, organise a protest to declare you don't like the company's policies? Even today, while we still have a thin veneer of supposedly accountable government, politicians are passing acts to severely restrict and penalise any form of protest, attempting to nullify the Bill of Rights 1689 which will lead to many false arrests and which the Courts will probably strike down (already have in the case of Reclaim These Streets v Metropolitan Police Judicial Review, Justice Holgate 12th March 2021.)

Of course, you are under no obligation to use the company's services. As has been said in the

debate over big tech censorship many times recently, Facebook, Twitter, Alphabet et al are private companies, they don't have to follow the law and allow freedom of speech - but when the company has a monopoly (or cartel) over an industry, what choice is there but to accept their terms? These companies are effectively in charge and set the 'law'.

This is how freedom was removed and slavery established without a shot being fired or most people even noticing. People know they're getting screwed - accepting longer hours, lower pay and less benefits year by year, no longer able to afford many of the things we are used to. The screw gets tightened each generation with the help of real price inflation, the hidden evil tax on everyone who's not a billionaire,

Public, local economies which are free of evil psychopathic parasites keeping the people down and poor by controlling the fiat currency system and establishing cartels over all resources and services. Some may say it has always been this way, that nothing ever changes and the rulers will always rule, but at least in the past people didn't actually go out and vote for their oppressive tyrants.

There are lots of local groups springing up with this aim. Crops Not Shops is one such movement, Farmacy Co-op have featured in The Light paper, and of course thefreedomnetwork.co.uk is a great springboard for connecting to other local 'dissidents', where the rights of the individual are paramount.

The Covid 1984 Act

All the focus is put on the Coronavirus Act 2020 but in many ways this is to distract us from how they are really making these 'laws' that are dictating every aspect of our lives. Whilst the Coronavirus Act 2020 is important to the Government for aspects of manipulation and control and also as a smokescreen, the real

power lies in the use of the Public Health (Control of Disease) Act 1984. Using Section 45 of this 1984 Act (which 'conveniently' was rewritten in 2008 before the so-called Swine Flu 'pandemic' of 2009 to facilitate unlimited government powers), Hancock or any other minister can literally immediately make any 'law' they like without any public debate or Parliamentary scrutiny. Another big deception is the pretence that there is a State of Emergency in the UK, when there is not. If the government declared an official State of Emergency (as they should have done), this would have triggered the Civil Contingencies Act 2004 (the CCA), which would have:

1. Protected and respected our Human Rights;
2. Made Parliament, not individual ministers, responsible for any laws;

3. These would be made under full Parliamentary and Public scrutiny;
4. They would be limited by law to 30 days and would have to be reviewed by Parliament before any renewal;
5. They would have to be proportional to any risk.
6. Furthermore under the CCA, legislation is supposed to be avoided and only used as a last resort.

So business closures, lockdowns, mask wearing, travel bans, quarantines, the severe restriction of our rights and the ruin of our economy would never have happened.

Another thing about the Civil Contingencies Act is that previous governments had spent the last 16 years claiming they were planning to use it prior to 2020 and it appears in all the numerous government 'pandemic' planning reports, but then they completely ignore it when an actual event happens, as it does not suit the 'agenda'. The CCA also acts

in a bottom up instead of a top-down way of resolving an emergency and has a whole Local Resilience network and local Scientific Advisory Groups that would have been mobilised in the event of its being used.

Just going by this alone, if this 'pandemic' was not a criminal even-greater-power grab by the ruling billionaire class, why would you not use the CCA 2004 that was set up to protect us and our rights in an emergency, unless your real aim is the actual removal of those rights towards the end goal of totalitarianism?

A Psychologist's Perspective On The Regime

I have been accused of hating the NHS and giving doctors a bad name, and have been called anti-establishment and anti-authoritarian. My younger, punk-rocker student self would have relished such compliments, but now I am seen as a pariah of humanity for daring to ask questions that I feel any decent, intelligent person might ask when living under an increasingly fascist regime, where the right to protest has just been criminalised and social media posts are censored.

As a Consultant Psychologist, I know first hand how the impact of isolation, lack of interaction and lack of meaningful activity has a devastating impact on morale, mental health and ultimately can evoke suicide amongst the most desperate and the least helped. There

are entire generations of people who have lost everything, their homes, their jobs, their businesses and their education as a result of lockdown.

There are people who are denied the basic right to medical treatment and as a result will die, or those seeking to marry or for the dead to have a respectable funeral, and there are the elderly who haven't seen anybody for over a year and live their last days effectively under house arrest. I am likely to be picking up the pieces of the impact of this for the rest of my clinical career. There has been an increase in attempted and actual suicides, emotional dysregulation, anger, obesity and alcoholism. Though these elements of this regime are devastating, they are not the most frightening. There is something infinitely more sinister at play here. I have said this from day one, and it is only now that there are others who

agree, including those in the helping professions.

By far the most terrifying element of all is the compliance of the people. The manipulation of society through instigating fear via the media has been successful in dividing families, neighbours, colleagues and friends irretrievably. We are encouraged to call the police on our nearest and dearest, and I have seen first-hand an elderly grandma carted off by the police for visiting her 6-year-old grandson on his birthday. I also have witnessed a man being shouted at by shop staff, who was only collecting some printer ink so that he could work from home, and I have been screamed at for accidentally walking through the wrong door in a café; when we were slightly liberated last summer.

It is this display of sudden, secret-police level authority of shop staff

and the encouragement of people telling on each other, ultimately turning against anyone who dares to not follow orders that causes me the most psychological disturbance, not only as a practitioner but ultimately as an ordinary human being. I am surrounded by paranoid neurotic fascists, and I cannot breathe. It is this which has caused me the most anger, the most sadness and the most despair. People I considered my friends pre-covid are now enemies who have spoken to me like I am a stupid ungrateful child, and it is unlikely those friendships will ever be repaired.

I am deeply offended by the apparent personality transplants most people I know seem to have had, and how draconian and Orwellian they have become in daily communications that are filled with self-righteous puritanical drivel. It is a time in which we trust no one. It is

a time for bribing those involved in the black market for basic services like a haircut or to organise a secret gathering of like-minded folks to enjoy conversations and laughter, and God forbid to sing and to dance to wonderful music. Sadly, I have lost many friends due to my disagreement with the regime and have a growing concern about the changing dynamics amongst people, and the increasing mental health pandemic that will follow.

In the wake of the March for Freedom in central London on Saturday 20th March 2021, I feel a surge of excitement about possible changes to our society as the establishment is challenged in more ways than one. I am looking forward to joining hands with people who are passionate about our freedoms and to also pay tribute to all those who have lost their lives as a result of lockdown.

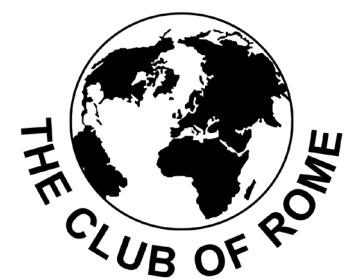
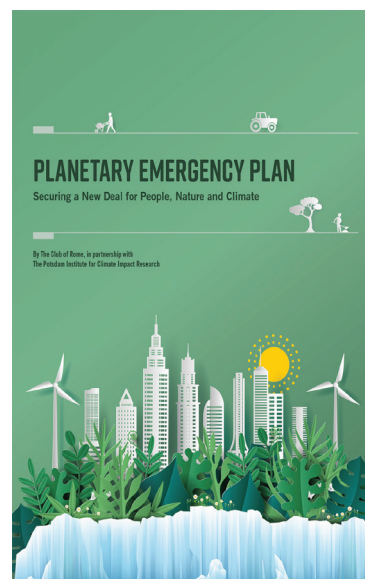
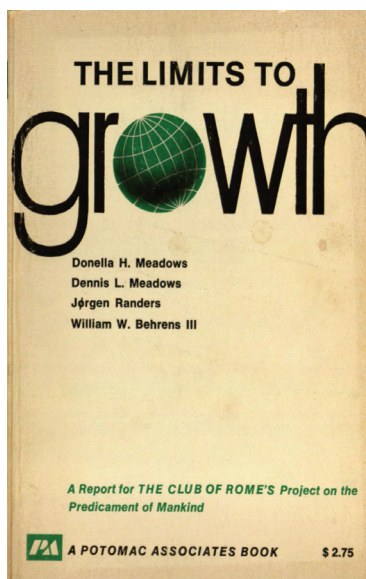

position comes reproduction. Whilst the UNESCO and UN literature provide guidelines for children from the age of 5 and above, the WHO guidelines begin at age 0-3. All literature on sex education, whether at an international level or local government one, stresses the need for material to be age/development-appropriate. With this in mind, let's skip to the syllabus matrix of the WHO's document.

One topic for 0-4 year old children is "enjoyment and pleasure when touching one's own body, childhood masturbation". Another is "the right to explore gender identities". In the 4-6 year old bracket we see the need for information to be provided on "friendship and love towards people of the same sex" together with this ethically and linguistically dubious recommendation from another table: "If the experience /feeling is not good you do not always have to comply". Is this clarified or muddied further by the insertion of another point of information for the same age group which states "some people pretend to be good but they might be violent"?

Could we be forgiven for thinking that children are being encouraged to use tenderness and pleasure as a thermometer for what does or does not constitute bodily violation?

The same children who have been encouraged to explore their own genitalia in a pleasurable way from birth? Could the emphasis on pleasure from a young age become a barrier to disclosure of sexual abuse in the future? Perhaps none of us have the answer.

Another important area for consideration is the type of resources that are being used to implement this curriculum and the motivations of those charities and organisations involved in delivering them.

Some of them are heavily involved in gender re-assignment. Indeed, the BBC itself has various videos on transgender journeys undertaken by teenagers on its educational pages. In one BBC video aimed at and involving pre-pubescent children, they are "expertly" informed that there are 100 genders in existence. It strikes me that we all need to question the wisdom of presenting children with highly confusing and possibly damaging concepts at such an age.

Some resource videos contain graphic references to bondage, anal sex, facial ejaculation, and some sexual practices that many of us might never have encountered before.

Lastly, it is time to consider some of the "experts" involved with advising the UN on their sexual agenda. Some of them came from the Kinsey Institute which has gained global recognition in good and bad ways. Its founder, Alfred Kinsey felt himself to be a victim of paternal and religious suppression. His aim was to release society from its sexual guilt. Some would argue that he always remained a victim, given his masochistic sexual practises. In his book on male sexuality published in the late 1940s, he included tables which correlated data that he had acquired from the observations of practising paedophiles. The perpetrators were referred to as "partners" and the tables logged the duration of the children's stimulation by the adult and the length of time it took the children to reach an orgasm and the frequency of the orgasms. The ages of the children were between 2 months and adolescence. One 4 year old was "observed" over a 24 hour period.

The use of the word 'orgasm' was obviously a subjective one on the part of the observer, which is one of many reasons to discredit the science of such data.

Kinsey once said "It is difficult to understand why a child, except for its cultural conditioning, should be disturbed at having its genitalia touched." Another observation of his brings us back full circle to the WHO's definition of sexuality: "We are all sexual beings from birth."

We all look at a baby and recognise its aura of complete innocence. Could it be that Kinsey, in his zeal to release society from sexual guilt and repression, actually threw the baby out with the bath water by sacrificing childhood innocence in the name of pseudo-science? And could it be that this worldwide roll out of dubious and explicit sexual 'education' spearheaded by the UN is doing the same thing? If the nature of their curriculum and the resources used to teach it are such that we normally have to refrain from discussing them within earshot of young children, then the answer is probably a resounding "yes".

We are also running a Network Survey which can help you find

candidates to support. This is the 'network' aspect, as we are co-operating with similar parties and candidates. If you want to make a difference in May, fill in the Network Survey on the Democratic Network web site. The long version of the survey covers your views on health, democracy, policing and media.

Are you contesting the London Mayoral or PCC elections?

Not this time; however, our early survey results do not make comfortable reading for the police and the PCC's (Police and Crime Commissioners).

Would you like to be an MP?

No. Our constitution clearly states 'Career politicians need not apply!' A key part of our approach is that we do not seek election in Westminster. This means our Councillors can focus on local issues and serve the interests of

their communities. There is no Westminster party line to tow - our policy is to be practical, accountable and represent the people.

What makes you think you can do the job?

In recent years my wife and I have had some interesting challenges with the local authorities which I think we've met with determination. Our personal experiences motivated us to get involved in local politics.

My day job as a statistician and market researcher, is about using information to make better decisions, solving difficult problems. The next four years are likely to be challenging for everyone. We need some good decision makers.

We Have To Move Quickly To Halt The Covid-19 Coup

Everything that has happened in the last year or so was planned. Nothing related to covid-19 has happened by accident.

Conspirators have been planning this coup for decades. Every detail has been worked out and their plans reach far into the future.

It isn't difficult to prove that covid-19, the lockdowns, the face masks and the social distancing are all part of a conspiracy designed to create fear and compliance. As I predicted on March 18th 2020, the plan was always to move onto mandatory vaccinations. The exaggerated threat of an annual flu was chosen as a weapon to push us towards a programme described as Agenda 21 – also known as the Great Reset or the 'new normal'.

The infamous virus being used as an excuse for permanent changes, started life as an ordinary winter flu.

The AIDS scare was probably the first time an infection was used in an attempt to frighten us into obedience. That failed when it became clear that the forecasts made for it had been wildly exaggerated. (They claimed that every family in Britain would be 'touched by AIDS by the year 2000'.)

There were a number of recent attempts with over-promoted infections. Neil Ferguson's fingerprints

were over most of the recent attempts to scare us into compliance. His track record is so appalling that if Ferguson were a race course tout, you'd steer well clear.

Today's fear is being created as justification for a constant stream of oppressive new legislation. They're banning protests, introducing mandatory vaccinations and planning health passports. They're even making football illegal because it doesn't fit with the absurd Agenda 21 re-wilding plan.

On March 19th 2020, the public health bodies in the UK, and the Advisory Committee on Dangerous Pathogens decided that the new coronavirus should no longer be classified as a 'high consequence infectious disease'. The coronavirus was downgraded to flu level. (There's a link to the relevant page of the UK Government website on www.vernoncoleman.com).

I published details of the downgrade on my website the day it appeared and assumed, innocently, that the mainstream media would carry the story, that everyone would breathe a sigh of relief and get on with their lives.

But, the mainstream media suppressed the news.

And hours later, the UK Government ignored its own advisors and introduced lockdowns and the most oppressive Bill in British Parliamentary history – a 358-page long Emergency Bill which gave the Government and the police unprecedented powers, and which turned Britain into a police state. Public meetings were banned and new powers were taken to restrict the 'use and disclosure of information'. Those working for the NHS were prevented from speaking about the lies and deceit.

Overnight, Britain became a police state. Freedom, democracy and free speech became history. Those who

dared to speak out were demonised and libelled.

The same bizarre things happened all across the world. Billions were put under house arrest. Economies were wrecked (to ruin small businesses and enrich billionaires). Schools were closed. Many hospital departments were shut leaving hospital staff so underworked that they started dressing up and doing silly dances to entertain the cancer patients being denied treatment. The official figures showed that hospitals had rarely been quieter. In care homes thousands were murdered as the elderly were denied medical care. The Government told us to protect our grannies while doing everything it could to kill them off.

Classic brainwashing techniques were introduced to create terror and compliance. The Government hired military psychologists to keep citizens frightened and a propaganda unit of the British Army (the 77th Brigade) was used against those British citizens who defied the coup and chose to share the truth.

It was clear that the lockdowns and closure of hospital departments would kill far more people than covid-19. Doctors could see this but most obeyed the Government's instructions and, to their shame, remained silent.

These deaths were used, as planned, to create the myth that covid-19 was a deadly plague. Governments across the world decided that anyone who died within a month or two of coughing, or testing positive for a coronavirus, must have died of covid-19. Thousands of patients dying of cancer, heart disease and other disorders were deliberately labelled as covid-19 deaths. The ordinary flu disappeared. No one in the media took much notice of the fact that governmental advisors had close links to vaccine manufacturers and the Bill and Melinda Gates Foundation, which had big investments in vaccine manufacture. Around the world politicians handed out billions of dollars' worth of contracts for masks, rubber gloves and testing kits to their chums. Corruption went unnoticed.

When even all these extra deaths weren't enough to keep people terrified, governments introduced a faulty testing programme designed to create more false positives than real positives. Special testing stations were set up and young schoolchildren (more likely to die from a lightning strike than covid-19) were forced to wear masks and have regular tests. The masks were designed to control people, not viruses. The tests were manipulated to

enhance the fear.

It is normal to measure the incidence of disease by using annual figures. With flu the figures are totted up in six monthly clumps. But with covid-19 the alleged deaths were added up on a rolling, never-ending basis to try to make the total look terrifying.

No one mentioned that the flu can affect a billion people a year, and kill 650,000 in a six month flu season.

And all the while they promised us freedom when the experimental 'vaccines' came.

It was a lie.

The 'vaccines' don't stop anyone catching covid-19. And they don't stop anyone passing it on. If the 'vaccines' do anything they simply reduce the significance of the symptoms associated with covid-19. But since most people who get covid-19 don't have any symptoms that's hardly much of an incentive to take an experimental injection.

So, the politicians and the journalists and the doctors lied and said that the 'vaccines' would prevent the infection.

And they lied and said there weren't any side effects.

Government agencies all over the world reported that thousands of those who'd been vaccinated had fallen ill or died. But politicians and doctors dismissed the figures (you can find up-to-date figures on my website) and said that if anyone dropped dead five minutes after an injection then it was merely a coincidence.

I suspect the experimental 'vaccines' will, in the end, kill more people than covid-19. (They've had to change the dictionary definition of 'vaccine' to accommodate these experimental products which have about as much in common with traditional 'vaccines' as Boris Johnson has with the word 'statesman'.)

Die within 28 days of having a cough, or a false positive test, and you died of covid-19. Die within 28 minutes of having a covid-19 injection and it was a coincidence.

We are living in a world ruled by liars.

It's only just begun, of course.

The 'vaccines' were promised as a panacea. But they aren't and they won't be. They weren't designed to get rid of covid-19. They were designed to control people and, I believe, to kill.

Next autumn and next winter the 'vaccines' will kill thousands. And those deaths will be blamed on covid-19 variants and on the newly designated 'long covid'. (The flu, too,

can produce long-term problems in some patients but it was never dignified as 'long flu'.)

It will all be our fault, of course. In the same way that 'global warming' is 'our' fault – for which we must be punished.

The rising number of deaths will be blamed on those who refused the 'vaccine' and on those who told the truth and campaigned against the coup.

There will be ever more oppressive legislation. New laws are coming every day. Elections will be postponed permanently. Regular vaccinations will be mandatory for those in certain occupations or for those wanting to enter public buildings or supermarkets. Travel, even within the UK, will be constrained. Cash will be banned. We will all be controlled by constant assessments of our behaviour, through the intrusive programme of social credit scoring advocated by Agenda 21 enthusiasts. If you want to know what life will be like, take a look at China or North Korea or think back to the USSR or East Germany – and imagine things to be far worse.

They have everything planned and time is running out. We have to move quickly if we're going to stop this:

Don't comply with pointless or dangerous rules and regulations. Question everything.

The Government website states that if 'putting on, wearing or removing a face covering will cause you severe distress' then you are exempt from wearing one.

Use cash whenever you can. If your cash is refused then take your business elsewhere. A cashless society will lead to enslavement.

Share the link (on my websites) which shows that covid-19 was downgraded to flu level in March 2020. Governments have known for over a year that covid-19 is no worse than the flu.

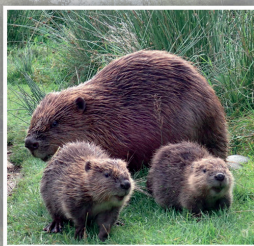

Public Debt Now At 97.5% Of GDP

The government borrowed £19.1bn last month, marking the highest figure for February since records began amid the spiralling cost of support measures during the pandemic.

Figures from the Office for National Statistics (ONS) showed public borrowing ballooned thirteenfold to £19.1bn in February this year - up from £1.5bn in the same month a year earlier.

Borrowing for the year so far has reached £278.8bn - marking a first quarter record. Government bodies have spent an estimated £72.6bn on day-to-day activities in February 2021, including £3.9bn on coronavirus job support schemes.

The figure easily dwarfs the levels of borrowing seen in the aftermath of the financial crisis in the UK.

Total public sector net debt has now risen to £2.13 trillion, after a £330bn rise over the first eleven months of the financial year, according to the ONS.

It means public net debt now stands at 97.5 per cent of GDP - a level not seen since the early 1960's.

The Office for Budget Responsibility (OBR) has said that public debt levels are expected to push through the 100 per cent mark and hit levels not seen since the Second World War.

Covid Ushering In Great Reset Economy

Back in February of this year the UK Office for national statistics reported that the UK economy had shrunk by an unprecedented 9.9% in 2020, which "was more than twice as much as the previous largest annual fall on record" they explained. However what the ONS didn't make quite as clear was that this figure would have been much much worse if it wasn't for the fact we now have a totally new sector of the national economy, namely the 'covid economy'.

ONS deputy national statistician Jonathan Athow gave the game away when he said: "An increase in covid-19 testing and tracing also boosted output. The economy continued to grow in the fourth quarter as a whole, despite the additional [lockdown] restrictions in November." In other words our pre-pandemic economy and way of life is being replaced piece by piece by a

With the real economy moribund and tax revenue falling off a cliff, how will the government finance these sinister ventures? The answer came recently from the Bank of England governor Andrew Bailey who told the BBC's Today programme he was looking at 'new tools' to deal with the economic fallout from lockdown. LIGHTING

There is nothing worse than trying to navigate anywhere, even in your own house, in pitch black.

Candles, torches, spare batteries, lanterns, matches and lighters - have them easily accessible in a power cut. Light is very important - power cuts from storms or grid failures are inevitable at some point so be prepared.

Also invest in a good battery-operated headtorch.



COOKING

Even though most tins can be eaten cold, you may prefer to cook them - don't underestimate the psychological power of a hot meal to look forward to. With no power, gas, electric etc. invest in a camping cooker with the small disposable gas canisters. They are cheap enough so make sure you buy plenty of gas for long term use.

Store safely away from too high or too low temperatures. You will be glad you brought one when the time comes.

Learning to cook on an open fire (and rigging up simple tripods etc. for hanging pots) could also well be useful.



FIRST AID

Make sure you have a good first aid kit, together with some basic medications, and know how to use them. Think of bandages, plasters, tape, scissors, hydrogen peroxide, steristrips and also basic medications, antiseptics, pure alcohol etc.

With no access to doctors or hospitals, keeping infections down is important so also have vitamins, colloidal silver and other non-pharmaceutical remedies on hand



FOOD

Tinned foods and dried foods have long shelf lives and store well - buy a little extra each shopping trip to store away.

Think about proteins, carbohydrates and vitamins. So, using meats for an example, include canned ham, corned beef, tuna, sardines and good old spam. Think also of tinned fruits and don't forget a tin opener.

Dried goods like pasta, rice, dried milk, eggs, dried fruits and importantly, flour and yeast so that you have ability to make your own bread. Learn to cook.

Always store what you actually eat and rotate it regularly as disaster doesn't strike that often. If you don't eat spam, ever, then don't store it.

Learn to grow food, even in pots in a small yard. Learn to fish, as stored food will eventually run out.

WATER

If the water stopped coming from your tap, or you could not buy it, how long would you last?
3 days is the average.

Storing water and/or having a good filtration/rainwater catch system is absolutely vital - think about the amount of things you use water for every day aside from drinking.

Plastic bottles must be kept in a cool, dry place out of sunlight, glass bottles won't leach chemicals but glass is fragile so store correctly. Also have some sort of filtration device/system in case you have to venture out to get water as your stores won't last forever. You can easily turn guttering and a barrel into a rainwater catch system, and know where any local fresh streams/wells are.

WARMTH

In Britain we are lucky not to have extreme cold temperatures, but still going through a winter with no power could be very unpleasant.

Extra blankets, sleeping bags and even portable gas heaters can all help.

Invest in some emergency survival shelters and foil blankets that can retain your body heat, also gloves, hats, scarves and hot water bottles.

TOILETRIES

As we have learned with the toilet roll buying epidemic, if you prepare carefully you will not have to join the hordes of panic buyers.

Stock up toilet roll, feminine hygiene products, baby wipes, toothpaste, soap, cotton balls and buds. Also stock some washing powder (not the gels) so if needed you can wash clothes by hand.

In emergency situations, hygiene is very important so also store plastic sanitary bags for disposal of any waste.

POWER

Keep tons of batteries for torches, lights, lamps, etc.

Solar power is another option - there are systems from 10W to 10000W and beyond - you can have something that suits your needs and these can help recharge small devices. On a bigger scale, they can run appliances like washing machines and refrigerators.

A generator is a more expensive option and needs fuel. Unless the generator is silent, it can attract unwanted attention.

You must be able to trust and rely on each other so get to know people now where possible. We still are pack animals and we need each other. There is nothing stronger than a tight community.

A 21st Century Plantation In Ireland

The Irish government are planning to transfer vast amounts of state land and property to a private company called the Land Development Agency (LDA). The LDA and the Irish government are hoping that a legislative Bill will be passed before the summer allowing the LDA to deliver housing projects in state owned land across the Republic of Ireland. The move will bypass local authority in the sale and purchase of public land and property.

The Land Development Agency Bill 2021 sets out the commercial, state-sponsored body's goal of undertaking strategic land assembly and building affordable homes and sustainable communities. Housing Minister Darragh O'Brien has said the agency will drive up housing delivery. The aim of the Bill, according to the Housing Minister, is to fulfil one of the governments key objectives of increasing housing supply during a housing crisis in Ireland.

Opposition in the Irish Parliament believe it will drive up house prices instead. Richard Boyd Barrett, who is a Teacher Dála (MP) for the Solidarity-People Before Profit party, says, "The LDA is a Trojan Horse for

the pillaging of the public land bank". He went on to say that "the Bill will do nothing to guarantee affordable housing but will create a mechanism through which public land will be transferred out of direct public control

without any accountability".

Many are concerned that local councils will be stripped of their powers regarding land and property. The controversial Bill allows the LDA to have first refusal to purchase public land being put up for sale. The Bill will also allow the LDA not

to require pre-consent from elected officials in local authorities in making purchases. A major advantage that the LDA has over local authorities is their funding. They have at their current disposal 2.5 billion Euros,

half of which comes from the Irish government and the other half in loans from the European Investment Bank.

Unfortunately, Ireland has been here before. The National Asset Management Agency or NAMA was a government initiative set up in 2009 aimed at fixing the corrupt and broken Irish banking system. The aim of the agency was to take over property loans from the banks in Ireland. Its job was to restore economic recovery and a functioning property market. A rallying cry from NAMA at the time was "We will chase developers to the ends of the earth". As expected with government-approved agencies, NAMA was engulfed in controversies including close connections to property developers, and accumulating billions of Euros of losses to the Irish taxpayer.

Many Irish people are naturally concerned and sceptical about the motives behind the state-approved and sponsored agency. Many feel it

opens the doors to the privatisation of land and property in Ireland by giving carte blanche to a dubious company. There are worries that many thousands of families and first-time buyers will be locked out of securing affordable housing and be at the perils of greedy developers, again. According to the Dublin Renters Union, "The set-up of this private agency is completely pro-landlord and developers".

Others simply view the Bill as a land and power grab and have renamed the private company the 'Landlord Development Agency'. The proposed legislation aligns with the goal of the World Economic Forum, "You will own nothing, and you will (still) be happy".

The Irish government are currently engaging with the European Commission that the legislation is in line with EU state-aid rules. The Land Development Agency Bill has already passed its first vote in the Irish Parliament.

Tanzanian President Who Refused Covid Narrative Dies at 61

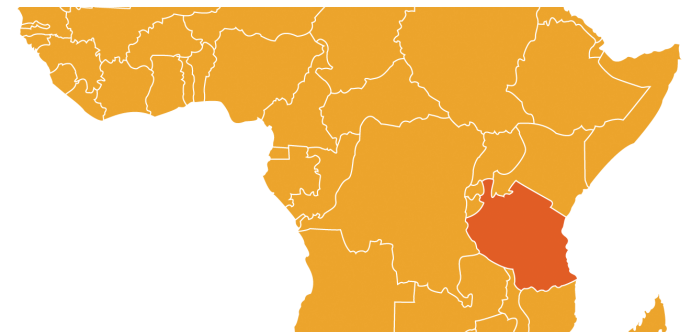

After spending the last year disputing the global narrative about covid-19, lockdowns and vaccines, Tanzanian President John Pombe Magufuli was pronounced dead on March 17 at age 61 as mystery and suspicion surrounded the circumstances of his passing.

The official announcement came March 17, when Vice President Samia Suluhu Hassan disclosed Magufuli's death to the nation during a television address. "Dear Tanzanians, it is sad to announce that today 17 March 2021 around 6 p.m. we lost our brave leader, President John Magufuli, who died from heart disease at Mzena hospital in Dar es Salaam where he was getting treatment," proclaimed Hassan.

Hassan said Magufuli had been admitted to the hospital on March 6 but discharged the next day. A week later, he was taken in again for his heart condition, which Hassan and government authorities have insisted was the cause of his death.

Magufuli made headlines for defying the globalist narrative and response to covid-19 since the disease was found in Tanzania. He rejected closing churches, calling on people to pray to God instead of being afraid, and reassuring fellow Catholics that the virus would not be transmitted through the Holy Eucharist. "The coronavirus cannot survive in the



Eucharistic body of Christ; it will soon be burnt away," he said.

Contrary to the majority of the Western world, Magufuli declined to lock the country down, and the country has not reported any information about covid-19 to the World Health Organization (WHO) since April 29, 2020. On that day, 509 cases and 21 deaths were reported. In June, Magufuli declared that the country had eradicated the disease.

Nor is this the only way that Tanzania's former president is likely to have angered globalist politicians. After PCR tests famously yielded positive results from a goat and a pawpaw, Magufuli rejected them as unreliable, saying they had "technical errors." His words have since been supported by an independent group of 22 scientists, who identified "10 fatal problems" with the widely used PCR tests, noting that each problem on its own was enough to render the tests useless in identifying covid-19. This should beg the question 'what

have all those 'positive' tests been finding?' and 'how can they declare a public health emergency and initiate draconian lockdown policies on such ridiculously unreliable tests?'

Magufuli, who had a doctorate in chemistry, also warned Tanzanians against becoming 'guinea pigs' for the various experimental covid injections, saying: "If the white man was able to come up with vaccinations, then vaccinations for AIDS would have been brought, tuberculosis would be a thing of the past, vaccines for malaria and cancer would have been found."

He was replaced by Hassan, who was sworn in March 19 with her hand on the Koran. She will serve the remainder of Magufuli's 2nd five-year term, which began in November 2020. She was employed as a project manager for the UN's World Food Programme and is a member of Klaus Schwab's unelected policy-shaping World Economic Forum.

America Opening Up

President Biden made a statement last week that Americans might be able to gather in small groups by July 4, to celebrate Independence Day. One wonders who is protecting him from the reality: most of the country is almost entirely back to normal.

Outside of California and some Northeast states, the lockdowns have largely ended, with ever more states repealing restrictions and mandates. Reimposing them for any reason seems almost unthinkable at this point. Anthony Fauci's constant prattle about the dangers of opening up are falling on deaf ears.

The few states that are still locked down are rapidly losing residents and businesses. States that are entirely open are gaining them. As for travel, against which the CDC warns, the nation's airports and highways are back to pre-lockdown levels of normal. The slogan 'land of the free' is starting to mean something again.

Even the New York Times, which has led the lockdown effort for longer than a year, is starting to back-pedal, finally. An article called "I Would Much Rather Be in Florida" points out: "much of the state has a boomtown feel, a sense of making up for months of lost time. Realtors cold-knock on doors looking to recruit sellers to the sizzling housing market, in part because New Yorkers and Californians keep moving in. The unemployment rate is 5.1 percent, compared to 9.3 percent in California, 8.7 percent in New York and 6.9 percent in Texas. That debate about opening schools? It came and went months ago. Children have been in classrooms since the fall...."

"Florida's death rate is no worse than the national average, and better than that of some other states that imposed more restrictions, despite its large numbers of retirees, young partyers and tourists. Caseloads and hospitalizations across most of the state are down...."

"Try to buy a home and the experience is frustrating for a different reason: an open house will have 30 cars parked outside. Though Florida's population growth has slowed during the pandemic, documentary stamps, an excise tax on real estate sales, were 15 percent higher in January than they were a year ago. Filing fees for new corporations were 14 percent higher."

Also notable is that the heavily curated comment section of the article is packed with people saying that we never should have locked down – a point of view practically banned for

the better part of a year.

Meanwhile, the science behind accepted postulates such as the 6-foot-of-distance rule is unraveling by the day. A study from Massachusetts found essentially no differences in rates of infection in students whether they are standing 6 feet or 3 feet apart. This prompted even Fauci to walk back his long-standing demand that students be 6 feet apart – just the latest of many flip flops. The study didn't examine what would happen if everyone just behaved normally, as they do in Florida. In fact, one of the missing pieces of research for a whole year would have compared a normal-behaving, maskless community with one that complied with all the extreme lockdown measures. The closest we have to this are the many studies showing no correlation at all between lockdowns and disease control.

Remember that the whole notion of managing people's lives to control a virus stemmed from untested models. That people should be compelled to stand apart is related to what Edward Stringham (President of the American Institute for Economic

Research) calls "Sim City Thinking" – the belief that society can be operated the way people play with computer games. It might have been wiser to have looked more critically at those models before adopting them the whole world over in the midst of a disease panic.

The terrible damage of the lockdowns has become palpably obvious. UNICEF reports:

- In developing countries, child poverty is expected to increase by around 15 per cent. An additional 140 million children in these countries are also projected to be in households pushed below the poverty line.
- Schools for more than 168 million schoolchildren globally have been closed for almost a year. Two-thirds of countries with full or partial closures are in Latin America and the Caribbean.
- At least 1 in 3 schoolchildren has been unable to access remote learning while their schools were closed.
- Around 10 million additional child

marriages may occur before the end of the decade, threatening years of progress in reducing the practice.

- At least 1 in 7 children and young people has lived under stay-at-home policies for most of the last year, leading to increases in anxiety, depression and isolation.
- As of November 2020, an additional 6 to 7 million children under age 5 may have suffered from wasting or acute malnutrition, resulting in almost 54 million wasted children, a 14 per cent rise that could translate into more than 10,000 additional child deaths per month – mostly in sub-Saharan Africa and South Asia. With a 40 per cent decline in nutrition services for children and women, many other nutrition outcomes can worsen.
- As of November 2020, more than 94 million people were at risk of missing measles vaccines due to paused campaigns in 26 countries.

The toll on civil liberties at home and around the world has been

devastating, and many are questioning whether any of it was necessary.

As Florida governor Ron DeSantis says now with some frequency: "lockdowns do not work and they cause immense harm." More opinion pages are admitting, as the Las Vegas Review Journal has said: "Virus lockdowns don't appear to have worked as advertised." Don't hold your breath waiting for the New York Times editorial page to admit that. Perhaps someday, but it won't come soon enough for many.

The lockdowners committed themselves to something previously unthinkable. To admit error at this point is too intellectually and psychologically upsetting. Regardless, we can be confident that as the years roll on, there will be a growing consensus that, as Jay Bhattacharya (Professor of Medicine at Stanford University and co-author of The Great Barrington declaration) has said, "lockdowns are the worst policy error of our lifetimes and many generations."

true – and nothing was more terrifying to the bankers than a developed, united Africa.

In a statement, the rebel council announced, among other things, the creation of a new oil company, and more significantly, "Designation of the Central Bank of Benghazi as a monetary authority competent in monetary policies in Libya and appointment of a Governor to the Central Bank of Libya, with a temporary headquarters in Benghazi".

So in just a few short weeks, amid complete unrest in Libya, not knowing if they would or could maintain their new-found power, these mostly financially-illiterate 'rebels' thought that a Central Bank would be a good idea? Why change something that had worked perfectly for years, had brought Libya out of poverty, something that the nation owned, into a new central bank owned by the same elitist criminals that own America's Federal Reserve? Why hand over all of their resources to an international banking cartel? To thoughtfully and generously prevent a 'world-wide financial panic' or because they were under the control of the international bankers in the first place?



- Gaddafi put up a communications satellite, the first by an African nation, to bring the continent of Africa into line with 21st century technology. This also bypassed the massive fees that European companies had been charging Libya.
- He gave women full access to education and employment.
- Gaddafi nationalised his nation's oil reserves and used the revenue to build schools, universities, hospitals and infrastructure.
- Money from Libya's oil revenue was regularly deposited into the bank account of every citizen.

In 2010 Gaddafi offered to invest \$97bn in Africa to free it from western influence, on condition that African states rid themselves of corruption and nepotism. Gaddafi always dreamed of a well-developed, united Africa and was about to make that dream come

warrant. The proposed Gold Dinar instituted by Libya would have had serious consequences for the corrupt world financial system, but would also have empowered the people of Africa, which the bankers wanted to avoid at all costs.

Gaddafi's Gold Dinar plan and his intention to cease selling Libyan oil in US dollars, demanding payment instead in gold-backed dinars, would have destroyed the US dollar according to many observers. The regime, sitting on massive amounts of gold, estimated at close to 150 tonnes, was also pushing other African and Middle Eastern governments to follow suit.

Saddam Hussein attempted something similar in 2000 with the result that Iraq was invaded and he was eliminated. Iran began selling oil in euros rather than US dollars and the country was immediately placed on the 'hit list' and totally vilified. And as soon as Gaddafi began plans for the Gold Dinar and 'gold for oil', he

financial security of the world". The elite were apparently panicking over Gaddafi's plans.

"Any move such as that would certainly not be welcomed by the power-elite, who are responsible for controlling the world's central banks. So yes, that would certainly be something that would cause his immediate dismissal and the need for other reasons to be brought forward for removing him from power. The central banking Ponzi scheme requires an ever-increasing base of demand and the immediate silencing of those who would threaten its existence. Perhaps that is what the hurry was in removing Gaddafi in particular and those who might have been sympathetic to his monetary idea. Investor newsletters and commentaries had been buzzing for months with speculation about the link between Gaddafi's Gold Dinar and the NATO-backed overthrow of the Libyan regime. Conservative analysts pounced on the potential relationship, too,

Forest Occupation Movement Germany

Lignite mining, express highways, gravel mining, parking decks, lime pits, and candy factories all have something in common that might not be obvious at first glance. Capitalists need to cut down forests to make way for them. But all around Germany, people are mobilizing to stop them. Over the past decade, forest occupations and forest defence actions have proliferated to such a point that we can now reflect on the movement as a whole.

Together against the megamachine: in this photo from 2014, a year before the mass “EndeGelände” actions began, we see a small group of people on their way to interrupt one of the massive diggers at a coal mine. Even facing seemingly impossible odds, small groups can experiment with tactics that later serve as the basis for mass actions and victories.

Since 26 February 2021, people have been occupying a forest near Ravensburg called Altdorfer Wald. A gravel pit is threatening the forest’s existence and some activists who had earlier built climate camps and tree houses in the inner city of Ravensburg decided to live in the forest to protect it. At the moment this occupation is not facing eviction.

On the day of the occupation near Ravensburg, at the other end of Germany police began the eviction of an occupied inner-city forest. In Flensburg, in October 2020, people had begun building tree houses and platforms to save the trees, which were slated to be cut down to make way for a hotel and parking deck. A matter of days before the end of the legal cutting season, the investors sent cold-blooded mercenaries with chainsaws to attack the trees despite

the risk to activists. The city politics rewarded the investors’ misdeeds by ordering more police to attack and evict the occupation at the very moment that Flensburg was one of the covid-19 mutation hotspots in Germany.

Speaking of the pandemic, the Green Party in Hessen has lost support even among middle-class people, as they not only argued for the new express highway A-49 and as a result for large cuttings in Dannenröder Forest, Herrenwald and Maulbacher Wald, but additionally initiated an eviction that lasted weeks in November 2020, even though the region was also a covid-19 ‘hotspot’. The occupations in these forests had started in 2019; some protesters still remain nearby, as the highway is not yet constructed, even though the trees on the future trail have been hacked down. One of the most spectacular actions involved a 300-meter-long traverse of rope connecting Danni and Herri.

Likely to the surprise of many of those involved, another occupation has been successful: On 21 February, near Halle (Westfalen), demonstrators occupied the Steinhausener Forest where the candy factory Storck intended to expand. Less than a week later, while the occupiers were awaiting eviction, the company decided to change plans. At least for the present the forest is safe.

In Wuppertal, at Osterholz, five hectares of forest are endangered because of a lime pit. The Kalkwerke Oetelshofen aims to store the earth that they excavate where there are trees. People have been occupying the area since August 2019. Just as occurs everywhere else, the



capitalists who are profiting from destroyed forests seek to frame their propaganda as “objective discussion”, they complain about alleged “defamation” and emphasize that their business is of systemic importance. Indeed, any capitalist business is of systemic importance - but as the system itself is the root of the problem, this argument is not convincing for those who want to change the system. In any case, at the moment, they are not being permitted to cut down the forest.

In Wilhelmsburg, in Hamburg, in a forest called WiWa (Wilder Wald wild forest), people constructed tree houses because the city declared the area a potential development area. The activists in the forest developed platforms in the trees -

but this is probably not the kind of development politicians appreciate.

Furthermore, people are maintaining forest occupations in two villages in Rhineland that are threatened by lignite mining. The occupation in Keyenberg dates to September 2020, while the one in Lützerath just began on 16 January 2021. The resistance there is closely connected to those people who are trying to save the villages by occupying houses that the coal company RWE wants to destroy or by squatting construction equipment.

Finally, the most famous forest defence occupation of all, in the Hambach Forest, is still occupied. First squatted in 2012, it has been evicted and reoccupied several times. In January 2020, politicians decided

that Hambach should not be completely destroyed - after most of it already had been - but the occupation still remains. Recently, some people from Hambach published issue number 5 of the bilingual zine Shitbarricade.

And for those who like to travel internationally, there are occupations in Poland, Switzerland and France as well as fights in Sweden and Belgium that are networked with the fights in Germany.

Right Said Fred have made their mark in multiple ways.

They were the first UK band to debut at number one in the US since the Beatles. They have clocked number one hits in over 70 countries. Millions sing their classic 'I'm too sexy'.

Now they stand out again by being one of the very few bands with the courage to not only have spoken out against the current state of politics, but have put their feelings and observations into the lyrics of 'We are criminals'.

What happened twenty years ago, that made you click?

FRED: When the band first kicked off, there were lots of lies told about us. They said we were both gay, or that we were lovers. It struck me that was if they were happy to tell such easy lies about us, the lies can't stop there.

I started reading authors like Paulo Coelho.

I was introduced to Alex Jones and liked him until he started shouting. I moved on to The Power Hour and Richie Allen, then CIA whistleblowers like Ray McGovern. I'm not a David Icke fan. I just don't click with his style, probably in the same way he might not like our band, but that said, many of his predictions have come true.

I followed the Media Monarchy and the Corbett report. I then came across the Q-Anon people. I don't agree with them all, but find them interesting.

I've now been down the rabbit hole for 20 years. Because the 'Operation Lockstep' plans have been discussed since 2010, what is happening now isn't as shocking for me as it might be for some.

RICHARD: I think it all started with seatbelts. When you buy a car, you buy the space inside, yet we have allowed the state inside our spaces to tell us how to behave. Now you're not allowed to even look at cigarette packets in a shop. When bad things happen, it's not God, it's the state. We then expect the state to put it right.

And now the state takes responsibility for our health. The State also has God-like all-seeing eyes with CCTV cameras.

FRED: And also they're getting people to snitch on each other.

RICHARD: When growing up, if the Second World War was mentioned, people would say, "Well, it couldn't happen here."

British people are not thinking for themselves any more and just doing exactly what they're told. The state tells them how to behave, how to

socialise, how many vegetables and salads to eat and when to watch the TV.

It's the salami-slicing of intrusion. They used to say, people were only aware of the British state three times in their life. When they got married, bought a stamp or when they died

Now, the State is in your face 24/7, even to the point of putting footprints on the floor, so you know where to stand when out and about.

FRED: It definitely feels like a spiritual war. People are being divided. I don't think it's a coincidence that there has been an attack on everything to do with mass gathering. Pubs, community centres, churches, parks, gyms, there's been an attack all of them. This is meant to be about our health and well-being, yet they close down gyms? We used to manage gyms back in the 80s before Sexy broke. The one thing you do is you keep gyms really clean, not far off from a doctor's surgery.

RICHARD: It's all been about fines, gloom, finger wagging, control and coercion. There has been no sort of spiritual uplifting message at all. People want some hope.

Which reminds me of the lyrics to your Nov 2020 song, 'We are Criminals' - "Can't Kiss, Can't hug. Can't dance. Can't Love."



Tell us how the song came about?

FRED: Although Right Said Fred are meant to be happy we needed to purge our system of some dark cynical thoughts and that became 'We are Criminals.'

Our latest song is 'Your Inner Light is Love' is much more of an upbeat, positive vibe. On the march through London on Sat 20th March, the inner light was very obvious.

RICHARD: I was with the lady from Portsmouth. She said her friends

at work and neighbours think she is bonkers. Being with like-minded people was psychologically really important for her.

FRED: We've both had problems with depression. Richard deals with it better than me. I fell apart about six weeks ago. I could feel, my spirit and well-being just disintegrating. I felt really lost and adrift. It was horrible. Things like last Saturday's 20th March protest are really important to people's mental and spiritual state.

absolutely vital.

I read and listen to people that I find inspiring,

I listen to music that resonates or makes me feel good. Although you might want a burger and chips, you've got to be careful not to shovel too much rubbish into your body.

When the government is waging war on us, we need to be fit and healthy to deal with it.

Back to the 20th March. The protest took over Central London. A stunningly peaceful and upbeat atmosphere. How many people do you think there were there?

FRED: There were three marches. Oxford Street. The Millennium to Downing Street. And Trafalgar Square. I reckon there must have been 120,000 people.

RICHARD: The BBC said there were twelve people!

Did you notice the difference with the drivers beeping, giving their support?

FRED: Huge difference. I was stunned. The response was incredible. I found it really heartwarming. A friend of ours who's never been on a march before came along and screamed, "This is great!"

As famous artists, you guys have had the courage to put these songs out there. Where are the other pop stars?

FRED: My gut feeling is they have got managers, agents, sponsors or record labels breathing down their necks. Anyone who has a sponsorship deal with a sports company or the perfume will have a clause for best endeavours, meaning at all times you

must do the right thing in terms of representing yourself, the record label and not put record sales at risk,

Back in 1995, we decided to go independent, so we are free to speak.

RICHARD: If you go back to the 60's, music was at the forefront of protest. Pop has withdrawn itself.

FRED: It's us, Ian Brown, Jim Corr and Van Morrison.

We're surprised how quiet people like Gallagher or Stormzy have been, even though Liam Gallagher has said a few things about masks and stuff.

And the older punk bands? The Damned even have a promo with them wearing masks.

On a positive note, we came out of the March 20th protest of 100,000 or more with an amazing feeling.

What would you say to everybody going forward?

FRED: Vote with your feet and shop locally.

Non-compliance might sound like a cliché, but millions are a force that cannot be reckoned with. People don't seem to understand their collective power.

I expect that the spirit of like-minded people coming together will make the change. I think the numbers will be massive at the London protest on April 24th.

What's next for Right Said Fred?

FRED: We've been commissioned to write an autobiography and one of our films has been fully funded. We'll create another EP for June or July. Upbeat. Feel good. We'll just keep doing what we're doing!

Open Letter To Medical Professionals

An open letter to the peoples of the world, especially to the medical profession:

She lay in bed in a half-delirium, strongly sedated with morphine, hardly aware of her surroundings. She was barely 19. She, like every other patient, had no right to any visits. She begged the doctor to phone her mother. He refused. She had a panic attack and could hardly breathe.

They refused to wear a mask as it was too painful. The nurses refused to attend to them. One of them was being given oxygen. In her early 80s, she was so desperate for help that she complied and nearly suffocated. Her younger fellow patient who had lost her mobility refused and could not therefore go to the toilet for so long that her blood pressure went up to 20.

He began to have a chest pain. It would not go away. His difficulty breathing kept worsening. His wife drove him to emergency. He was not admitted because he did not present any 'covid' symptoms. He was sent home. Within hours he passed away. He was barely 70 and was known to be in good health. Only his wife was allowed to attend the funeral. She was banned from praying in the church. The priest was so afraid that he remained far apart and rapidly disappeared. His son, in his late 40s, unable to cope with a death which should not have occurred, prevented from attending the funeral, had a nervous breakdown. He was left without care: after all, he might infect everyone with 'covid'.

His kidney stone problem was diagnosed in September. He was supposed to be operated in November. The operation was postponed to

December, and once more cancelled. His pain became insufferable; he only survived with high doses of morphine. He went to emergency. They only tested him for covid and sent him home, then pestered him through calls and visits because he had tested positive. He was finally operated in late February, but by then his condition had worsened. He has been experiencing excessive post-surgical pain. He is only 41.

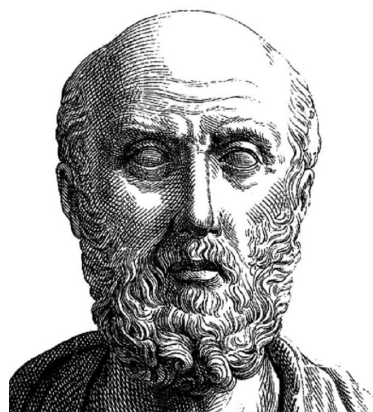
She suffers from low blood pressure and needs to regularly go to Accident & Emergency; each time her heart and other organ functions are properly checked. Unable to breathe when she went recently, she was only tested for covid, and she was pestered because she had tested positive. She is in her 30s.

She had serious knee pains and went to emergency. They refused to even consider her case because she refused to wear a mask. She is 80, she returned home, and had to nurse herself alone.

She broke her tibia bone. Where she is, the mask is compulsory outside. She suffocates with it, and even more so now that every step is such a physical effort. Her GP refused the certificate necessary for exemption. This is her response: "the severity of the pandemic does not accept any exception to the wearing of a mask; the physiotherapist can teach you to breathe well [through the mask]...before going out with you, both masked." This leaves her unable to practice walking outside. She is in her 50s.

These have since last year become commonplace stories.

We are letting people suffer and die by leaving them without medical care. We are letting people suffer and die by ensuring detrimental conditions, by misdiagnosing them and then giving them the wrong treatment. According to an administrator in one of the world's most prestigious hospitals: "all of our non-covid patients caught covid while hospitalised and have all died." Was this a consequence of misdiagnosis based on a test whose inventor said is not fit for this purpose?



The existence of a virus has not yet been evidenced. Not only has causality not been established, no specimens have been isolated. What are the tests, treatments and vaccines about in that case? What is the logic behind their development?

Whether doctor, nurse, admin or orderly, you who chose the responsibility to care for your fellow human beings in their greatest hour of need, step back and think about what you are doing, and are being asked to do. Talk to one other about concerns you may have. Is it not nonsensical

when you need help, to be told "we can't do anything for you, so we can protect you from covid"??

Why are you certifying on death certificates an unidentified disease as the cause of death, and ignoring the real causes? "She was 80, she had cardiopulmonary disease with increased breathlessness over the last 18 months, thyroid and stomach problems, and metal pins holding her extremely crooked leg together for the last 8 years. She was on 10 different medications, including a long-term and relatively high dosage of morphine. She came down with cold/flu-like symptoms a few weeks ago, had a 'test', it came back positive, which made her anxious, and one morning she fell while getting out of bed and broke her leg. They couldn't operate. Her oxygen levels plummeted. Her morphine intake increased massively. Her body shut down, and the Doctor gave covid-19 as the cause of death." This sadly is also an all too familiar story by now.

Think about your colleagues around the world who have refused to accept orders detrimental to their patients, preferring to lose their jobs than lose their humanity. Now is not the time to blindly accept the protocols being placed in front of you. Look into the eyes of the people under your care. Should your empathy not be with them instead of with a system based on false premises? How will you justify that you demanded or supported policies listed in Amnesty International's 1973 Report on Torture as methods of coercion used on prisoners of war and opponents by repressive regimes? How will you justify it to all whose health is fast deteriorating as a consequence? How

will you justify it to their families and friends? How will you justify to yourself that while claiming you were overwhelmed by severe cases, you posted videos of dance routines?

Read and question: all the information is there. Is there truly a dangerous pandemic? What are the variants of, if in the first place no virus has been identified? You do not need a Phd to comprehend. Science is not a matter of experts: trust should not be automatic. Questioning accepted ideas, not taking anything at face value, are characteristics of a scientific approach. The criticality of doubting has been insisted upon by scientific thinkers from all epochs and traditions.

Whatever you do, never lose your own humanity. Tolstoy wrote in 1902: "the majority have entirely lost the capacity of differentiating between good and evil, falsehood and truth." Today have we not also lost the capacity to differentiate between reality and virtuality, between life and death? For, are we not so lost that out of the fear of death for us or others, we are precipitating our own death and that of everyone else? Those of you enforcing or participating in the enforcement of a cruel dehumanization process on populations, are you not possibly for the sake of some all too ephemeral power or financial gain or security forgetting the most essential, that which makes you a human being? Whoever you are, remember that you can lie to everyone you can lie to your spouse, to your parents, to your children; you can lie to the entire world, you can never lie to yourself, you can never lie to life. Lying to life has consequences.

Every Official UK Covid Death To Be Investigated

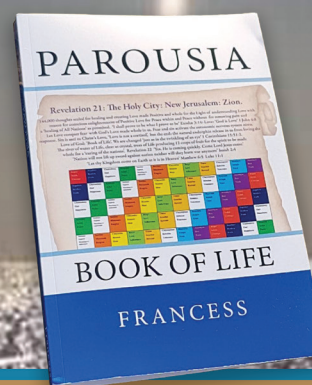
