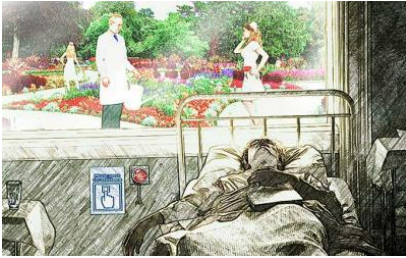


And You Still Think They Work For You?

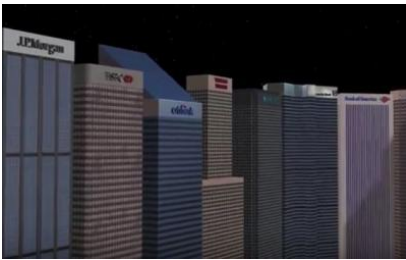
