**Resolved** that the Minutes of the Open Space Committee Meeting held on Monday 12<sup>th</sup> August 2013 that had been duly circulated be taken as read and approved as being correct record and signed as such by the Chairman

**OS5.4 To resolve to take note of RoSPA's recommendations relating to the "Goal Posts" in the Children's Play Area and to agree on the resulting action.**

The meeting noted the recommendations contained within the report and recognised that it would be more beneficial to nearby neighbours if the "Goal Posts" were moved further around so that they were located between the trees parallel to the West Boundary Fence. It was also noted that there was a fear that footballs would possibly hit the roof of the Coronation Hall and if so latent action like extending the height of the fence would have to be implemented. Closing the existing entrance and

moving it further in a clockwise direction was agreed not to be a practical solution as footballs might then strike parked cars in the car park

**Resolved** that the current location of the “Goal Posts” be moved further around in a clockwise direction so that they might be sited parallel with the west boundary fence.

**Resolved** that the site line be away from the fence sufficiently so that the (a) grass could be cut easily and (b) the fence could not be used as an aid for climbing the posts.

**Resolved** that the tops of each pole be chamfered alternatively at 45 Degrees
