

**NOTICE OF MAKING OF AN ORDER**  
**HIGHWAYS ACT 1980**  
**NORTH SOMERSET DISTRICT COUNCIL**  
**(PARTS OF FOOTPATH AX 6/12, PART OF FOOTPATH AX 6/15**  
**AND FOOTPATH AX 6/14 SOUTH HILL FARM BLEADON)**  
**PUBLIC PATH DIVERSION ORDER NO. 5 2013**

The above Order, made on 12 December 2013, under section 119 of the Highways Act 1980, will divert parts of Footpath AX 6/12, part of Footpath AX 6/15 and Footpath AX 6/14 in the Parish of Bleadon which crosses land at South Hill Farm within the District of North Somerset as described below:

That part of Public Footpath AX 6/15 from point A (Grid Ref: ST 34108 56506), running in an east north easterly direction for a distance of approximately 539 metres to point B (Grid Ref: ST 34607 56703) as shown as a bold continuous line on Map No PPO 159 to a new path to be known as Footpath AX 6/15 running from point C (Grid Ref: ST 34156 56552) and proceeds in an easterly direction for approximately 379 metres to a kissing gate at point C1 (Grid Ref: ST 34516 56628), then continues in a north easterly direction for a distance of approximately 118 metres to point B (Grid Ref: ST 34607 56703) as shown as a bold broken line on Map No PPO 159 a total distance of approximately 497 metres.

That part of Public Footpath AX 6/12 from point D (Grid Ref: ST 34317 56660) running in an east south easterly direction for a distance of approximately 264 metres to point E (Grid Ref: ST 34577 56626), then proceeds in a south south easterly direction for a distance of approximately 89 metres to point F (Grid Ref: ST 34626 56548), then an easterly direction for a distance of approximately 53 metres to point G (Grid Ref: ST 34680 56555) and continues in an easterly direction for a distance of approximately 176 metres to point H (Grid Ref: ST 34854 56577) as shown as a bold continuous line on Map No PPO 159: to a new path to be known as Footpath AX 6/12 running from point L (Grid Ref: ST 34292 56645) and proceeds in an easterly direction for a distance of approximately 264 metres to a pedestrian gate at point E (Grid Ref: ST 34577 56626) then continues in an east north easterly direction for a distance of approximately 180 metres to a kissing gate at point M (Grid Ref: ST 34741 56679) then in a south easterly direction for a distance of approximately 156 metres to a kissing gate at point H (Grid Ref: ST 34854 56577) as shown as a bold broken line on Map No PPO 159 a total distance of approximately of 600 metres.

Footpath AX 6/14 from point K (Grid Ref: ST 34604 56379) running in a northerly direction for a distance of approximately 20 metres, then in an east north easterly direction for a distance of approximately 96 metres to point J (Grid Ref: ST 34699 56419), then continues in a northerly direction for a distance of approximately 137 metres to point G (Grid Ref: ST 34680 56555) as shown as a bold continuous line on Map No PPO 159: to a new path to be known as Footpath AX 6/14 running from point K (Grid Ref: ST 34604 56379) and proceeds in an east north easterly direction for approximately 104 metres to point J (Grid Ref: ST 34699 56419) then continues in an easterly direction for approximately 154 metres to point N (Grid Ref: ST 34851 56433) then proceeds in a northerly direction for a distance of approximately 144 metres to the farm access track at point H (Grid Ref: ST 34854 56577) as shown as a bold broken line on Map No PPO 159 a total distance of approximately 402 metres.

All of the new routes above will be a width of 2 metres.

Any representations about or objections to the Order may be sent in writing to the Director of Development and Environment, Natural Environment Team, Streets and Open Spaces, Town Hall, Walliscote Grove Road, Weston-super-Mare, BS23 1UJ not later than **23 January 2014** (quoting reference **EB/PPO 159**). Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, North Somerset District Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment for confirmation, any representations and objections which have not been withdrawn will be sent with the Order.

**PUBLIC PATH DIVERSION ORDER No. 5 2013**

This Order is made by North Somerset District Council (“the authority”) under Section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interests of the owners of the land crossed by the footpaths described in paragraph 1 of the Order it is expedient that the lines of these paths should be diverted.

The applicants have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the paths into a fit condition for use by the public.

**BY THIS ORDER:**

1. The public rights of way over the land situated at South Hill Farm, Bleadon and shown by bold continuous lines on the Map No. PPO 159 contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which North Somerset District Council certify that work has been carried out to bring the site of the new paths mentioned in Part 2 of the Schedule into a fit condition for use by the public.
2. Notwithstanding this order Openreach BT and Western Power Distribution shall have the following rights over the land referred to in paragraph 1 namely: they shall for the purpose of carrying out their undertaking continue to have the same rights in respect of their apparatus as they had immediately before the date on which the footpaths are diverted.
3. There shall at the end of 28 days from the date of confirmation of this Order be public footpaths over the land situate at South Hill Farm Bleadon described in Part 2 of the Schedule and shown by bold broken lines on the Map No. PPO 159 attached to this Order.
4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

## **SCHEDULE**

### **PART 1**

#### **DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS**

That part of Public Footpath AX 6/15 in the Parish of Bleadon from point A (Grid Ref: ST 34108 56506), running in an east north easterly direction for a distance of approximately 539 metres to point B (Grid Ref: ST 34607 56703) as shown as a bold continuous line on Map No PPO 159.

That part of Public Footpath AX 6/12 in the Parish of Bleadon from point D (Grid Ref: ST 34317 56660) running in an east south easterly direction for a distance of approximately 264 metres to point E (Grid Ref: ST 34577 56626), then south south easterly direction for a distance of approximately 89 metres to point F (Grid Ref: ST 34626 56548), then an easterly direction for a distance of approximately 53 metres to point G (Grid Ref: ST 34680 56555) then continues in an easterly direction for a distance of approximately 176 metres to point H (Grid Ref: ST 34854 56577) as shown as a bold continuous line on Map No PPO 159.

Footpath AX 6/14 in the Parish of Bleadon from point K (Grid Ref: ST 34604 56379) running in a northerly direction for a distance of approximately 20 metres, then in an east north easterly direction for a distance of approximately 96 metres to point J (Grid Ref: ST 34699 56419), then continues in a northerly direction for a distance of approximately 137 metres to point G (Grid Ref: ST 34680 56555) as shown as a bold continuous line on Map No PPO 159.

### **PART 2**

#### **DESCRIPTION OF SITE OF NEW PATH OR WAY**

A public footpath to be known as Footpath AX 6/15 in the Parish of Bleadon will commence from point C (Grid Ref: ST 34156 56552), proceeds in an easterly direction for approximately 379 metres to a kissing gate at point C1 (Grid Ref: ST 34516 56628), then continues in a north easterly direction for a distance of approximately 118 metres to point B (Grid Ref: ST 34607 56703) as shown as a bold broken line on Map No PPO 159 a total distance of approximately 497 metres. The new footpath will be a width of 2 metres.

A public footpath to be known as Footpath AX 6/12 in the Parish of Bleadon will commence from point L (Grid Ref: ST 34292 56645) proceeds in an easterly direction for a distance of approximately 264 metres to a pedestrian gate at point E (Grid Ref: ST 34577 56626) then continues in an east north easterly direction for a distance of approximately 180 metres to a kissing gate at point M (Grid Ref: ST 34741 56679) then in a south easterly direction for a distance of approximately 156 metres to a kissing gate at point H (Grid Ref: ST 34854 56577) as shown as a bold broken line on Map No PPO 159 a total distance of approximately of 600 metres. The new footpath will be a width of 2 metres.

A public footpath to be known as Footpath AX 6/14 in the Parish of Bleadon will commence from point K (Grid Ref: ST 34604 56379) proceeds in an east north easterly direction for approximately 104 metres to point J (Grid Ref: ST 36499 56419) then continues in an easterly direction for approximately 154 metres to point N (Grid Ref: ST 34851 56433) then proceeds in a northerly direction for a distance of approximately 144 metres to the farm access track at point H (Grid Ref: ST 34854 56577) as shown as a bold broken line on Map No PPO 159 a total distance of approximately 402 metres. The new route will be a width of 2 metres.

The gates specified above are to be provided to comply with BS 5709.2006 and should be considered for removal in the event that they are no longer required to prevent the ingress or egress of animals or if the land is no longer used for agricultural purposes including forestry and the keeping of horses.

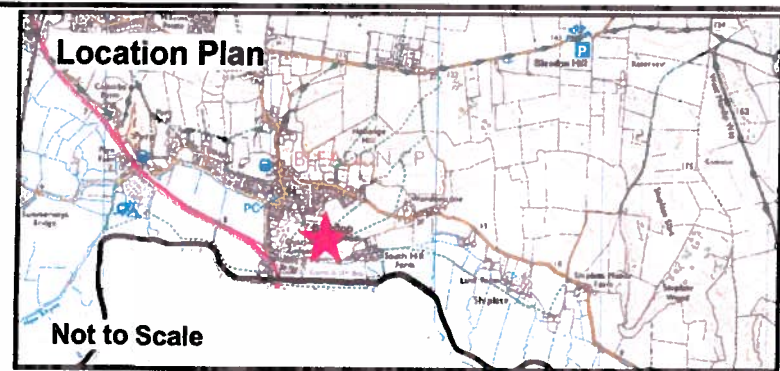
