Exeter Chiefs Rugby Players Denounce Lockdown

Several high-profile Exeter Chiefs rugby players released anti-lockdown social media posts over the weekend of 20-21st December 2020, creating a public relations crisis for the club.

Both Alec Hepburn and Harry Williams shared posts reprimanding the government following its South East Tier 4 Lockdown announcement.



One of Exeter Chief's props, Harry Williams, posted on Instagram that 'we are being lied to', and to 'open your eyes'

England and Exeter Chiefs prop, Alec Hepburn, also posted on Instagram, criticising the UK government over the imminent return to Tier 4 lockdown, claiming that the government were using 'force and coercion to manipulate the public into compliance'.

Although Alec Hepburn's post divided opinions, plenty lent their support. Fellow England and Exeter Chiefs' player Jack Nowell was among several players supporting the sentiment, taking to Twitter to post: "Sacrifice your summer to save Christmas" with a Pinocchio emoji.

3,150 Reported With Adverse Reactions To Pfizer's Covid-19 Vaccine

Thousands of people have been unable to work or perform daily activities, or required care from a health care professional, after getting the new covid-19 vaccine, according to data from the Advisory Committee on Immunisation Practices (ACIP) which advises the Centers for Disease Control and Prevention (CDC).

As of Dec.18th 2020, 3,150 people had reported what the agency terms "health impact events" after getting vaccinated. Those who are experiencing these 'events' are 'unable to perform normal daily activities, unable to work, or required care from a doctor or health care professional.'

The incidents were reported through V-safe, a smartphone application. The tool uses text messages and web surveys to provide personalized health check-ins, and allows users to quickly tell the ACIP if they're experiencing side effects.

The CDC and Pfizer, which produces the vaccine with BioNTech, didn't immediately respond to a request for comments.

The information was presented on Dec. 19th by Dr. Thomas Clark, a

CDC epidemiologist, to the Advisory Committee on Immunization Practices, an independent panel that provides recommendations to the agency. They said that 272,001 doses of the vaccine were administered as of Dec.19th.

ACIP identified six case reports of anaphylaxis, or **severe allergic reaction**, that occurred following injection with the new vaccine, Clark reported. Other case reports were reviewed and determined not to be of anaphylaxis.

In an update on Dec.18th, the CDC stressed that anyone who has ever had a severe allergic reaction to any ingredient in a covid-19 vaccine **should not get that vaccine**. People with severe allergic reactions to other vaccines should consult their doctor about getting the new vaccine, while those with a history of anaphylaxis not related to vaccines "may still get vaccinated."

Anyone who experiences anaphylaxis after getting the first vaccine should not get the second shot, the CDC also said. Covid-19 vaccines are meant to be given across two



doses, spaced about three weeks apart.

At least five health care workers in Alaska experienced adverse reactions after getting the Pfizer vaccine, the Anchorage Daily News reported. One worker at the Bartlett Regional Hospital required treatment at the hospital for at least two nights. An Illinois hospital also halted

vaccinations after four workers suffered adverse reactions.

Dr. Peter Marks, director of the Food and Drug Administration's Center for Biologics Evaluation and Research, told reporters in a call on Dec.17th that the agency is working with the CDC and colleagues in the UK on probing the allergic reactions.

"We'll be looking at all of the data we can from each of these reactions to sort out exactly what happened. And we'll also be looking to try to understand which components of the vaccine might be helping to produce them," he said.

Noting that he was speculating, Marks said it's known that polyethylene glycol - a component present in both the Pfizer vaccine and one from Moderna that regulators approved earlier in the day - can be associated, uncommonly, with allergic reactions.

"So that could be a culprit here. And that's why we'll be watching very closely," he said. "But we just don't know at this point."

Both vaccines have "systemic side effects," which are "generally mild," Marks said. According to the FDA website, the most commonly reported side effects include tiredness,

headaches, muscle pain, and chills. The agency said they go away after several days.

One volunteer in Pfizer's latestage clinical trial experienced an allergic reaction. Two people in Moderna's phase three clinical trial experienced anaphylactic reactions, the company said during a meeting on Dec.17th. But despite the very obvious risks, the data showed the benefits outweigh the risk, FDA officials said, as they granted emergency use authorisation to the vaccines about seven days apart.

People who get a covid-19 vaccine should be monitored for at least 15 minutes after getting vaccinated, according to the CDC.

If someone experiences a severe allergic reaction to getting a covid-19 vaccine, vaccination providers are supposed to provide rapid care and call for emergency medical services. The person should continue to be monitored in a medical facility for at least several hours.

Faith To Keep Her Business Open

'If you have faith the size of a mustard seed, and you believe, you can move mountains.'

When Chris Stala took on a failing Christian bookshop in Nottingham, she never realised how personal the mantra of her new establishment would become.

Twenty-five years on, and her unwavering faith, plus the committed support of friends, has empowered the 69 year old mother of four to make a stand against the government's lockdown orders. To boldly defy commands from police and council to shut up shop under the Coronavirus Act 2020. To shrug off seeing her good name and motivations smeared in the local press. To reject demands to pay over £17,000 in fines, and finally be forced from her business with the threat of a prison sentence.

For daring to question her government and the motives behind its pandemic/panic attack on the nation's sanity and stability. For her conviction that there is a deeper spiritual dimension to current world events. For her calling to push back against what she sees as an oppressive and tyrannical power grab from the 'elite' oligarch classes, disguised behind a virus smokescreen.

During lockdown one on March 15th, Chris begrudgingly closed the doors of her popular high street bookshop and tea-room 'The Mustard Seed' in the village of Gedling, Nottinghamshire. Although already suspicious of the government narrative, she followed the lead of the local churches and wider community.

An ardent researcher on matters of spirituality and alternative health, she became increasingly suspicious of the developing news agenda. Making social media connections with likeminded people, she planned a regular meet-up at the bookshop once the doors reopened.

On June 15th customers were permitted to return. For many it couldn't come soon enough. Some suffered with mental health challenges, or had little social interaction away from the tea-room. Other local businesses hadn't weathered the first storm...staff at nearby hairdressers 'Roots' would never smarten another head in there. Tales of financial, mental and physical problems from the lockdown were already being heard on the Gedling grapevine.

A collective of 15-20 regulars found camaraderie through local activism and met weekly at the bookstore, under the name 'Action for Freedom'. Committed to exploring alternative views largely kept hidden from the people of Nottingham.

Chris reluctantly adapted to the brave new covid world of track-and-trace QR scanner codes,

limiting customer numbers to enable social distancing and so on. While refusing it herself, she offered PPE equipment to her employees. She felt that something was hurting a small section of society, but recognised the statistical manipulation and ongoing misdiagnosis surrounding covid cases. Takings had plummeted, but her unexpected calling to save this failing community hub had nothing to do with money.

Around midday several police and a senior council official showed up. Chris found their demeanour intimidating and patronising and gave them short-shrift. The council officer presented her with a fine of £1000 for breaching lockdown orders, and they left.

While showering the following morning the thought crossed her mind: 'I might go to prison today.' A concern that she has since taken seriously, the packed bag she has prepared just in case is testament.

anti-lockdown event in the town centre. Including a determined 84-year-old lady who struggled the six mile distance to show her support.

Police were already waiting in Gedling and shadowing the protest march of some 20 people. At the shop Chris was serving a relatively busy tearoom when she was called to the front door. Again, the police were denied a conversation and permission to enter the premises.

Distracted by her duties, Chris paid little attention to the group of supporters and interested

serve three envelopes. They remain unopened, yet subsequent press reports suggest they contained fines totalling a further £16,000.

Local activists used the shop on Tuesday to create flyers and posters to distribute. The windows were plastered with alternative information, including a scathing report on government lockdown decisions from the British Medical Journal (BMJ).

The Mustard Seed was closed as normal on Wednesday. Amusingly, the leader of the council recognised this in a letter to Chris, thanking her for seeing sense. You can only imagine his face after learning she had reopened the next day as usual.

This triggered the authorities to change tack and escalate the situation. The police were granted a three month closure order under anti-social behaviour order (ASBO) legislation from the city's Magistrates Court. The suggestion being Chris' refusal to close would create a similar scene that ended in the Saturday arrests. Despite this having nothing to do with her or her staff.

Late on Thursday afternoon a police officer was again refused entry and firmly told he was trespassing. Friday the 20th arrived and the authorities switched up a gear. They tried to confront Chris at her home, only leaving after knocking a neighbour's house to pass on the message they wanted to talk. Shortly after arriving home a few hours later there was a second loud knock on the door. It was the police returning with the closure order notice.

Next she discovered that the notice had been plastered across her shop windows, and that her tenant - who was living above - had been questioned.

As it stands Chris is not allowed back into her shop until February. But the order suggests that the police and council can come and go as they please.

Now facing a potential prison sentence under the ASBO legislation, she and her supporters have prepared their appeal and have taken time to pause, reflect and build their best legal defence.

Chris said: "I don't want to be seen as some renegade. I want to do this properly, to make a stand for others who are suffering because of these evil directives. When I open again, I am staying open for all of the people who need me.

This is a true walk of faith and we will take one step at a time. This is a lot bigger than what happens to me or my shop, it's part of a wider spiritual battle that we must win. If people like me don't stand up against this tyranny, who will?"



crash the entire economy like this, it has and will hurt so many more people," she said. "Since when has our government cared so much about our health to do something so drastic?"

The second lockdown started on November 5th. It was time to make a stand. She would remain open - business as usual, inspired by advice from knowledgeable people in Common Law and the support of her friends, regulars and locals.

This small act of defiance slipped under the radar for several days. Until she received an unwelcome visit from Nottinghamshire Police and Gedling But Chris is determined to see this through. There is nothing that her government can do to her that could compare with the pain of losing two beloved children to diseases no young child should suffer from. Her charming and fun-loving demeanour masks the tragedies of her own personal story, the trials that have made her so strong.

Saturday the 14th started quietly. Regulars were deep in conversation. Chris was making soup. There was talk of a small group of freedomfighters marching in solidarity towards The Mustard Seed from an locals gathered outside her shop. Unbeknownst to her, an 'intoxicated man' began goading the police. He was soon strong-armed into a police Transit van. A second man was arrested and also fined £200 for breaking lockdown demands. Neither man entered the shop and neither has been seen since.

Disappointed to hear some suggest her stand was financially motivated, despite having never taken a wage in 25 years, on Monday Chris opened her doors but decided to stop taking money. The council and police escort returned in the afternoon to

Cuadrilla Give Up Fracking Licences In Lancs

Fracking opponents have called for a countdown to restoration at Cuadrilla's Preston New Road shale gas site near Blackpool after the company gave up consents to key operations.

The Environment Agency (EA) announced on the 9th of December that Cuadrilla had surrendered part of its environmental permit for the Preston New Road site.

The surrender notice showed that the company had given up consent to: •Inject hydraulic fracturing fluid •Incinerate gases

•Manage drilling waste

Claire Stephenson, of Frack Free Lancashire, said: "It is a welcome early Christmas gift to residents, to learn that Cuadrilla are now beginning their much-anticipated leave of Preston New Road.

We encourage Cuadrilla to issue communication on such matters to the Community Liaison Group so that information can be passed to residents and parish councils in a timely manner.

We would also urge Cuadrilla to present a timescale for site restoration of Preston New Road, so that long-suffering residents where fracking was forced upon their community, are able to feel closure on a very stressful and imposing chapter of their lives.

Fracking is an unpleasant and dirty relic that should now be confined to the past where it belongs. We are now looking forward to a cleaner, greener energy revolution."

Preston New Road Action Group, said: "It is good to receive some positive news in this very difficult year. No more drilling, no more fracking and no more flaring this will be such a relief to those residents who live close to the Preston New Road Site.

However, actions speak louder than words so I think that we will only believe that it is really true when the flare stacks are removed and the site is restored back to its former green field state."

Cuadrilla fracked for shale gas at Preston New Road in 2018 and 2019 – the UK's first high volume hydraulic fractures since 2011.

Both operations caused local earthquakes, including the UK's largest fracking-induced seismic activity, measuring 2.9ML, in August 2019.

After the imposition of an England-wide moratorium on fracking a year ago, Cuadrilla scaled back activity at Preston New Road. Last month, the company described itself as "largely non-operational".

Planning permission for drilling and fracking at the site has expired and earlier this month, Cuadrilla surrendered a permit allowing storage and handling of crude oil, gas condensate and mixtures of crude oil and water at Preston New Road.

In today's surrender document,

the EA said it was satisfied that the company could give up the parts of a separate permit covering flaring of waste gas, management of drilling waste and injection of hydraulic fracturing fluid.

On fracking fluid, the EA said: "As there will be no further injection of fluid, this activity is no longer required."

On incineration of waste gases, the EA said: "This activity was taking place during the flow testing phase of the site operations. As this has now concluded, the flares are no longer needed on site and no gas flaring will take place."

On the management of extractive waste, the EA said: "As the drilling

of the boreholes was completed some time ago and no further drilling will take place, this part of the activity is no longer needed."

The storage of waste containing oil-based drilling muds was also not needed, the EA said. But it added that part of the permit would remain in force to manage any extractive waste generated when the boreholes were decommissioned.

A section of the permit controlling the discharge of surface water collected on-site would also remain.

The EA added: "We are satisfied that the necessary measures have been taken to avoid a pollution risk resulting from the operation of the regulated facility.

"We are satisfied that the necessary measures have been taken to return the site of the regulated facility to a satisfactory state, having regard to the state of the site before the facility was put into operation."

DrillOrDrop asked Cuadrilla why it had surrendered part of its environmental permit now and what timeline there was for site decommissioning. We also asked whether the company still intended to apply to extend planning permission for drilling and fracking at Preston New Road.

There was no company response at the time of going to print.

'Publishing Propaganda': Piers Corbyn Challenges Guardian Editor To Debate

6 Why are we doing your job?', asked a placard outside a national newspaper headquarters at King's Cross, London. 'Shame on you', it continued, 'Guardian now bankrolled by corrupt, drug-pusher billionaires'.

The placard-bearer, an ex-reader of the Guardian, had come with around twenty others to deliver a letter challenging the editor, Kath Viner, to a debate on covid-19 dogma and censorship.

The gathering, on 8th December, was led by tireless campaigner Piers Corbyn. First to speak was Alex Heaton, who previously appeared at a demonstration outside the government's Behavioural Insights Team. Heaton presented a clear case for the prosecution: the Guardian was guilty of stifling freedom of speech on the authoritarian covid regime.

Then Piers Corbyn took the

megaphone. He asked: would you fly on a new aircraft without an airworthiness certificate, and if the maker and airline had no liability for a crash? That's exactly what is being expected of people with inadequately-tested coronavirus vaccines. Corbyn cited the concern of Doctor Mike Yeadon, former scientific advisor at Pfizer, about the safety risk to trial volunteers, and potential risk to fertility. Now the whole population is being press-ganged into a mass experiment.

The man with the initials PC is as politically incorrect as you can find. A seasoned sceptic of global warming and siren against the establishment, Corbyn drew attention to the underlying agenda of the vaccinators. His bête-noire is Bill Gates, the computer salesman who uses his

riches to dictate world health policy, centred around mass vaccination programmes. Although Gates claims that the remedy for overpopulation is better health, a troubling theme of eugenics is discernible.

According to Corbyn, the mRNA shot is not really a vaccine but an instrument of genetic modification and control, potentially making women infertile. Language, as shown by George Orwell in Nineteen Eighty-Four, is being distorted for misanthropic ends. 'It is evil, satanic', Corbyn concluded.

A letter to Kath Viner was then delivered, via a reluctant security guard, titled 'Formal notice of liability as an accomplice in genocide'. Corbyn and Heaton pulled no punches in their missive:

"As a journalist working for an organisation that is directly funded by the Bill and Melinda Gates foundation, your integrity has been completely compromised... it has been your policy to publish government propaganda on a regular basis throughout this crisis...your complicity with their agenda can only be seen as a direct attempt to deceive your readers and coerce them towards harmful outcomes to their own health."

Corbyn and Heaton warned Viner that her newspaper's unqualified promotion of mass vaccination was veering towards violation of the Nuremberg Code. They demanded:

"Given the imminent threat to the lives of many millions of people nationwide, we are notifying you that we expect you to reply to us within forty-eight hours with written confirmation of the cessation of all advice to your readers to take the covid-19 vaccinations. Failure to comply with

this request will place you on notice that you may be deemed to be an accomplice in what may accurately be described as genocide."

The letter had no effect on Guardian editorial, with numerous opinion pieces casting anyone with concerns about covid vaccines as an 'anti-vaxxer'.

Two days later, Toby Young's Free Speech Union failed in its application for a judicial review of the media regulator Ofcom for censoring dissent on covid-19. The High Court ruled that Ofcom's guidance had been misrepresented, and that it was preventing harmful information about the coronavirus rather than criticism of government policy.

It's a slippery slope, though—the Guardian, ensconced in the official covid narrative, would not need much encouragement from Ofcom.

Is There Any Point In Protesting?

Taking a short break over the festive period this die hard group plan to serve more notices of liability this year to people in positions of authority in local councils, hospitals and GP practices in respect of contraventions of the Human Rights Act 1998, Article 8 in particular, reminding them of their Duty of Care (and hippocratic oath).

This huge undertaking requires great skills in logistics and planning. Meeting up to three times a week, this cohesive group shares ideas with real democracy where the majority vote decides strategies.

Constantly changing goalposts mean, in order to remain on the ball, meetings sometimes have to be arranged with only hours to spare.

Each individual has their own private demands with work and a family life. All have been affected in one way or another by the draconian overreaching lockdown rules and regulations and have by and large sensibly ignored all the contradictory insane policies. There are a few who

have been denied or experienced delayed medical treatments. Two are small business owners who are at risk of losing their livelihoods. One is a mother of two vaccine injured children who does a great deal of research for the group.

There is an ex-nurse who was a whistle blower, another a retired social worker who has much experience in challenging pharmaceutical companies. One enthusiastic member works long shifts in a car manufacturing plant, there is a working single mother worried for her children, another a local bus driver with a young family.

The experience of one husband and father who has a background in logistics is of immense use. Bringing further knowledge and passion to this active and anonymous group is a family man who has stood locally for one of the political parties and sits on many boards.

They have attended rallies and marches up and down the country and have helped organise some big events. Some are distributors of The Light.

Having designed, printed and distributed their own leaflets covering everything from PCR tests to vaccinations, the group is committed to informing local people and waking them up to the tyranny behind the covid smokescreen.

They understand the great need for a reset and that people have choices. They believe community activism with local people supporting each other is the only way we can overcome this tyranny and build a better future for ourselves and others.

March and wave placards, chant, shout, blow whistles. More of this is needed in order to facilitate networking but the real work is really needed at grass roots level, this is when the activists get active. Hard work, dedication, passion and drive with a meeting of minds, a pooling of skills and qualities, with each playing to their own strength, is essential in order to achieve any results.

There is no room for ego. This is one of the reasons why this group remains anonymous. A name, a banner, or a logo means there is something to hang a hook on. Their focus is not on identity or recognition; their focus is the activism, the results needed and achieving those results. Remaining anonymous gives them more scope—clandestine secrecy achieves more.

They know who they are, their identities need not be known because that is not what is important. They want no accolades, they want results. They want communities to work together and for each other to safeguard and protect everyone regardless.

This anonymous activist group calls on others to meet and get active in your local communities to effect change for the better for everyone. You only have yourselves and cannot rely on others. You can only trust yourselves to do what is needed to be done. Foot soldiers unite for freedom and protect the vulnerable ones in your community.

However, it was not all good news. Fishermen, especially in Scotland, feel as though their industry has been sacrificed for the free trade deal - EU fishing trawlers will only have to give up 25% of what they catch.

As for services and the allimportant financial service sector, there are set to be further talks, meaning nothing has been decided and the EU may decide to play hardball in the future.

The European Research Group (ERG) of the Conservative Party all supported the deal and heaped praise on Johnson's perceived triumph.

Nigel Farage announced the battle is over, but then again he did 4.5 years ago as well, and so the people's vigilance is ever needed.

According to Business Insider, 90% of the American mainstream media is owned by only 6 corporations. Or maybe the flat-out lies about Blair's 'dodgy dossier' and Bush's 'weapons of mass destruction' that could be 'launched in 45 minutes' resulting in the utterly horrific destruction of Iraq.

Furthermore, some news anchors, such as Brian Williams, have been

forced to admit to making up false stories—again in his case, about the disastrous Iraq war.

There are plenty more lies and dodgy dealings that mainstream media (MSM) has been caught up in. Most recently, governments have had to backtrack on the misinformation they've disseminated about covid-19. It seems their statistics and projections are often wildly incorrect, and many thousands of doctors disagree with the advice they've been giving to the public—see the Great Barrington declaration.


Clearly, the MSM is bad enough at simply reporting the facts (they often don't), so hosting balanced debates is pretty much out of the question. Nothing else is offered; it's a very narrow Overton window.

Today there's a war on independent investigative journalism. After the U.S. elections, where Donald Trump won the Presidency despite the MSM's best attempts to discredit him, the establishment media erroneously blamed Russia for his victory (and of course, they were proven—yet again—to be wrong).

Nonetheless, the MSM has furiously declared war on what they call 'fake news sites'—i.e. alternative, independent media that actually tells the truth. Facebook has even vowed to shut 'fake news' down on their social media platform. We truly are in the age of mass digital censorship and book-burning, but luckily

there is still one medium we can use to share alternative and opposing ideas to that which the monolithic media machine and the world's governments want you to believe, automatically, without question.

David Kurten - A New Hope?

In 2020 politicians of all sides blatantly lied to and let down the British public. Not only has the regime response closed businesses, created loneliness and confusion, caused financial hardship and a loss of liberty, but the reactions have been based on a sham and agenda in the first place.

Throughout this year there has been one man involved in the political field who has consistently spoken out and been a part of the demonstrations and freedom rallies. That man is David Kurten, a member of the London Assembly—and his plan is to run for London Mayor in 2021.

The police should not be there to censor thought and the expression of public protest. You should have the right to express your thoughts & beliefs. People have a right to protest and it should not be biased-we need to stop this and we need to get people's freedoms back". Passionate David continues "We have so many orders from Westminster with police used as state enforcers, while businesses close - I would like to be able to say I'm against such actions and steer the police to not enforce such things against our local communities".

Another priority is transport in London and not just the state of the buses and underground. "There are so many roadblocks in London, creating 15 minute neighbourhoods (a new term which I only heard recently). It ties into Agenda 21/2030-a desire to make everything within 15 mins of each neighbourhood and use surveillance control to box off neighbourhoods while most things are done digitally. The polls show Sadiq Khan has over 50% of the vote but in the age of Donald Trump and Brexit, one should not always trust the pollsters. Khan and his excuses, looking for alternatives." David has been out on the London streets regularly, hearing real citizens' feedback. He is hoping to work on their genuine concerns rather than following an agenda of political persuasion.

Online you can find many clips of David challenging current London Mayor Sadiq Khan in the London Assembly. It is highly recommended, because you can clearly view Khan squirming and refusing to answer questions on issues that concern the public. I had noticed over recent months that the press has covered a few grooming gangs being busted across

The mainstream media often labels those who question their narrative as conspiracy theorists but David is a well-educated former teacher. "I've got a science background and I'm making a stand because I call it as it is. Too many politicians are career politicians with no maths and science background and do not question the data, graphs and modelling. I can clearly see the lies they are spinning. Sars-Cov-2 is real, but it is not anywhere near the issue being made out. The average age of people dying is 83! Remember there are many coronaviruses but we do not need to treat them like the bubonic plague We could carry on as normal; use hydroxychloroquine, zinc, ivermectin, vitamin D and other protocols that work

of it, or those that have been deceived by mainstream media propaganda. Goebbels would be proud of the lies coming out of government, and it has affected people who succumb to peer pressure. taking away our freedoms. Before this came along, I had been talking about Cultural Marxism—political correctness undermining nation, faith, family and freedom. Trying to fit us all into boxes and fighting each other with grievance identity; creating 'intersectional victim groups', installing the transgender agenda in schools by teaching children far too early about these niche issues. I am fighting this battle and the actual taking away of freedoms by starting the Heritage Party.

If we do not understand how these people think, we end up in hot water. Brexit is a chance to help small businesses and daily life, but we may next year be facing a perfect storm depending on the type of deal or otherwise. For local businesses 88% trade only domestically so we need rules tailored for our own country.

I predict Boris Johnson may well be gone in 2021 and I hope that the mayoral elections will take place although this may be further delayed to suit their agenda. Let's keep up the momentum and keep trying for change. A lot is hinging on what happens in America, and we haven't seen the end of that yet."

David has experience of campaigning, and although he has no major financial backers he hopes to get the message out via hard work and genuine people engaging. By gaining public support, and meeting voters out and about in London, engaging with citizen journalists and YouTube live streamers, he feels that a true groundswell of support is possible.

England, but that there never seems to be news like that from London, where I would presume that there was indeed an issue of that sort of crime. "I did ask Sadiq Khan about this at Mayor's question time. Without answering the question he said 'are you asking me because of my faith, my ethnicity?" And I told him I was asking because he is the police and crime commissioner. Then the chair of the assembly got involved and told me I should not be asking this sort of question".

For me this is a clear illustration of the kind of cover-up and obfuscation explicit in modern UK politics, and is an eye opener for everyday people who are concerned about child sexual abuse. Then you see a simple magic trick performed for the first time it is natural to be impressed. But when the trick has been explained, and you understand what has gone on and why, then vou wonder why on earth vou fell for it.

The coronavirus hoax is like that. The pandemic myth is a carefully constructed deception which has been planned for years and is now being executed with military precision.

Even, or rather especially, the chaos and the apparent incompetence are all part of the trick.

Remember Tommy Cooper? He never seemed to know what he was doing. Everything always seemed on the brink of disaster. But, of course, everything he did was carefully prepared. There was a reason for this wickedness, of course. Everything that happened in 2020 was carefully designed to create enough fear to turn people into compliant victims; ready to accept any inconvenience that would protect them. But the 'plague' was as fake as anything dreamt up by Hollywood.

Have you ever seen the film 'Wag the Dog'? If not, I commend it to vou. It describes how an American spin doctor creates a fake war with Albania in order to distract the voters from a presidential indiscretion.

And it's a perfect representation of what has happened to us in 2020. We have been tricked and manipulated by politicians and the media.

Right from the start, the evidence convinced me that Ferguson's gloom laden predictions were absurdly pessimistic. And Ferguson's unduly inaccurate history as a 'forecaster' even suggested to me that he might have been chosen for his ability to get things badly wrong

Then in March 2020, the UK government's specialist advisers told the politicians that the coronavirus could be downgraded since it was no more of a threat than the ordinary flu.

That should have been the end of the scam. Not a few would-be Masters of the New Universe were doubtless dismayed by the experts' decision.

But the Government shrugged its collective shoulders, ignored the inconvenient advice and published a 358-page Emergency Bill giving itself extraordinary powers to combat a virus known to be no worse than the flu. Government Spend Millions On Vaccine PR

s the majority of Britain enters A yet another lockdown, the pressure of rolling out a vaccine continues in an ever more pressing fashion which leaves those who have concerns about the safety of vaccinations looking for answers.

When asked on the day that the first vaccinations began to be rolled out Boris Johnson said in regards to those who felt apprehensive about the vaccinations "I would just say to those who are scared, don't be.' he went on to say "People are going to be taking it in the next few days and weeks and there's nothing to be nervous about. In July, Boris Johnson visited a GP surgery and branded those who do not get vaccinations as being "nuts'

- this is after the Government had planned to offer everyone over 50 a free vaccination and all those under 11, which would've been the largest vaccination program ever to be carried out in the United Kingdom. Boris Johnson has also been questioned on his spending of taxpayers' money as it was revealed that the Government had spent 130 million on PR companies this year alone.

Boris Johnson himself has claimed that the £670,000 contract was spent on PR companies to "fight antivaxxers" and to help sway the public into taking part in vaccination trials. This reported contract was put in place in the past seven months which

would mean it would've taken place in April/May, which would make it around the same time that Boris Johnson also pledged £4,600,000 for a coronavirus vaccine, and it would also make it around the same time Dr Richard Hatchett, who works for the Coalition for Epidemic Preparedness Innovations, said governments need to adopt an 'aggressive' response to tackle the virus as he revealed it could take between 12-18 months to develop a vaccine and cost £1.5bn.

The timeframe for most vaccinations can take up to 10 years before it's fully developed, the Wellcome Trust claims that the initial delivery and research stage is around two-five years and can

cost up to £500 million.

Matt Hancock has also chimed in on the matter of 'anti-vaxxers' -"Those who promulgate lies about vaccines that are safe and have been approved, they are threatening lives," he told MPs whilst talking about people's fears over vaccinations.


The vaccines are created using computer modelling, and a consensus is drawn as to what the sequence should be. This could also be called

Covid-19 And Cargo Cult Science

Following Japan's attack on Pearl Harbour in 1941, the US (and allies) fought the Japanese across the Pacific Rim. Key to American success was the deployment of South Sea island bases to launch bombing raids against Japan itself.

Unintentionally, this had a profound impact on South Sea islanders. Until then, indigenous contact with the industrialised world had been limited; the arrival of airstrips, modern weapons and equipment – medicines and tinned foods – impressed the locals.

After the war, bases were abandoned and supplies stopped. Bewildered islanders formed cults dedicated to lost 'cargo', invoking its return through imitating US troops on parade. Full scale replicas of aircraft were fashioned from bamboo and straw. Shamanic leaders encouraged disciples to build enough model planes so cargo would eventually drop from the sky. Of course, the idea was flawed. Bamboo planes won't fly, and even if they could, would they bring cargo?

Such 'cargo cult' thinking – deluding yourself that imitation brings about a desirable yet improbable outcome – troubled the physicist Richard Feynman. Lecturing in 1974, he pondered whether scientific claims to objectivity were often just blind faith.

Scientific communities work within paradigms, sets of values and assumptions, pertinent to their field. But what if evidence does not fit the paradigm? Is it valid? Such caveats speak to our covidobsessed age, saturated by SAGE briefings, and media coverage of 'the Science'. Patrick Vallance's novel strain scaremongering anyone?

So in Feynman fashion, let's deconstruct the covid paradigm:



More fundamentally, what if the assumptions underpinning the paradigm are themselves false; if you accept the truth of bamboo planes, then is it a matter of refining the wing design to enable flight? Well, you've missed the point entirely.

Feynman bemoaned so much cargo cult science, warning colleagues not to replicate research but question it, especially the 'A-number-1 experiment' generating the paradigm. Experts 'should not fool the layman', but demonstrate integrity 'bending over backwards to show how you're maybe wrong', certainly when advising government.

1. SARS-CoV-2 is a contagious virus that can result in the respiratory infection covid-19, a potentially fatal condition, and a public health risk.

- 2. SARS-CoV-2 is transmitted from person to person by aerosol particles exhaled in breath.
- 3. Not all infected persons show symptoms, so even asymptomatic carriers are 'spreaders'.
- 4. Therefore, everyone is a potential source of deadly contagion.
- 5. Individuals should be kept apart, ideally for as long as possible, to avoid further infection.
- 6. Lockdowns and other mitigation strategies distancing, masks,

tracking and testing – enable this and should remain until covid-19 either disappears or is vaccinated away.

Now our 'rule of six' begs many questions. Firstly, while yes, SARS-Cov-2 may be contagious, is it especially dangerous to most humans? Covid-19 has a high survival rate of 99.8%, inflicting harm overwhelmingly to the very old and very frail, although treatment is improving. Secondly, yes SARS-Cov-2 is communicable and endemic. Yet does this mean that sufficient viral loads are transmitted to induce serious illness? According to WHO, around 80% of those who contract the virus will experience no, or mild symptoms not requiring hospital care.

What of the critical third premise, are we blissfully ignorant walking bio-hazards? Here I defer to an important paper from lockdownsceptics.org by Drs Clare Craig and Jonathan Engler, which judged the original Chinese studies on asymptomatic transmission anecdotal and far from persuasive. Surprisingly, the case rests on just two covid-19 patients' becoming infected after contact with alleged 'asymptomatic carriers'.

However, their diagnoses relied on the now much-discredited PCR tests, which are notorious for giving false positive results. Neither patients, nor contacts, may have contracted SARS-Cov-2 at all. Since this must count as Feynman's 'A-number-1 experiment', we should revise assumptions; asymptomatic individuals are not disease vectors.

That being so, what benefit is there to quarantining the healthy? Lockdowns clearly won't halt an endemic virus, while efforts to identify and isolate 'spreaders' through mass PCR testing, throws up data with no clinical significance. Evidence is made to fit the explanation that coronavirus/covid-19 is a threat; this is pure cargo cult.

Nevertheless, 'the experts' and their ministerial masters are doomed to repeat locking down; the paradigm continues to captivate. Outside their elite circle, the paradigm has enabled an army of what sociologists term 'moral entrepreneurs', individuals who seek respect and status by goldplating and policing the 'rules'. We're saving lives. Petty shamans talk on prime time.

But who are we kidding? Even South Sea cult members realised they could not go on fooling themselves forever; most cargo cults were short-lived.

If covid proponents refuse to question their assumptions, then we must do it for them. If we don't, then we perpetuate cargo cult science, endlessly constructing bamboo aircraft in the hope of reclaiming that precious cargo, normal life.

Brazil Say No To Great Reset | Christians Gather To

On December 3, Brazil's Minister of Foreign Affairs Ernesto Araujo rebuked the WEF's technocratic "great reset" of society and the global economy in a recorded speech before the special session of the UN.

Although Araujo did not say the words "great reset" or "World Economic Forum" during his speech to the UN, he made it abundantly clear in a tweet the following day that he was referring to the "great reset" agenda in his speech.

The "great reset" is the brainchild of WEF Founder Klaus Schwab, who has been planning the technocratic agenda to reset all of society and the global economy for many years.

Brazil is now pushing back against the great reset. "Brazil is a founding member of the UN, and hence, is committed to its basic principles: peace and security, cooperation among nations, respect for human rights, and fundamental freedoms," Arauio told the UN.

"Covid-19 must not be taken as a pretext to advance agendas that extrapolate from the constitutional structure of the UN system," he added.

The Brazilian minister went on to say: "Fundamental freedoms are not an ideology. Human dignity requires freedom as much as it requires health and economic opportunities.

"Those who dislike freedom always try to benefit from moments of crisis to preach the curtailing of freedom. Let's not fall for that trap.

"Totalitarian social control is not the remedy for any crisis. Let's not make democracy and freedom one more victim of covid-19.

Araujo is a fierce opponent of globalist ideologies. In April, 2020, he wrote that "globalism replaces socialism as a preparatory stage for communism," and he referred to the coronavirus as the "comunavirus" after reading a recent booklet by Slovenian philosopher and communist Slavoj Zizek, from which he extrapolated that viruses were beneficial for spreading communism.

The Brazilian minister of foreign affairs was a controversial pick by President Jair Bolsonaro, partly due to Araujo's belief that climate science was a "dogma" being used "to justify increasing the regulatory power of states over the economy and the power of international institutions on the nation states and their populations, as well as to stifle economic growth in democratic capitalist countries and to promote the

growth of China," the Guardian's global environment editor Jonathan Watts wrote in November, 2018.

Araujo's views that climate change science and globalism are vectors for spreading Marxist ideologies, along with his pro-nationalistic beliefs. have not won him many allies on the international stage

As a cabinet member of the Bolsonaro administration, he has received his fair share of criticism from the media, and his Wikipedia page currently says that he "subscribes to conspiracy theories.'

According to Watts, Bolsonaro chose a "foreign minister who believes climate change is part of a plot by 'cultural Marxists' to stifle western economies and promote the growth of China."

However unpopular among globalists, climate change activists, and the media Araujo may be, when he said "no to the great reset," in his words he was rejecting the exploitation of the coronavirus crisis to further an agenda set by those who "preach the curtailing of freedom.'

In his speech to the UN, Araujo called for coordination and collaboration during the crisis at the international level while letting countries handle policies in their own way at the national level

"The pandemic represents a rare but narrow window of opportunity to reflect, reimagine, and reset our world to create a healthier, more equitable, and more prosperous future" — Klaus Schwab, WEF

The great reset agenda calls for a complete restructuring of society under a new form of stakeholder capitalism, where ownership is obsolete and privacy is non-existent thanks to invasive technologies coming out of the Fourth Industrial Revolution that will lead us to, in Schwab's words, "a fusion of our physical, our digital, and our biological identities.'

No one can be truly free if they are under constant surveillance and their behaviour is tracked and monitored through digital devices via the Internet of Bodies that keep a record of their every social interaction, their every purchase, their carbon footprint, their credit scores, and all of their health information — not to mention every key they smash, every link they click, and every website they visit. Technology is a double-edged sword.

All the technologies of the socalled Fourth Industrial Revolution, such as blockchain, AI, computer vision, and the IoT ecosystem can be used to help uplift people out of poverty, feed the world, and safeguard personal freedoms and privacy giving power back to the people.

But these technologies can also be enlisted to do the exact opposite of good and enforce totalitarian control under a social credit system, like the one the Chinese Communist Party

Part of China's Orwellian surveillance state strategy is to link the digital identities of its "netizens" to a social credit system. They even have a contact tracing app for "deadbeat debtors" that alerts citizens with a warning whenever they come within 500 meters of someone who is in debt

Fear of public shaming can be a strong incentive to modify one's behaviour rather quickly, but the social control goes way beyond public shaming. It determines which services you can access, which information you receive, and where you can or cannot travel, based on your credit score.

Sing Christmas Carols In **Defiance Of California Lockdown Orders**

Dozens of Christians gathered in Thousand Oaks, California, to protest Governor Gavin Newsom's severe lockdown orders. The group sang Christmas carols in defiance of state and local stayat-home mandates.

not use The Oaks as their venue." The mall is located in Ventura County, part of the Southern

California Region, a group of counties under Governor Gavin Newsom's mandated stay home order. Large gatherings are prohibited with



According to a local ABC affiliate, the crowd, appearing to be about 75 to 100 people, was caroling outside The Oaks mall-right next to a covid-19 testing center. There were people of all ages, from children to senior citizens, in the group.

The event was part of nationwide effort by Sing It Louder USA to engage people to peacefully protest lockdowns and restrictions through song. Their events are for "...all Americans who are fed up with government officials telling you that you can't celebrate Christmas the way you want to." The first nationwide event was held on Dec. 6, but many have continued the events throughout the month.

The Sing It Louder event in Southern California was held in the parking lot of The Oaks, a mall in Thousand Oaks and was organized by actor Kirk Cameron, best known for his role as Mike Seaver on the 1990s ABC sitcom Growing Pains

"I'm getting ready to go out in 38 minutes, it's T-38 minutes for our Christmas caroling peaceful protest," Cameron said in an Instagram post. "We are going to be celebrating our God-given liberties, our constitutionally protected rights at this time at Christmas to sing Christmas songs to gather, to assemble, and to sing about the birth of our Saviour."

The Oaks mall posted a statement to Facebook, saying: "We do not condone this irresponsible—yet constitutionally protected—peaceful protest event planned. We share your concern and have notified the Sheriff's office. As well, we have reached out to the event planner to ask that they do the exception of religious services and political expression.

"Feel like you're done with all the mandates telling you how many people you can have in your home or how you're supposed to eat or that you cannot sing?" said Houston pastor Steve Riggle on the Sing It Louder website.

According to NBC, Cameron stated that all attendees were encouraged to wear masks and had no further comment.

In an interview on Fox News Cameron said "I'm looking around in my community and I'm seeing the devastation and the suffering of people whose businesses have been bankrupted. People who have been dealing with anxiety, depression; suicide spiking. The abused being quarantined with their abusers and I can't just ignore that. I love my neighbors and so I want to give them hope.

Thousand Oaks Mayor Claudia Bill-de la Pena said regarding the event: "Liberty and freedom are very fragile and they come with great responsibility. Continuing to hold large gatherings and ignoring all guidelines, I feel, is unchristian."

Cameron pledged to continue hosting caroling events: "This is the land of the free and home of the brave, and there are thousands and thousands of people in our community who would rather not suffer in isolation and come out to sing and express their gratitude," he said. "We believe there is immunity in community, but there is desolation in isolation.'

Mexico Bans Roundup As Toxic

Mexico's Environment Ministry has announced that glyphosate-based herbicides will be phased out of use in the country by 2024 to protect human health and the environment.

The Secretariat of Environment and Natural Resources (SEMARNAT) announced in June 2020 that it had created a roadmap for the gradual reduction of the use of glyphosate in Mexico until it achieves a complete ban in 2024.

SustainablePulse.com translated and published the SEMARNAT announcement in full:

"Given the scientific evidence of glyphosate toxicity, demonstrating the impacts on human health and the environment, the Secretariat of Environment and Natural Resources (SEMARNAT) has taken important steps to gradually reduce the use of this chemical until it achieves a total ban in 2024."

Dr. Adelita San Vicente Tello, Director General of the Primary Sector and Renewable Natural Resources at SEMARNAT, announced the news after participating in the conversation

San Vicente Tello explained that the issue of pesticides has provoked a great struggle for several years, and now SEMARNAT, with Victor M. Toledo at the helm, is taking determined steps towards the transformation of the country's agrifood system in order to make it "safer, healthier and more environmentally friendly", as part of which it has identified the gradual reduction of



glyphosate with alternative methods as critical.

Among the actions that have already been taken, she recalled that in November last year, under the precautionary principle for the prevention of environmental risks, SEMARNAT stopped the import of a thousand tons of glyphosate.

She also explained that the Committee on Health, Food, Environment and Competitiveness (GISAMAC) was also established in 2019 with the aim of having a national vision for major health and environmental problems. The Ministry recently gave its full support to the policy introduced by the Committee for the urgent attention of environmental issues for the benefit of the health and well-being of the Mexican population.

San Vicente Tello said that, together with the National Council of Science and Technology, she is analysing alternatives to the use of glyphosate-herbicides for large-scale agricultural production, as there are many weed management experiences with methods that farmers themselves and indigenous communities have applied for thousands of years.

In addition, government education campaigns are being prepared with different medias, such as infographics and videos that will be translated into several languages and will include data and independent scientific sources on the effects of glyphosate-based herbicides on the environment and health, with the purpose of alerting the population to the risks involved from their use. During and after these campaigns the general public and specific communities can draw their own conclusions.

Finally, San Vicente Tello reiterated that in the face of this problem we all have to act, because "beyond productivity, there is human and environmental health."

Australia Scrap Vaccine Trials After Participants Return False HIV Results

The Australian authorities following medical advice have abandoned a covid vaccine after Stage One clinical trials indicated false HIV positive results in numerous participants.

The cancellation of the trial vaccine comes as an embarrassment for the Australian government as they had agreed to buy 51 million doses. The experimental vaccine project was planned to cost \$750 million.

According to the University of Queensland and biotech firm CSL who had been conducting the clinical trials in the past few months, the vaccine was showing promising signs and was proving to be effective in making antibodies in the early trial stages. Despite early positive predictions, the vaccine ran into difficulties and was axed after several volunteers returned a false positive HIV result due to a protein contained in the vaccine.

According to Health Minister Greg Hunt, the vaccine "triggered an antibody response that could interfere with HIV screening". Follow up tests proved that HIV was not present, and no safety concerns were observed in the 216 participants involved in the first clinical trial.

The vaccine developers stated that re-engineering the vaccine could take a year and together with risking public trust and confidence in vaccinations, they decided not to proceed to Phase 2/3. Professor and vaccine co-lead Paul Young from the University of Queensland reported feeling devastated with the decision after months of "living and breathing this project".

As expected, the Australian government downplayed the mistakes in the trial. Prime Minister Scott Morrison when asked about invested money wasted, told reporters "You need to spread your investments to give as much opportunity for the most successful vaccines to go forward". In response, the Australian government increased its order of other vaccines as a way of compensation.

The cancellation only highlights the issues that can occur when scientists and vaccine developers try to condense clinical trials and testing in only a few months instead of the recommended years long process in developing safe and effective vaccinations. Immunologist John Moore from Weill Cornell Medical College in New York reacted to the scrapped vaccine by saying "It's not great to be associated with a mistake like this but when you're running at 90 miles an hour, sometimes you trip".

The world has been watching Australia during covid and is shocked by their strict aggressive lockdown measures, invasive contact tracing, state/border shutdowns, and violent enforcement by the Police. The State of Victoria under the control of totalitarian Premier Daniel Andrews got the brunt of these draconian measures.

In a recent decision, dated November 11, 2020, a Portuguese appeal court ruled against the Azores Regional Health Authority concerning a lower court decision to declare unlawful the quarantining of four persons.

Of these, one had tested positive for Covid using a PCR test; the other three were deemed to have undergone a high risk of exposure. Consequently, the Regional Health Authority decided that all four were infectious and a health hazard, which required that they go into isolation.

The lower court had ruled against the Health Authority, and the appeal court upheld that ruling with arguments that explicitly endorse the scientific case for the lack of reliability of the PCR tests (e.g., as extensively explained in Lockdown Skeptics by Dr. Mike Yeadon, Dr. Clare Craig and others).

"Based on the currently available scientific evidence this test [the RT-PCR test] is in and of itself unable to determine beyond reasonable doubt that positivity in fact corresponds to infection by the SARS-CoV-2 virus, for several reasons, among which two are paramount (to which one would need to add the issue of the gold standard, which, due to that issue's specificity, will not be considered here): the test's reliability depends on the number of cycles used; the test's reliability depends on the viral load present."

Citing Surkova et al. (2020; https://www.thelancet.com/journals/lanres/article/PIIS2213-2600(20)30453-7/fulltext), the court further states that any diagnostic test must be interpreted in the context of the actual probability of disease as assessed prior to the undertaking

of the test itself, and expresses the opinion that "in the current epidemiological landscape of the United Kingdom, the likelihood is increasing that Covid 19 tests are returning false positives, with major implications for individuals, the health system and society."

The court's summary of the case to rule against the Regional Health Authority's appeal reads as follows: "Given how much scientific doubt exists — as voiced by experts, i.e., those who matter — about the reliability of the PCR tests, given the lack of information concerning the tests' analytical parameters, and in the absence of a physician's diagnosis supporting the existence of infection or risk, there is no way this court would ever be able to determine whether C was indeed a carrier of the SARS-CoV-2 virus, or whether A, B and D had been at a high risk of exposure to it."



'High-Value' Business Travellers Exempt From New Quarantine Rules

S ince the 5th of December, journalists, TV production staff, performing arts professionals, elite sports-people and "high value" business travellers no longer need to self-isolate when arriving in England.

The generous exemption applies even for arrivals from countries deemed covid high risk, or not found on the UK 'Travel Corridor' list. Prior to this, exemption rules were only made for armed services personnel, essential government workers, diplomats, and seasonal agricultural workers.

On the 3rd of December Transport Secretary Grant Shapps tweeted "New Business Traveller exemption: From 4am on Sat 5th Dec high-value business travellers will no longer need to self-isolate when returning to England from a country not in a travel corridor, allowing more travel to support the economy and jobs. Conditions apply".

The qualifying criteria so far from the Department for Transport to determine what is a "high-value" traveller is that business trips must result in a deal which creates or preserves 50 jobs or leads to a £100,000 investment or order. The Department also stated that the high-value enterprise exemption would apply to enterprise exercise which might ship a big profit to the UK economic system. Another absurd

rule in a long list that makes the mind boggle.

There has been a backlash to this cynical decision by the government to allow their 'mates' to travel freely under the guise of "bringing significant economic benefit to the UK".

Labour MP Ben Bradshaw tweeted: 'Is this a joke? What Is high value?' Many social commentators online have commented that the term "high-value" business traveller is just a fancy way of saying 'a rich person'.

For the rest of the general population, travellers entering England from destinations not on the travel corridor list can choose to cut their quarantine to five days of self-isolation, if they take a covid test that comes back negative.

The test will be at the cost of the traveller and must be from a government-approved private test provider. Tests from private firms can cost between £65 and £120. The new 'Test to Release' strategy have been in effect since December 15, 2020.

Be in no doubt, the government will always prioritise the rich and privileged and find 'loopholes' to meet their greedy needs. One rule for the elites and big multi-national companies, another rule for ordinary citizens.



The Impact Of 2020 On The Travel & Tourism Industry

In 2019 travel & tourism contributed US\$8.9 trillion to the world's GDP, creating 330 million jobs (1 in 10).

But the travel industry has always been highly susceptible to world events, thus it is no stranger to fighting for its survival and finding solutions to weather each storm. Covid has been catastrophic for many countries where tourism has been their main source of revenue - the 'One in 330 million' article linked at the end illustrates this well.

No one would have expected that by the end of the year the disruption to air, sea and rail travel would have resulted in Manchester and Heathrow airports both announcing the closure of terminals throughout 2021, the scrapping of redundant cruise ships and the increasing likelihood of rail re-nationalisation.

Airlines have been forced to re-evaluate their operating model and many have chosen to retire their 'jumbo jets' as no longer economically viable - out of 492 Boeing 747's in existence today over two thirds are used for freight and of the remaining 157 commercial passenger jets just 35 are currently in service. Similarly the Airbus A380, which only entered service in October 2007, is no longer in production and of the 251 manufactured only 18 are flying and 5 of those belong to China Southern Airlines. Whilst scrapping a 40 year old 747 could be expected, the same treatment of a 13 year old A380 would ordinarily be unheard of, yet several have already been scrapped whilst many others, along with their Boeing counterpart, are being stored in aircraft graveyards around the world whilst their owners debate their fate

Those airlines still able to fly have been handicapped considerably by the ever changing restrictions and travel corridors whilst others impacted by the dramatic drop in demand for air travel have welcomed the recent news that their fleets of Boeing 737-800 Max aircraft can once more take to the skies following the two fatal incidents in 2018 which grounded the type.

Redundant air crew, especially experienced pilots, have effectively been faced with early retirement with reports from Australia of some becoming bus drivers.

Cruise lines, enjoying tremendous growth prior to March, saw their market disappear almost completely with a record 34 ships being sold, at least 10 of which have been scrapped. Today's modern mega cruise ships cost up to \$1 billion to build and would normally be retired after around 40 years. Yet ships half that

age have been sold to specialised scrap yards in Turkey and India for around \$4million a time.

There are currently over 300 cruise ships plying the world's oceans with another 30 set to have been launched in 2020. Of those that were actually launched Richard Branson's first ever vessel for his new, rather ill-timed, Virgin Voyages venture and P&O's 5,200 passenger, 180,000 ton ship which runs on Liquefied Natural Gas have yet to commence their cruising operations in the Caribbean and Mediterranean respectively.

A large percentage of people working on cruise ships in the crew capacity are typically from developing world countries with their meagre income, boosted by tips, being sent home to support their families. Many of these have been left stranded on board ships that are anchored in safe harbours around the world (here in the UK Weymouth Bay attracted thousands of sightseers to the magnificent spectacle of up to a dozen huge cruise ships) and two months ago it was estimated that as many as 400,000 crew find themselves in this unacceptable situation

Meanwhile the 'mothballed' aircraft and cruise ships themselves have to be maintained and modified for re-entry into service in compliance with health and safety guidelines that differ from country to country.

Inconsistencies in these same guidelines permit an aircraft to carry a full load of passengers whilst rail and bus operators, here in the UK at least, have had to block off seats to ensure social distancing with the attendant loss in revenue and reduced schedules reflecting the dramatic drop in demand.

Rail operators, like their airline counterparts, are equally dependent on business travel which has dried up considerably and been replaced by online meetings facilitated by technology.

Car rental companies rely as much on business travellers as they do on holidaymakers. Hertz was forced to file for bankruptcy in the USA and Canada at the end of May, as the business lost all its revenue and amassed debts of more than £15 billion, with the majority of its branches closed during the pandemic.

Rival US firm Avis posted a \$158 million (£127m) loss in the first quarter of 2020, warning of an \$800m (£643m) cash burn between April and June.

The hotel sector has fared no better with MGM Hotels losing \$535m and choosing to open their flagship Las Vegas properties only at weekends. In

New York City it is reckoned that as much as 20% of their hotel rooms will be closed permanently.


Over the past four decades the travel industry has reaped the benefits of incredible demand for foreign travel fuelled by many factors and leading to fierce competition between airlines, tour operators, cruise lines, hoteliers and even tourist boards all eager to attract new customers and retain existing ones. A healthy percentage of these customers had been seniors with both the disposable income and appetite for regular trips.

Consequently with their higher susceptibility to infection this market contracted immediately and, here in the UK, by May it had led to the collapse of the UK's largest coach tour operation, comprising the longestablished brands of Shearings, National and Wallace Arnold, with debts of over £200 million resulting in the loss of 2500 jobs and 64000 cancelled peak season holiday bookings. (Their purpose built interchange at Stretton, near Warrington, has become a post Brexit staging point for Irish Sea freight traffic)

Freight traffic has increased significantly as a result of the explosion in online shopping and has helped the ferry operators keep afloat (pun intended) albeit their losses are unsustainable in the long term.

Of course, business adapts. With the onset of the first lockdown travel agents around the world had to set about modifying and cancelling millions of bookings. A recent report from the UBS investment bank has found that the covid-19 pandemic could accelerate the shift of passengers from air to rail, supercharging growth across the next decade predicting that global air traffic growth will drop from 5.1% to 4.6% over 2018-2028 with recovery to pre-2020 levels not expected until at least 2023. The company also estimates that there will be approximately 800 more high-speed trains in operation in Europe within the next decade, while 196 fewer planes will be required.

The report went on to say there is likely to be a boom in rail travel, as has been the case in China, where domestic tourism was the first to benefit post-pandemic. Regional travel then looks like the next beneficiary as passengers look to travel to neighbouring destinations rather than further afield. In the short-term, rail travel will likely experience an upturn as travellers venture domestically and to neighbouring destinations once restrictions are lifted, says



GlobalData travel and tourism analyst Johanna Bonhill-Smith.

"A boom in rail travel may be possible as this offers a 'middle ground' between expensive flights and slow travel by sea. Looking to the long-term, however, once efficient measures are put in place, it is likely that air travel will resume, causing pent-up demand amongst certain age groups."

Travel businesses around the world have been using the hiatus to enhance and adapt their offerings to the new marketplace that will inevitably emerge and those that survive can look forward to consumers eager to enjoy new experiences whilst playing an important role in reversing the environmental damage that has so often resulted from mass tourism. New generation aircraft from both Boeing and Airbus along with new cruise ships have all been designed to reduce their environmental impact whilst improving the customer comfort and people will undoubtedly be eager to enjoy the experience aboard these planes and ships.

The tourism offices will play a key role in the development of strategies designed to protect the significant contribution that the sector makes to their country's economy. A good example is that taken by Petra Roach, interim president and chief executive of the Barbados Tourism Authority in the UK and head of global markets,

when she launched the 'Barbados Welcome Stamp' initiative which invited people working from home to move over there to do so. This move was the subject of a Channel 4 documentary as it demonstrated the benefits both to the island economy and to those who took advantage of the scheme to live and work in what many would consider paradise.

Similarly the United Arab Emirate of Dubai has capitalised on its strategic location and massive investment in tourism by promoting the destination as an extremely safe place to visit. Emirates is the largest operator of the Airbus A380 – ensuring sufficient capacity in line with the campaign and attracting those who still wish to experience the aircraft.

Of course the pent-up demand is already catered for by those customers whose faith in the industry has led to their accepting vouchers for future bookings rather than insisting on refunds. It is these very customers who have ensured the survival of many airlines and cruise lines as are those consumers placing deposits for bookings as far ahead as 2022.

Safe To Fly? Aerotoxicity Cover-Up Scandal

s an airline pilot I got seriously by JOHN HOYTE A ill from flying jets. To help those with the same illness, I founded The Aerotoxic Association in 2007.

Aerotoxic Syndrome is the term used to describe an illness caused by jet planes. However, to protect the aircraft industry, this term and my Association are effectively banned by Governments and media

Most jets use unfiltered 'bleed air', which has been 'piped' off the jet engines to pressurise the cabin. Everyone on board breathes air containing toxic particles from jet engine oil. In a significant leak, a visible cloud of poisonous chemicals called a 'fume event' is released. However, as jet oil seals are designed to leak, a background level of poison is present all of the time.

Organophosphates were originally developed as nerve agents for chemical warfare in the 1930s but are used as 'anti-wear' agents when added with other toxic substances to jet engine oil to make engines last longer. When smoking was outlawed in the 1980's, cabin air was no longer clouded with pungent tobacco smoke. People started to report odours caused by toxic oil fumes-described as 'Sweaty Socks' or 'Wet Dog'.

In the 1990s, Australian aircrews presented with poor memories, lung damage and multiple neurological complaints caused by nerve agent poisoning. In 1999, an Australian Toxicologist, a US Doctor and a French forensic scientist, who had all been studying sufferers, called this disease 'Aerotoxic Syndrome'. But as this knowledge would reduce anyone's desire-either as a passenger or crew-to fly in planes with a design flaw, a systemic cover-up began.

Such is the financial power of the air industry they can still claim there is 'no positive evidence' and use 'jet lag' as a convenient cover story. Certain scientists shamefully downgraded organophosphates from 'nerve agents' to 'nuisance or irritant' chemicals. Just like the VW Emission scandal - the identified high concentrations of poisons in a visible oil 'fume event' have still never been published, leading to endless costly, fruitless 'further research' which is deliberately designed to misinform doctors, scientists and politicians who serve the public.

No sworn testimony or published medical tests of survivors are believed and most cases are settled 'out of court' with countless cases waiting to be heard.

The BBC effectively banned their new unpublished term of Aerotoxicity in around 2006 – otherwise too many flyers would discover the inconvenient cause behind their ill health.

The last time the BBC covered the

health scandal was on 25th February 2020 with shocking news: 'After years of gathering evidence, 10 lead cases against four UK airlines are due at the Royal Courts of Justice this year. Unite, the union behind the action, says it wants the public to know about the aviation industry's biggest secret. "An extraordinary amount of powerful evidence has been gathered," says General Secretary Howard Beckett, the BBC have failed to follow up, as the 'pandemic' has since confirmed that wealth was always more important than health.

Around 30% of the population have difficulty detoxifying organophosphates and are badly affected by exposure to them. 5% become severely affected. This translates into huge numbers. A 2017 Dutch published paper estimated 1,000,000 frequent flyers and aircrew unknowingly have Aerotoxic Syndrome in Europe alone.

On 21st January 2017, US pilot, Captain Andrew Myers made legal history. He was incapacitated during a fume event whilst in command of an Airbus A320. His landmark legal case was won in an Oregon public court on 31st July 2020, paving the way for countless other victims to be compensated, but the establishment media led by the BBC failed to report this legal precedent, which is now being appealed against.

Another example of this habit of appealing occurred when after multiple appeals over eighteen years, cabin attendant Joanne Turner finally won her poisoning case in the High Court of Australia on 3rd of September 2010. But the next day. industry would claim again that there was 'no positive evidence'

There are solutions, once the industry has accepted there is a major problem. The first jets of the 1950s took in clean outside air and compressed it. But these compressor pumps failed regularly. From 1962 onwards, industry found it cheaper to let 'bleed air' enter the cabin via the engines, even though it was publicly recorded that this air was contaminated-by design.

It is on record that in 1999, Boeing were aware of the poisoning in their aircraft and therefore their new design - the Boeing 787 Dreamliner - returned to the old tried and tested electrical pumping architecture of compressing outside air. There are two nostril-like holes either side of the fuselage where air is sucked in. Passengers and crew enjoy uncontaminated air; but Boeing cleverly introduced other changes for example, they increased the cabin air pressure from 8,000 feet to 5,000

feet. In this way, the health benefits could not be solely attributed to breathing uncontaminated air.

Before the plandemic started, there were around a thousand B787s. The rest of commercial flying was performed by some twenty-five thousand aircraft, all of which use contaminated 'bleed air'.

However, there are engineering solutions that would mitigate the known design flaw:

- 1. Filter the bleed air filters are now available.
- 2. Provide every aircraft with a Toxic Air Detector to allow the poison to be monitored. It is almost beyond belief that there are no Toxic Air Detectors in multibillion dollar jets. Aircrews' noses judge whether or not the air is poisonous?
- 3. To use engine oil that uses less toxic chemicals. In recent years, many airlines have started to use safer

However, from the industry's point of view, putting any solution into effect runs the risk of admitting there was a problem and thus admission of liability. Such fears have caused glacially slow progress in fixing this problem. And in any case, these are all 'sticking plaster' solutions.

By far the biggest crime of the past 20 years has been the ban of any mention of the name of the illness to prevent the public from finding out about their ill health.

We are used to the self-righteous indignation of media journalists over other human rights and serious health issues, but this time the ongoing media ban and cover-up of even the word 'aerotoxic' is an even greater scandal. not the seven decade long cause of mass poisoning, which has become normalised like so many others

The word which best sums up the systemic aerotoxic public poisoning cover-up is embarrassing. To poison professional aircrew for seven decades and expect to get away with it misunderstands the mindset of professional aircrew who dedicate their lives to public duty and are used to 'completing the mission'

Directions:


Layer the sliced onion into a glass jar.

Bad Diet Advice Is The Real Epidemic-Metabolic

Syndrome

have worked for most of my life as a pharmacist. However, I left my profession earlier than I had intended to because I was frustrated and disillusioned. I was seeing so many people who took their medication but never got better.

They had metabolic diseases and their drugs were treating the symptoms, but not the root cause, of the illness. Type 2 diabetes, heart disease, hypertension, obesity and insulin resistance are the components of what is known as Metabolic Syndrome - these are all lifestyle-induced abnormalities and the most significant root cause of them all is a bad diet.

In the UK there are more than 20 million obese people, and at least 4 million have type 2 diabetes. Why has this happened when there is so much advice available on 'healthy eating'?

After a lot of research, it became clear to me that the advice we are being given is wrong. Since 1983 the NHS has been promoting the consumption of carbohydrates in place of dietary fat. Saturated fat has been vilified despite the fact there is no scientific evidence that saturated fat is harmful. The relentless weight gain and prevalence of diabetes is driven by insulin resistance, which is caused by eating too much carbohydrate.

I was appalled at the realisation that the diet recommended by the NHS, and many nutritionists, is causing all our metabolic malaise.

The Government response to the SARS-Cov-2 virus has involved the most draconian restrictions ever imposed on healthy people. In

March we were told a three-week Lockdown was necessary to save the NHS from being overwhelmed. Nine months later we are still severely restricted. 'Saving the NHS' has been a constant theme along with antisocial distancing, masks and quarantine. This implies there is nothing else to be done while waiting for a vaccine.

When Government agencies like Sage are telling us what to do, I always pay attention to what they are not saying. They have never suggested anything with which we could boost our own immunity. Surely if we all had a potent immune system, that would reduce demands on the health service?

Covid-19 is a nasty disease, which, sadly, has hastened the death of some people. Why do Johnson, Hancock, Whitty and Vallance never mention the fact that 95% of the people who have died had at least one pre-existing metabolic condition?

The health service, which they are so keen to save, is constantly under pressure from all the millions of people who have dietary-induced diseases. The real health emergency in the UK is not a coronavirus; it is Metabolic Syndrome.

The Government has spent a staggering £350 billion on one virus. Imagine if they had put all that money, time and effort into tackling what really ails us. They could have improved the health and well-being of tens of millions of people, slashed the NHS bill for years to come, whilst also preventing a great many deaths.

Chris Whitty is the Government's

Chief Medical Officer and Patrick Vallance is its Chief Scientist. Throughout their tenures, they have both failed to tackle the diseases which cause hundreds of thousands of premature deaths every year.

They have failed to mention a recent study from Spain which measured the blood sugar levels of hospitalised covid patients. Those with the highest blood sugar were 50% more likely to die than those with the lowest levels.

We are told to base our meals on carbohydrate rich foods like bread, rice, pasta and potatoes. These are all known as starches but our digestive system breaks them down into simple sugars. The elevated blood sugar that follows can have drastic effects. Someone with uncontrolled type 2 diabetes may suffer from kidney damage, blindness, nerve pain, gangrene leading to amputation, dementia, heart disease and increased susceptibility to infections.

A study in 2011 showed that raised blood sugar hampers our innate immune system. Healthy immune cells have a variety of functions including the ability to recognise certain molecular patterns, which identify bacteria and viruses as pathogens. High levels of blood sugar were shown in the study to diminish the ability of immune cells to recognise infectious agents. If

we cannot recognise a pathogen, we cannot initiate the response we need to eliminate it.

An excellent diet not only prevents modern, non-communicable diseases but also helps us to fight infections. We need to eat a diet which keeps sugar levels, and therefore insulin levels, low. Good health comes from a low-carbohydrate, high-fat diet, which is the opposite of official advice.

A robust immune system also requires certain critical nutrients to function properly. One of those is selenium, which is needed to produce infection-fighting T-cells, B cells and antibodies.

Zinc is another trace mineral which is important for maintenance and development of immune cells. Lymphocytes and natural killer cells do not form properly, nor function properly, unless there is an adequate supply of zinc. Studies have shown that people with optimum levels of zinc are far less likely to die from covid than those who are deficient.

The best sources of selenium and zinc include salmon, tuna, beef, chicken, free-range eggs, mushrooms, sardines, nuts and dairy products.


Vitamin D has a wide range of benefits in the human body. An optimum level of Vitamin D has previously been shown to reduce the severity of an influenza infection. Knowing this, some researchers tested the vitamin D status of hospitalised covid patients and found a clear relationship: the lower the Vitamin D levels, the worse the outcome. Properly controlled trials have now been conducted which confirmed these observations. We make Vitamin D from cholesterol molecules when the sun shines on our bare skin, but during the winter we need to eat oily fish, eggs, liver and beef to obtain a sufficient supply.

I am not suggesting that an optimum level of these nutrients is a cure for covid, but if you become infected, your chances of a severe illness are considerably greater if you are deficient.

Why have Whitty and Vallance never mentioned this when there is no downside to having an ideal intake of essential nutrients? It is important to note that the great majority of foods containing selenium, zinc and vitamin D are of animal origin and high in fat.

Large sections of the population are unwell because we are fed by a food industry that pays little attention to our health and treated by a drug industry that pays no attention to our food.

Pharmaceutical companies do not want you to believe you can keep yourself healthy with the right diet and lifestyle, because if we all did that, their profits would plunge.

I am also very supportive of The Light newspaper and we decided to advertise for like-minded people to set up their own Freedom Hubs to meet, chat and take action and network. We are not political or religious, we are all inclusive and all want the same thing which is our birthright—freedom!

What is its purpose?

We have all been affected in some way or other by what has gone on this past year. Many of us are aware that we are not being told the truth and there is an ulterior motive behind the scenes. Many people are scared and need support and others are proactive and want their freedom back. The Freedom Network is a means for everybody to join together, either large groups already set up or individuals who have no one to turn to. We want everyone who is of a similar mindset to join us and work together so we can take action.

We are also connecting with professional groups of people such as CACUK, a group of individuals taking class action (group litigation) against the government. Then there's the UK Medical Freedom Alliance. We are basically the Yellow Pages of all what is going on right now, gathering various communities and tribes so we can work together and regain our freedom.

How many people have joined?

In less than one month we have set up over one hundred hubs in the UK and each hub could comprise either one person or over 100. We also have the Mighty Freedom Network Hub which is the social media network for people to chat, share and come up with plans of action that we can take across the UK.

We are receiving enquiries from abroad and now have hubs in Brazil, US and Canada. We are planning to get more organised and discover who our members are as they are from all walks of life – doctors to train drivers, vets to shelf stackers.

How can people join your group or learn more?

Please check out the website www. thefreedomnetwork.co.uk to see if there is a Freedom Hub in your area to join. If there isn't then please set one up! It's very easy, we add you to the website map and then like-minded folk will contact you directly.

I send out a 'newsletter/email' each week to the Hub co-ordinators who will share it with their group so we can take simultaneous action. At this point I would like to say I am more the administrator than the 'take action' person. On this occasion, we really are 'all in this together' so everyone has their part to play.

Do you have any recommendations for people to do their own research?

I had an apologetic email this afternoon from a lady who just last week, had described the benefits of wearing a mask and how to make and wear them. I realise that being kind in my response is crucial with a suggestion to research, in this case

Everton Demand Covid Test For Attending Fans

A message by Everton Football Club has caused much concern.

All of the restricted number of season ticket holders allowed to attend the match on 28th December against Manchester City needed to complete a health questionnaire and pass a Covid-19 test within 36 hours of going through the turnstiles. Ironically the match was postponed due to positive Covid cases in the visiting team.

Fears that a vaccine passport will be required for public events cannot be dismissed: this medical tyranny is happening now. Unless as a society we stand up for our rights, this Everton tweet will become the norm:

- 'Coming to Goodison for #EVEMCI tomorrow? Remember to follow our #GamePlan and get a negative covid-19 test no more than 36 hours before the match. Click the link to find out which testing centres are open.'

It seems that the authorities are using Liverpool as a testing ground for the 'New Normal' emerging from the coronavirus pandemic. The mass testing programme in the autumn, with army

trucks on the streets, was portrayed by the Labour mayor as a demonstration of how Liverpudlians care for each other. Perhaps Everton, with its working-class dockside roots and self-described as the 'People's Club', was chosen because if feisty Scousers can be persuaded to follow radical changes to their lives, anyone can.

But this was a step too far. The outrage on Twitter was palpable. Many simply replied 'Boycott'. Others expressed their horror at this dystopian turn: – 'We are not livestock to be tested and tagged. Don't stand for it.' (Indrid Coldert)

And: — 'These clubs are COLLABORATORS. Do not contribute to the new norm because this will become permanent.' (Nordic Mike)

Testing healthy people for a disease of low risk to themselves just to spend two hours sitting in the open air is not justifiable. Medical interventions should be targeted at those who are vulnerable or ill. Furthermore, as a tweet by David N



argued, 'one of the most likely places to catch covid-19 is at a testing centre'.

Test results based on a dubious procedure with a high false positive rate could unfairly bar supporters, but a negative result is no guarantee against germs, as tweeted by Father John Hackett: – 'You can't catch this highly infectious virus for 36 hours after a test. That's a new one anyone told SAGE?'

A chap named Chris tweeted 'make sure they get a HIV test too'.

Well, why not? Simon Dolan, who unsuccessfully sought a judicial review against the government's emergency legislation, wrote: – 'You can of course attend if you have Ebola, Dengue fever, typhoid, tuberculosis, Marburg hemorrhagic fever, or indeed all of these.'

Over ninety-nine per cent of the

hundreds of replies were against the club. Indeed, the only exception was a supporter who had completed the questionnaire but wanted to know why none was provided for his son. It seems that this lad was tested for nothing.

Everton supporter Invictus saw this latest move in the broader context of ideological imposition: — 'That's me out. 50+yrs a blue supporter, but done with football between this and the knee.'

Invictus was referring to the Black Lives Matter campaign and the tiresome ritual of 'taking the knee' by players before kick-off. This racial divisiveness is an insult to supporters, many of them whom can barely afford the tickets. Traditional fans have become disillusioned with clubs they have supported throughout their lives treating them like naughty schoolchildren. Every stadium is adorned with prominent signs hectoring about woke causes and urging people to report 'hate'.

Meanwhile VAR is ruining the raw excitement of the game, with muted goal celebrations while the scorer is checked for offside. The hashtag #FuckFootball has been trending.

For millions of men (and many women too) the habit of a lifetime is fading into nostalgia. Lifelong supporters may never return. Do the premier clubs care? There is much more profit from live televised matches than from ground receipts, and an empty stadium needs no stewards and policing.

The World Economic Forum, architect of the 'Great Reset', plans a technologically controlled society in which human beings are kept apart. No more crowded pubs, gigs or football stands.

Fans should speak out now. The only way to get back to a full ground with all the noise and atmosphere is to refuse to comply with Covid passports. This is a battle for the future of football that must be won. The arguments should not be merely sentimental. Forcing healthy citizens to be tested or vaccinated as a condition for normal activities would breach the Nuremberg Code.
