

**NOTICE OF MAKING OF AN ORDER**

**HIGHWAYS ACT 1980**  
**NORTH SOMERSET DISTRICT COUNCIL**  
**(PART OF FOOTPATH AX 6/7, PURN HOUSE FARM, PURN WAY, BLEADON)**  
**PUBLIC PATH DIVERSION ORDER NO. 3 2012**

The above Order, made on 5<sup>th</sup> April 2012, under section 119 of the Highways Act 1980, will divert that part of Public Footpath AX 6/7 in the Parish of Bleadon within the District of North Somerset as described below, **from:**

point A (Grid Reference ST 33488 57260) running in a generally westerly direction for approximately 106 metres to point B (Grid Reference ST 33383 57263) then in a generally north westerly direction for approximately 120 metres to point C (Grid Reference ST 33293 57341) as shown by a bold continuous line on Map No. PPO 139.

**to:**

a Public Footpath from point A (Grid Reference ST 33488 57260) running in a generally northerly direction for approximately 27 metres to point D (Grid Reference ST 33485 57287) then in a generally westerly direction for approximately 76 metres to point E (Grid Reference ST 33408 57294) then in a generally westerly direction for approximately 10 metres to point F (Grid Reference ST 33399 57293) and then in a west, north westerly direction for approximately 117 metres to point C (Grid Reference ST 33293 57341). The footpath will have a width of 2 metres between points A and F and 2.5 metres between points F and C, as shown by a bold broken line on Map No. PPO 139. The pedestrian gates at points E and F will be BS 5709.2006 compliant.

References to the lettered points above are references to the points on the Order Map No. PPO 139.

Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, North Somerset District Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment for confirmation, any representations and objections which have not been withdrawn will be sent with the Order.

#### **PUBLIC PATH DIVERSION ORDER NO. 3 2012**

This Order is made by North Somerset District Council (“the authority”) under Section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interests of the owners of the land crossed by the footpath described in paragraph 1 of the Order and of the public it is expedient that the line of the path should be diverted.

The applicants have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER:

1. The public right of way over the land situated at Purn House Farm, Purn Way, Bleadon and shown by a bold continuous line on the Map No. PPO 139 contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which North Somerset District Council certify that work has been carried out to bring the site of the new highway mentioned in Part 2 of the Schedule into a fit condition for use by the public.
2. There shall at the end of 28 days from the date of confirmation of this Order be a public footpath over the land situated at Purn House Farm, Purn Way, Bleadon described in Part 2 of the Schedule and shown by a bold broken line on the Map No. PPO 139 contained in this Order.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

## **SCHEDULE**

### **PART 1**

#### **DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS**

That part of Public Footpath AX 6/7 in the Parish of Bleadon from point A (Grid Reference ST 33488 57260) running in a generally westerly direction for approximately 106 metres to point B (Grid Reference ST 33383 57263) then in a generally north westerly direction for approximately 120 metres to point C (Grid Reference ST 33293 57341) as shown by a bold continuous line on Map No. PPO 139.

### **PART 2**

#### **DESCRIPTION OF SITE OF ALTERNATIVE HIGHWAYS**

A Public Footpath in the Parish of Bleadon from point A (Grid Reference ST 33488 57260) running in a generally northerly direction for approximately 27 metres to point D (Grid Reference ST 33485 57287) then in a generally westerly direction for approximately 76 metres to point E (Grid Reference ST 33408 57294) then in a generally westerly direction for approximately 10 metres to point F (Grid Reference ST 33399 57293) and then in a west, north westerly direction for approximately 117 metres to point C (Grid Reference ST 33293 57341). The footpath will have a width of 2 metres between points A and F and 2.5 metres between points F and C, as shown by a bold broken line on Map No. PPO 139.

#### **LIMITATIONS AND CONDITIONS**

Point E (Grid Reference ST 33408 57294)	Pedestrian Gate
Point F (Grid Reference ST 33399 57293)	Pedestrian Gate

The pedestrian gates specified above are to be provided to comply with BS 5709.2006 and should be considered for removal in the event that they are no longer required to prevent the ingress or egress of animals or if the land is no longer used for agricultural purposes including forestry and the keeping of horses.

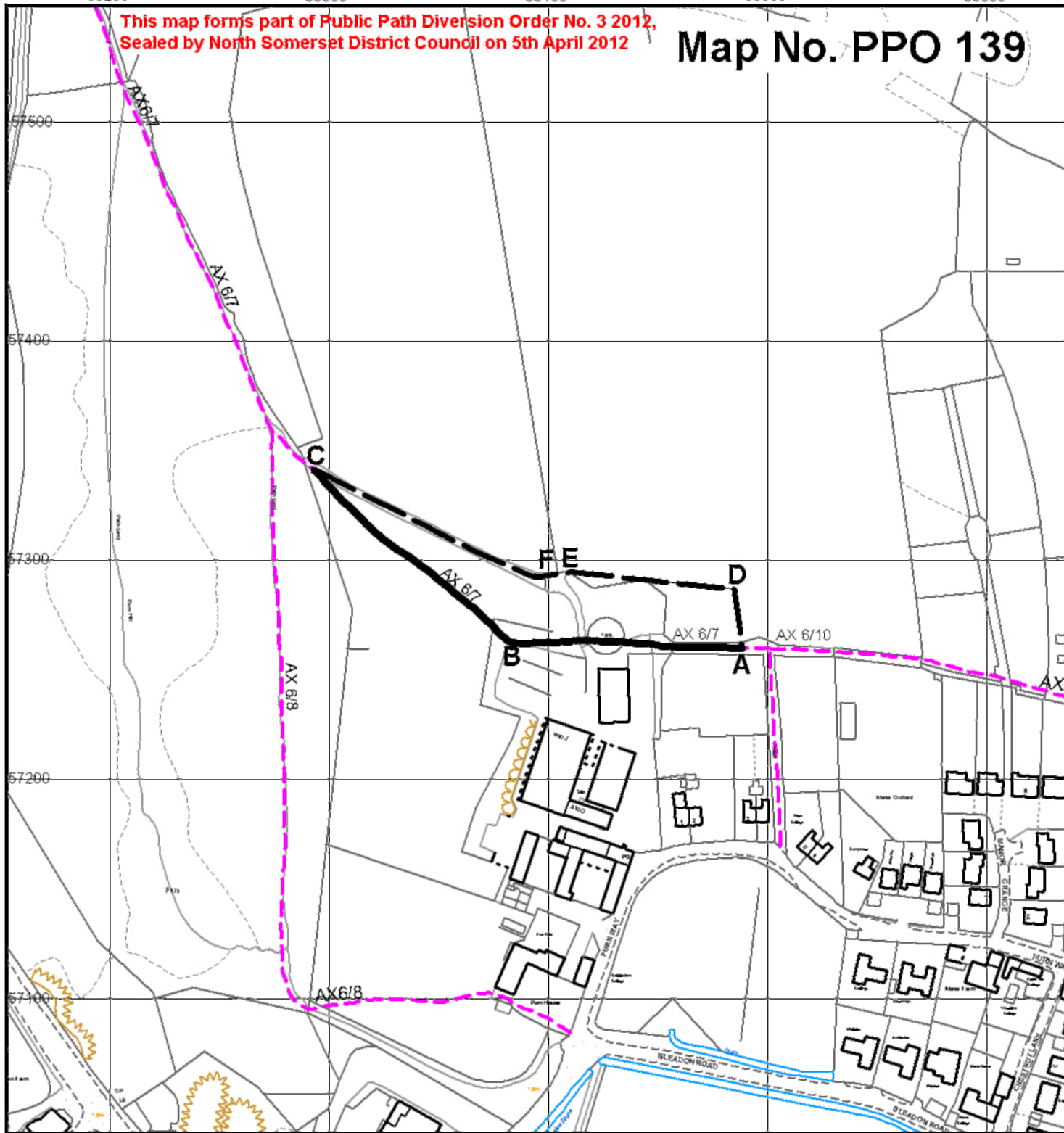

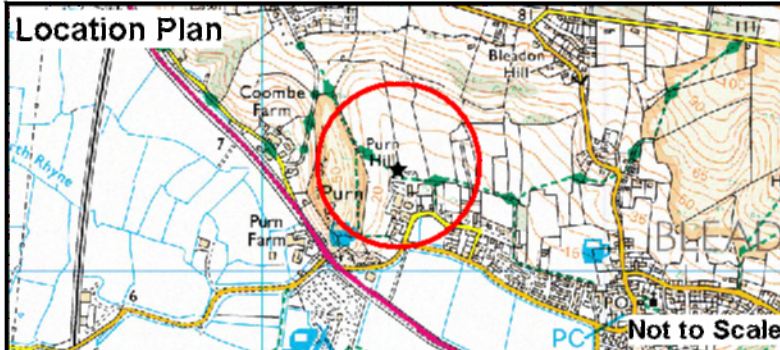
