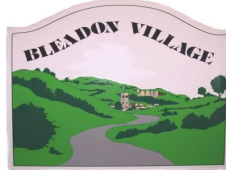

Councillor Mary Sheppard noted her concern of a newly installed 5 Bar Gate at next to Curry Cottage. Clerk was asked to investigate.

The Council noted with satisfaction what action North Somerset was taking in respect to fly tipping and placement of stones on Roman Road.
