## 181.2 Minutes

## 181.3 Matters Arising

(1) Matters raised by the Public

(a) Dropped Pavements

Cllr Mrs Robinson reported on her conversation with Mr Phil Bush (North Somerset Council). It was agreed that work to drop the main kerb on the corner of School Lane be requested and that application should be made to North Somerset for the remainder in the next financial year.

(2) Tarmacadam Quotations

Work is scheduled to commence on 15 February subject to satisfactory weather conditions. Notices to close the car Park will be displayed

(3) Churchyard Path

Cracks in the tarmac path have been caused by tree roots. The Clerk was requested to write to the PCC requesting they engage an arborist to undertake the necessary work to stop further damage. The Parish Council would then review matters.
