Final funding allocations for the local transport authorities of the active travel fund. The grant funding supports local transport authorities with producing cycling and walking facilities. The funding is in 2 transhes:

- tranche 1 supports the installation of temporary projects for the COVID-19 pandemic
- tranche 2 supports the creation of longer-term projects

The funding was announced by the Secretary of State on 23 May 2020 (https://www.gov.uk/government/news/transport-secretary-announces-new-measures-to-keep-passengers-safe-now-and-level-up-for-the-future) as part of the work to combat the COVID-19 pandemic.
