Temporary signs to guide traffic to COVID-19 vaccination centres

COVID-19 vaccination signs produced for use in your traffic areas. The use of these signs allows a local authority to meet their duty under the Road Traffic Regulation Act (RTRA) 1984 (https://www.legislation.gov.uk/ukpga/1984/27/contents) and will bring a degree of national consistency.
