Your guide to council tax

This leaflet provides information about the budgets for local public services for the year ahead and explains your council tax bill.

Depending on your household income, you may be eligible for help with paying your bill (see page 12 for more information).

In North Somerset we pride ourselves on our low council tax levels and have frozen council tax for three out of the last five years while also saving £60m from the council's overall expenditure since 2010. However, the national issue of ongoing increases in demand on adult social care and reductions in the amount of funding the council receives from central government mean that there will be a council tax increase for the year ahead.

The change in government policy for the funding of social care has led to a 3 per cent levy being applied to council tax bills, along with a general council tax increase of 1.75 per cent as a result of reduced central government funding.

We will continue to do our best to keep council tax in North Somerset below average and we remain committed to providing excellent value for money through the services we deliver.

What is council tax?

It's a local property tax levied by councils to top up central government funding of the local services they provide.

What does it pay for?

North Somerset Council provides a wide range of services including education, planning, transport, highways, social care, public health, libraries, leisure and recreation, recycling and waste collection, environmental health and trading standards among many others. The money you pay also funds the police and fire and rescue service, as well as supporting work in your local parish or town.

Parish and town councils raise their money primarily from a levy called a precept. We collect the precept on behalf of town and parish councils and pass it on to them.

Who decides how much I have to pay?

Council tax is based on property value. Every property is put into a banding and charged accordingly after certain other factors are taken into account.

Adult Social Care Precept

The Secretary of State for Communities and Local Government has made an offer to councils with responsibilities for adult social care.

The offer is the option of being able to charge an additional "precept" on council tax from 2016 without holding a referendum, to assist the council in meeting expenditure on adult social care. Subject to the annual approval of the House of Commons, the Secretary of State intends to offer the option of charging this "precept" at an appropriate level in each financial year up to and including the financial year 2019-20.

For councils with responsibilities for adult social care, council tax demand notices show two percentage changes: one for the part of the overall change attributable to the adult social care precept, and one for the part attributable to general expenditure.

Where does the money go?

The table below shows how the money will be spent on services and how that relates to the average council tax bill.

Council tax and housing benefits have gone digital

The council tax and benefit service is an online service. To access these services you must register and create an account. Registration is quick, easy and secure and will allow you to apply for benefits, discounts and exemptions. You can also let us know about a change of circumstances or a change of address, set up a direct debit or just view your account balance.

Going digital means we can process many of your requests earlier and provided any additional documents are submitted with your application, you may receive your benefit earlier. For those customers who may have difficulty getting online or have additional needs, support is available. Please visit us at the Town Hall, Weston-super-Mare, visit one of our libraries or call us on **01934 888 144** and one of our customer service advisers will assist you.

Help with your bill

Council tax support

If you are on a low income and currently pay council tax, you may be eligible for council tax support even if you receive other benefits or council tax discounts.



Please visit our website to register for MyAccount and make your application online. If you are unable to get online or have additional needs please visit us at the Town Hall, Weston-super-Mare where one of our customer service advisers will assist you.

You can also visit any of our libraries and use one of the public access computers to make your application.

If you receive council tax support an amount will be taken off the total council tax you owe for the year and this is shown on the front of your bill.



What to do if your circumstances change

If your circumstances change you must tell us as soon as the changes happen. It is an offence not to tell us about any change in your circumstances that affects your support and could result in a fine of £70 or prosecution. Don't rely on someone else to pass the message on. Examples of changes in circumstances are:

- you move home
- your rent changes
- any changes to the income or circumstances of anyone who lives with you
- someone moves into or out of your home
- you're going to be away from your home for more than four weeks.

You can request a written statement of your entitlement, within one month of the decision being made, by contacting the council on 01934 888 144. If you want to appeal, this should be in writing within two months of the decision, to the council, who will review the decision. If you remain dissatisfied a further appeal can be made to the Valuation Tribunal.

More help with your bill

Even if you are not eligible for council tax support based on your income and savings there are other ways to reduce your bill:

Exemptions

Some properties will be exempt from council tax altogether, for example if you are living elsewhere to receive personal care, or if you have gone to live in a care home.

Disability reduction scheme

Your property may be placed in a lower band if it has features such as extra space for a wheelchair.

Discounts

Some bills can be reduced by up to 50 per cent. There is a 25 per cent discount for all properties where only one person is a resident.



CHANGES IN SPENDING

The net expenditure for the police will be £2m higher in 2017/18 compared to 2016/17 following a 1.4% reduction in central government funding offset by a rise in council tax funding. The Police & Crime Commissioner (PCC) has taken the decision to increase the policing part of the council tax by £3.55 a year for the average band D household. This means that the average band D precept will be £181.81. This follows extensive consultation with over 3,000 residents. Although inflation and other unavoidable spending pressures will increase costs by £10m, savings have been agreed to balance the budget.

The PCC also receives ± 1.95 million funding for victims services from the Ministry of Justice and this has been retained at the same level as 2016/17.

STRENGTHEN AND IMPROVE YOUR LOCAL POLICING TEAMS


Sue wants the police to be accessible and tackle the crime that matters most to you.

Your fire and rescue service

Avon Fire & Rescue Service (AF&RS) protects the communities of Bath & North East Somerset, Bristol, North Somerset and South Gloucestershire.

This service costs the average Band D household $\pounds 69.28$ a year – or around $\pounds 1.33$ a week.

This year we have increased the precept, or the amount we ask for from the average home, by a total of £1.35 a year which is a rise of less than 3p a week. Despite this rise, Avon Fire Authority's precept remains among the lowest in the country.

We also receive around a third of our funding from central Government. The grant we receive has fallen in recent years and will continue to reduce.

As a result, savings of £5 million will need to be made over the next three years which means we will continue to implement plans to allow us to provide a first-class emergency service with a smaller budget.

Following a public consultation we have now published our Integrated Risk

Management Plan (IRMP) which outlines how we will use our resources to respond to a wide range of local and national risks up until 2020.


This plan included a number of changes to the way we deliver our frontline services which will allow us to reduce costs but maintain our existing response standards.

As part of our cost saving plans the Headquarters of Avon Fire & Rescue Service will also move from the centre of Bristol to the site of the Avon and Somerset Constabulary Headquarters at Portishead. As well as reducing running costs the move will allow for closer collaboration in a number of areas.

Although we are making changes to the way we deliver our services, ensuring the safety of local people remains our focus.

PROVIDING AVON FIRE & RESCUE SERVICE

Annual budget

Avon Fire Authority has set its net budget for 2017/18 at £42.067 million. This represents a Council Tax level of £69.28 a year for a Band D property, an increase of just below 2%.

The Government's funding assessment for Avon Fire Authority has been cut by \pounds 1.741m (9.35%) to \pounds 16.888m for 2017/18. The impact of this is that the funding provided by central Government is reduced by \pounds 1.492m (10.7%) to \pounds 12.457m.
