The summer is almost over and it hasn't been kind to many growers and farmers. However, we may be able to enjoy a better autumn before the clocks return to normal.

Speaking of which, you will have noticed the clockface on the church has been removed and taken away for regilding. We, the Parish Council, have been promised it will be ready and installed in October.

You will have seen the progress taking place at the old quarry site, with the show home now open. Negotiations regarding the play area equipment are taking place between North Somerset Council and our clerk, and will be discussed at our next council meeting. Comments would be helpful for future improvements to the play areas.

I am pleased to report that the layby at the east end of Roman Road has been upgraded and looks much tidier. Let us hope it does not get damaged by people doing wheelies. Our thanks goes to the Mendip Hills for contributing £2,000 for the project.

The footpath from Rectory Lane to Purn Hill has been resurfaced by Edenstone and looks to be better for walkers during the winter. Thank you. Unfortunately, not all the landowners gave their consent for this to be done, hence a gap in the middle.

The most recent improvement is the Jubilee Garden walls and the widening of the pavement next to the Gent's lavatories. This will be resurfaced making it safer and easier for pedestrians and buggies alike.

Have you thought about becoming a Parish Councillor?

The Parish Council currently has three vacancies for Parish Councillors. All Councillors volunteer their time to work hard on behalf of parishioners, much of which is carried out behind the scenes and often goes unrecognised. However, I hope they would say that it is a rewarding task.

Parish Councils don't have many statutory duties but they do have quite a lot of powers and can exercise those powers for the benefit of parishioners – you might be surprised to learn the extent of the Council's powers. The Parish Council also manages a sizeable budget and – together with parishioners – can exercise influence over the District Council and other statutory bodies.

If you are interested in becoming a Councillor you would go through a process of co-option (rather than election). This would involve you attending at least two meetings of the Council (as an observer) and then submitting yourself for co-option at a parish council meeting. This would then be voted upon by existing Councillors. If accepted, you will be asked to sign a Declaration of Acceptance of Office form, and take up the position as a holder of public office in a local authority, albeit unpaid, with all the responsibility that comes with it. Our Developing Parish

The time is drawing near when the first residents of Eden's Green arrive. In the last issue I wrote about some of the improvements they will find in Bleadon that have taken place in the thirty-seven years we have lived here, ending with the positive changes at the Queen's Arms. It is only fair, however, to record a negative change made there soon after Butcombe took over, namely the removal of the skittle alley. The fact that there is no longer anywhere in Bleadon to play skittles has to be counted as a loss, and I know a good number of locals who would endorse that.

Let us get back to the positive. From 1987 till 2000 Glenise and I ran the village shop and post office in what is now a private house just in front of the church. When the then owners closed it at Christmas 2003 everyone was worried that the village would lose this amenity. Out of the blue Alistair House rode to the rescue, converting farm buildings to provide a bigger and better replacement, with the addition of a cafe and function room. This could never have been done at the old premises, and I welcome the sight of people eating and drinking outside when I collect my daily newspaper. It is worth noting that today's post office offers a much wider range of facilities than the one in 2000, and the traditional butcher's shop now flourishing there is a really exceptional feature.

Another exceptional feature of quite a different kind is the croquet field opposite the cafe. The Weston club relocated there from a town park and its membership shot up, including a number of local residents. I gather it is not an expensive sport, and I like to see this activity on sunny days in season. Compare this with a better known sport now available in Bleadon - golf. The nine hole course on Roman Road has offered recreation and social life to a surprising number of locals, leading to greatly increased sales at the Queen's on Tuesday evenings. The lack of a membership requirement is a considerable advantage. Interestingly, up to WW2 Roman Road was called Golf Course Road, being home to an eighteen hole course. The latter was taken over for defence purposes during the war and did not re-open. The recent replacement is undoubtedly an asset to Bleadon.

Some improvements took place so long ago that we forget how things

used to be. It seems hard to believe that there were no dog bins, for example, or that there were no speed or weight limits on our roads. I remember when the speed limit on the A370 was 60 m.p.h. and there were no traffic islands or street lights by the Anchor. Things will never be perfect, but they can be far better than they used to be.

Newcomers in various waves since WW2 have contributed to life in Bleadon. The most recent influx was at Bleadon Mill in 1994 - thirty houses. The residents of that development have been enormously influential in various ways, helping to improve the village for everyone's benefit. It is remarkable how many of its original inhabitants are still there after thirty years. I hope these new residents will appreciate the improvements made by their predecessors and go on to make their own.

In and Around the Car Park

There's been quite a lot of activity in and around the car park over the last few weeks, with more planned for the months ahead.



The Jubilee Garden walls have been renovated with a new 'cock and hen' top to reflect the style of many of the surrounding walls. The wall itself required extensive rebuilding in some areas and we also took the opportunity to replace some of the brickbuilt sections with natural stone.

Over the coming months the planting area will be filled and replanted. A planting scheme has not yet been finalised but it will be a low level, low maintenance scheme with – as far as possible – year round colour and interest.



The Council also took the decision to try and address the access problems by the toilet block. With the support of the wall owners – and we would like to publicly say 'thank you' to the wall owners – we were able to both remove a section of wall which jutted out into the pavement and remove the large stone planters.

There is now unrestricted access for wheelchairs and buggies. The next stage of the works will be to level out and resurface the pavement area. The next stages of work will include looking at alternatives for the car parking barrier – which is looking a little tired – and tackling the overgrown areas to the rear of the Coronation Halls.

Next Years Budget & Precept Setting

Although we're only halfway through the current financial year, we've already started the planning for next financial year.

From the Parish Council's perspective, most of the variables which affected the budget for this year have been addressed so we hope to enter a period of stability. We've previously signalled that we would like to be in a position to freeze the Parish Council precept for the next 2/3 years and we will be entering into our budget discussions for next financial year on the presumption that there will be no rise in the local precept.

One of the issues we will be considering as part of the budget setting process is the likely impact of North Somerset Council budget cuts. North Somerset Council has indicated that it is under significant funding pressures which will force it to prioritise statutory services. As such, North Somerset Council has indicated a wish to discuss with Parish and Town Councils whether there are opportunities for different service delivery models to enable the continuation of non-statutory services.

Improving Play Provision

We also know that there is little in the way of accessible equipment for children with additional needs. As a consequence, we will formulate our proposals with these gaps in mind – whilst recognising that we are a relatively small Parish and don't have access to a lot of land!

Local Farming & Food Security Concerns



Residents have raised concerns with North Somerset Council about the reducing land available for food production.

North Somerset Council
Executive Meeting 17 July 2024
NSC ha declared a Nature and
Climate Emergency (2019). Food
production and its security
depend on both nature and the

climate. Therefore, a member of the public, addressed the Executive and asked it to declare a **Food Security Emergency.** See also NSC Youtube https://youtube.com/live/lJAlginS6Qg at 13:55 mins. The Chair, Cllr Bell, stated that an Executive member would be asked to contact him with a response.

Transport, Climate and Communities Policy and Scrutiny Panel 25th July 2024 – NSC's Climate Emergency Action Plan (pg 49) says, "Enclosed farmland makes up 68% of all land in North Somerset" It also goes on to say that the council needs to "Identify more areas of council land for re-wilding/management for biodiversity and manage 30% land for biodiversity by 2030" in order to replenish its carbon stores, along with planting "50,000 trees and introduce tall grass manage to 40 hectares of open space". Its Local Plan press release states "Around 85 per cent of our land is at risk from flooding, part of the Mendip Hills landscape, highquality Green Belt or protected in other ways for environmental or heritage reasons" Where will NSC permit the 23,805 dwellings proposed to be built in North Somerset over the next 15 years via its Local Plan? I asked the panel for an update on how local food production has been protected over the last eight months, and what the future plan is to protect it. The Chair, Cllr Bridger, stated that he will ask Cllrs Canniford and Waite for an update following my January meeting, where they proposed a Local Plan Supplementary Planning Document to the Local Plan.

North Somerset Council Health and Wellbeing Board 29 July 2024 – A member of the public addressed the board regarding diary, farming and nutrition of alternative food. She asked for information on the long term health effects of eating 'alternative' foods, with less dairy and meat. She also asked NSC to prioritise and protect farming, dairy production and related land, to deliver natural food that is key to health and wellbeing, and to include this in all North Somerset Council policies, plans and activities (including health education)

Affordable Housing Survey

All Bleadon households will shortly receive a survey form from a company called Arc4 regarding affordable housing needs. We realise that the temptation may be to think that this survey doesn't affect you or your family. However, we would urge you to take some time to look at the form and think about the long term needs for yourself and your family. For instance, you may be of an age where you are starting to think about more accessible housing e.g. a home without stairs or have teenage children and be thinking about whether there will be options for them to stay within the Parish in their own accommodation when they reach adulthood.

The outcome of the survey will help the Local Planning Authority (North Somerset Council) in assessing whether there are particular requirements which need to be addressed in the context of any future housing developments. If, for instance, there is sufficient evidence (through this type of survey) for particular types of property or models of home ownership, then the Local Planning Authority can require that developers build these into their plans.

Although the current version of the approved North Somerset Local Plan would not support significant housing development in the Parish, this position could change over time. In this event, being able to influence the type of housing is an opportunity we would urge residents to take.

Footpaths and Public Rights of Way



As the weather has improved people have been using the many footpaths and rights of way in and around the Parish. One of the questions we are often asked is 'who is responsible for clearing away vegetation and maintaining the footpaths?' The general 'rule of thumb' is that most footpaths are 'permissive' paths which cross over private land so landowners are responsible for, and need to be consulted about action affecting, their property.

However, North Somerset Council also has a responsibility for ensuring and maintaining access in respect of many of these footpaths as they are pedestrian highways. As such, North Somerset Council manages improvement and maintenance schemes across the network of footpaths. Two very recent examples of this work in and around the Parish are the works at South Hill, Purn Hill and the allotments.





Vegetation from neighbouring sites which has overgrown and is affecting the footpath is technically the responsibility of the neighbouring site. The same principle applies as it would in your own garden if your neighbour's plants are crossing your fence line – you are able to cut the plants back but the offcuts are technically their property. So, there is no problem with vegetation being cut back along footpaths as long as you respect the fact that the cuttings belong to somebody else.

In some cases, the vegetation growth is more than just a couple of brambles and we've had some reports of heavily overgrown areas in the vicinity of Shiplate Road and Roman Road. In these cases, the best thing to do is to report the issues direct to North Somerset Council using their online reporting tool https://forms.n-somerset.gov.uk/report-request/form/publicrightsofway#/1

Quarry Development Update

Churchyard Memorial Testing



As part of its responsibilities for maintaining the enclosed churchyard, the Parish Council must undertake 5 yearly tests of the memorials (headstones).

This was undertaken earlier in the Summer. The test involves checking the condition of the memorials and whether they are at risk of toppling if sufficient force is applied.

Unfortunately, the test revealed that a number of memorials require work. The memorials are the responsibility of beneficiaries of the estates of the deceased. However, it is often hard to track down surviving family members. For this reason, notices have been placed adjacent to the memorials in question to ask anybody who might be affected by the outcomes of the testing to contact the Parish Council.

The responsibility of the Council is to make the memorials safe and the conventional way of doing this is to lay the memorials flat. However, this is something we'd rather not do as it feels a little disrespectful. So, we are looking at some different solutions and with the support of Reverend Erridge, we are in discussions with the Diocese of Bath & Wells to try and secure their support for solutions which would meet safety requirements and avoid laying down memorials.

The eagle-eyed among you will have noticed that the clock dial has been removed for restoration. It's fair to say that it's taken longer to get to this stage than originally anticipated but the restoration is now well underway.

When the dial was removed, we found a large dent on the raised rim. The mallet shaped dent would suggest that somebody missed when hammering in the fixings when the dial was last installed! We won't have this problem when it is reinstalled as it will be fixed in place with stainless steel screws and resins.

We're anticipating that the dial will be put back in place mid to late October – weather dependent!

Councillors are also making arrangements for a plaque to recognize the many public and business contributions.

Public Consultations & Resident Meetings

<u>National Consultation NPPF</u> - Deadline 11:45pm on 24 September 2024

The Ministry of Housing, Communities and Local Government states, "This consultation seeks views on our proposed approach to revising the National Planning Policy Framework in order to achieve sustainable growth in our planning system.

We are also seeking views on a series of wider policy proposals in relation to increasing planning fees, local plan intervention criteria and appropriate thresholds for certain Nationally Significant Infrastructure Projects."

This consultation, and resulting planning reform, will have 'major implications' for North Somerset Council's Local Plan, as indicated its press release below. which will affect all future development in Bleadon,

North Somerset Council Local Plan Press Release 31 July 2024

"Following the launch of consultation on the government's proposed planning reforms, North Somerset Council is reviewing its draft Local Plan. The plan – which was first consulted on in 2020 and has been shaped by three more rounds of public consultation – was set to go out for a final round of consultation later this year, before being submitted for independent examination. This consultation will not now take place, pending consideration of the updated government guidance and any further work which may be required.

Councillor Mark Canniford, North Somerset Council's executive member who is responsible for spatial planning, placemaking and economy, said: "The government's planning reforms have major implications for our proposed Local Plan. "The new standard method is 23,805 dwellings in North Somerset over the next 15 years – that's nearly 9,000 dwellings more than our current Local Plan target. This figure also doesn't take into account the needs of our neighbours, as the government has asked all

councils to work together to jointly address unmet need.

"In light of this, we will not be proceeding with our planned final consultation on the Local Plan. We're working hard to review our draft plan in the light of the government's announcements, and hope to progress this as quickly as we can. "As a council, we support the government's commitment to growth and meeting the housing need of our communities. All our communities will need to play a role in helping to meet this challenging housing requirement, and we'll work closely with them as we develop a revised plan.

"However, we want to create a Local Plan that also reflects the needs of our environment. Around 85 per cent of our land is at risk from flooding, part of the Mendip Hills landscape, high-quality Green Belt or protected in other ways for environmental or heritage reasons. This is a practical geographic constraint on the amount of development that's possible in North Somerset. "New homes also need to be supported with the right infrastructure, so communities have access to the services they want and need. We want to make sure that infrastructure challenges are being met before we consider further development.


"We appreciate that this has been a long process. It's really important that we get our Local Plan right, as this will shape development in our area for the next 15 years. Thank you to our residents for your patience, and to our officers for their continued hard work."


