

#### **Our Developing Parish**

It will not be long before the population of Bleadon increases by perhaps a hundred as the development of the Marshalls site in Bridge Road is completed. What kind of village will these newcomers find compared to the one Glenise and I encountered in 1987? As far as I am concerned it will be a considerably improved one.

When they walk out and turn left they will very soon come to Escape, now a much appreciated facility that did not exist in 1987. Turn the corner to the A370 and they will find a tarmac path leading to the bus stops, with a traffic island enabling a safe crossing of this busy main road. Most readers know that these were only recently provided - better late than never. The crossing gives walkers safe access to the footpath alongside the river, which many residents only discovered during lockdown and have treasured ever since. They will benefit from the new timber walkway, which does away with problems involving river levels, and be able to follow the river bank past Riverside, a delightful, peaceful route. They will not realise that this became possible only quite recently, when the present owners of Riverside reshaped the landscape and created the fishing lake, itself a pleasure to look at.

What if they turn right? They will come to the Coronation Halls, a village amenity that has been transformed in the thirty-seven years we have been here. In 1987 there was just the one hall, which looked decidedly tatty, and not much went on there. Now there are two, with very tidy exteriors and an impressive range of internal features, and a great deal goes on there. Part of this is due to new organisations being set up and becoming long-standing regular users: the short mat bowls club, the bridge club, Bleadon Players, keep fit classes, art classes, the W.I. and its choir. All these contributed to funds, and the icing on the cake has been provided for about twenty years by the monthly village markets.

On dark evenings they will be able to see their way round that area because of our street lights, of which there were none in 1987. I was a member of the parish council that installed these lights in batches over several years, and as I have grown older I have come to appreciate them more and more. The lighted area extends to the Queen's Arms, another village amenity which has improved over all through many ups and downs. In 1987 the pub

atmosphere was fine and the place was deservedly popular, but the interior was grotty. Heaven knows when the owners, Whitbread, had spent any money on it. About 1990 it became a free house, and the landlord set about the dingy old tap room to expose the old hearth and hack off the plaster, making it a very attractive room as it is today. He sold to a brewery, who predictably spent nothing, but it became a free house again when the Sanders bought it. They commissioned the merging of the two rooms at the other end into the present restaurant. The pub is certainly more up-market than it used to be, which is not to everyone's taste, but circumstances and the market have changed (think - all day opening) and you cannot run a business on nostalgia.

The Parish Council has set aside £10,000 to improve play facilities across the Parish and is also actively exploring other funding opportunities to increase the amount of money available.


We would really like your views on the sorts of things we could do to improve play facilities for children and young people in the Parish – even better would be to get the views of children and young people themselves!

#### **Dog Bins**

The Council currently has 5 bespoke dog bins across the Parish and there are two general litter bins which can also be used for dog waste. The cost of emptying these bins is more than £2,000 per year, so we want to be sure that we're spending this money wisely and that the dog bins are in the right locations and being emptied at the right intervals.

As a consequence, Councillors will be looking at this issue over the coming weeks. #### **Jubilee Gardens Wall and Planter**

The Jubilee Gardens planter was emptied earlier in the year to enable the Council to assess the state of the natural stone wall along the boundary of the car park. Although stable, the wall does need some work – particularly to the inside face of the wall. A tendering exercise has been completed and the Council has awarded a contract to undertake works to the wall to a Weston based firm of Stonemasons. The work will involve remedial work where there are some bulges, significant re-mortaring and a new 'cock and hen' capping to reflect the finish on other walls within the vicinity. The curved section of the wall entering the car park will also be rebuilt out of natural stone as it is currently a mismatch of different bricks. The works will involve the use of traditional lime mortar.

Because of this, the works will be scheduled for September – as the Summer is not the best time to apply lime mortar. In the meantime, the Council would like to hear from anybody who has thoughts or ideas in relation to the future planting scheme for Jubilee Gardens. The planting scheme proposals will be developed by the Council's Open Spaces Working Group which meets once a month. This is usually on the third Thursday of each month and alternates between a morning and evening meeting. #### Planning applications

The Parish Council receives a weekly register of applications within its boundary. Site visits are arranged and we try to speak to applicants and other affected parties The applications are considered by the Council and anybody has the right to attend and listen to the Council's deliberations. The Council can support, object or simply note an application. If it objects, it should give reasons for objecting.

The Parish Council is a consultee, so its decisions aren't binding and it is North Somerset Council which makes the final decision. We have had an interesting and diverse year - along with a selection of the normal extensions and conversions a few more interesting ones have come our way- equestrian buildings, a dog boarding business, listed buildings and a livestock building to name a few. This year we received 50.

Applications from NSC – 14 of these were requests to discharge conditions previously imposed by NSC (mainly from Bleadon Quarry). Almost all of our recommendations have been in accord with NSC. Sincere thanks to all the Parishioners whose doorsteps we have turned up on unannounced, whose friendliness and helpfulness have helped us enormously in our task.

#### Parish Precept and Budget for 2024/25


At the 2023/24 financial year end, recorded expenditure was £70,664, against a budget of £85,454. The primary reasons for the difference in actual spend against budget can be summarised as follows:

- Known delays in the project to regild the Parish Clock
- Works undertaken in the 2023/24 financial year being invoiced in 2024/25 (or the Council's payment arrangements falling in 2024/25)
- Efficiency measures introduced by the Council mid-way through the financial year to reduce expenditure and redirect funds to other priorities.

The budget for the 2024/25 financial year has been set at £145,387. The main reason for the increase relates to a number of projects the Council has initiated. These projects are largely funded from the Community Infrastructure Levy (which is funding the Parish Council receives as a consequence of residential developments within the Parish boundary) and some successful funding applications. We set out the full range of projects in the last edition of Parish News.

The general day to day running of the Council is funded by way of the Parish Precept. The Precept for 2024/25 increased by 4% from the previous year to £67,800. This increase was half the average level of increase for Town and Parish Councils across the former Avon area.

In setting the budget for 2024/25 the Council took a conscious decision to reduce the amount of money it spends upon administration and increase the amount of money available to support improvements in and around the Parish. The graph below provides a simple summary of the change in emphasis and funding from last financial year to this one.

#### **Bleadon Midsummer Fest**

#### **Report on What Instead Meeting**

A "WHAT INSTEAD" (of the May Day Fayre) Meeting was held on Wednesday 22nd May to discuss and exchange ideas about community event/s in Bleadon for 2024.

Individuals and representatives of local businesses/organisations were all invited as was anyone who wished to be involved in some way. There was a really good turn out which was very encouraging and lots of suggestions for various events this year leading to more ambitious events in 2025, which will take more planning.

It seemed bringing the community together was more meaningful than the fundraising aspect, although this is always a welcome bonus! The consensus seemed to be a series of events (rather than a one day affair) over a period of time, beginning Saturday 31st August 2024 with The Horticultural Show in the Coronation Hall and an Art Exhibition to run simultaneously in the Jubilee Room. Other suggestions, going forward, were Bleadon Church to organise something in the Church, Harvest Home (Sept/Oct), looking to a larger event in 2025. The Queens have offered to possibly organise a BBQ or Hog Roast but also a live music event. A scarecrow competition was also suggested.

#### **Bleadon Church Report**

Did you know that as your Parochial Church Council we are required to produce an Annual Report which is made available to all members on our electoral roll?

This year we thought we would also like to include the local community in



the distribution so that they too know what, as a church, we have done throughout the year for the village.

As the annual report is a very lengthy document we have tried in this article to let as many people as possible know what we have been doing.

The report covers the church's activities regarding worship, membership, financial challenges, building upkeep, new community outreach efforts and environmental initiatives during 2023.

A new Reader, David Hughes was licensed in October. He not only takes on some of our services but has become Church Treasurer transitioning to a new accounting system.

Membership recorded on the Electoral Roll went down this year but we have some new villagers joining us at services and we hope they will become permanent members of our community.

A variety of worship services were held during the year with the average attendance being 20 for regular Sunday services. For other services of celebration e.g. the Civic Coronation Service, the Civic Remembrance Day service and the Christmas Crib Service, we were delighted that numbers filled the church.

Fundraising activities for the village, included our contribution to the modified May Fayre, a sold out Richard Lennox concert in the church, a Christmas Bazaar and several coffee mornings raising funds for the church and a variety of charities we supported. This year we raised over £2000 for them.

A variety of new initiatives included setting up a community warming space in the church room for the needy during the coldest winter months, a caring and sharing group for carers, increased social media presence and an eco church programme which was part of a Bronze medal winning award.

The churchyard volunteers continued maintenance work and received an award from the Royal Horticultural Society.

Partnership with Bleadon in Bloom allowed growing and sharing of fruit and vegetables. Boxes of these were delivered weekly to the Food Bank at Bournville from the end of May to September and boxes were also left in the church porch during this period for any villagers to pick up.

Our church building is a beautiful village landmark and has been for over 700 years. It is a Grade 1 listed building so we as a church have a requirement and duty to provide ongoing care and maintenance. This has to come from our limited resources raised from church collections, donations and fundraising activities.

This year we carried out an electrical survey, an investigation into the safety of the bell frame in the tower, radiator removal and general repairs and ongoing health and safety issues.

We just wanted to give you a brief picture of what your village church of St Peter and St Paul have to do each year to help keep us open for the needs of the whole village.

This is your church, why not come and be part of it and keep it going as a beautiful village centre.

#### **Hellenge Hill Nature Recovery Project Proposal**

Avon Wildlife Trust is looking to secure up to £50K to enhance this popular site in the local community. The calcareous grassland of Hellenge Hill supports rare plants such as honewort and Somerset hair-grass which are only found on the hot southern scarp of the Mendips. Look out also for green-winged orchid, common broomrape, yellow-wort, carline thistle and autumn lady's tresses. Gorse and hawthorn provide good habitat for birds and invertebrates. You may see adders basking on the slopes. Hellenge Hill is a Site of Nature Conservation Interest (SNCI). The reserve was purchased with funding from HLF, Wyvern Waste and public donation.

# Your Chance to View Bleadon Parish Council's Governance and Accountability

Commencing on 4th June 2024 and Ending on 15th July 2024

The AGAR or Annual Governance and Accountability Return is a set of documents and financial statements that local councils are required to prepare and submit each year. It is an essential part of the external audit process and ensures public transparency of the council's decision making processes and financial spending.

The AGAR typically consists of various sections, including the Annual Governance Statement, Accounting Statements, and an Internal Audit Report. Each section requires specific information related to the council's governance arrangements, financial transactions, assets and liabilities, income and expenditure, and other relevant details.

Any person interested has the right to inspect and make copies of the accounting records for the financial year to which the audit relates and all books, deeds, contracts, bills, vouchers, receipts and other documents relating to those records must be made available for inspection by any person interested. For the year ended 31 March 2024, these documents will be available on reasonable notice by application to the clerk.
