## Consultation subject

The Food Standards Agency (FSA) was seeking stakeholder comments on a proposed legislated transitional period under the novel food regulations for edible insects in England, Scotland and Wales. The proposal was developed with input from Food Standards Scotland (FSS).

In Northern Ireland, edible insects are considered novel under EU Food Law, as applied under the current terms of the Protocol on Ireland/Northern Ireland (NIP), require authorisation in line with [Regulation \(EU\) 2015/2283](#), before being placed on the market in Northern Ireland. It is the European Commission's authorisation process, including validation, that applies in Northern Ireland.

## Purpose of the consultation

The Food Standards Agency (FSA) had reviewed the policy approach to authorisation of certain edible insects in Great Britain (GB) within scope of the existing transitional measures in the

novel food regulations retained from the European Union (EU) (see specifically Article 35(2) of [retained Regulation \(EU\) 2015/2283](#) ).

The consultation sought comments from industry, enforcement authorities, and other interested stakeholders on the policy proposal to introduce a legislated transitional measure, specific to GB, which will clarify the arrangements for businesses seeking a novel food authorisation for their edible insect product.
