



To ensure candidates have confidence that the process is well-managed, and have confidence in the results


Transparent process (attendance at postal vote opening sessions, the verification and the count)






### **Qualifications**

Candidates must satisfy the following criteria on the day they are nominated and on polling day.

- be at least 18 years old
- be a British citizen, an eligible Commonwealth citizen or a citizen of any member state of the European Union, and
- meet at least one of the following four qualifications:
  - a. Registered as a local government elector for the electoral area in which you wish to stand from the day of your nomination onwards.
  - b. Occupied as owner or tenant any land or other premises in the electoral area during the whole of the 12 months before the day of your nomination and the day of election.
  - c. Main or only place of work during the 12 months prior to the day of your nomination and the day of election has been in the electoral area
  - d. Have lived in the electoral area [or within three miles of it during the whole of the 12 months before the day of your nomination and the day of election (parish only)]

It is a matter for the candidate to determine their own eligibility and if necessary take advice from their party, the Electoral Commission or even their own personal legal advice.






### **Disqualifications**

A person **cannot** be a candidate if they:

- > are employed by the local authority
- are subject of a Bankruptcy Restrictions Order (or interim restrictions order) in England or Wales
- have been sentenced to certain terms of imprisonment
- are serving a disqualification due to being found guilty of a corrupt or illegal practice by an election court
- ▶ hold a politically restricted post (NB political restrictions do not apply to parish council elections)

The Returning Officer will not be able to confirm whether or not candidates are disqualified.

# The nomination forms

Bespoke nomination forms for each District ward or Parish (or Parish ward if warded) are available on our website.

To avoid any issues please submit packs in their entirety, whether you think the pages are relevant or not. This includes;

- the nomination form (1a)
- their home address form (1b) (part 1 AND part 2)
- > the candidate's consent to nomination (1c) (including pages 2, 3 and 4 of the legislation)

Party candidates will also need to submit;

A certificate authorising the use of a party name / registered description on the ballot paper (form 2)

A written request to use one of the party's emblems on the ballot paper [optional] (form 3)

### Candidates' details

- > Full names must be added (no initials).
- > Prefixes like Sir or suffixes like Snr must not be used -
- ➤ It is not vital to complete titles as they will not appear on the ballot paper.
- A candidate can request to use a commonly used forename, surname or both
- A candidate cannot use their first name as a commonly used name in order to exclude the use of their middle name.
- Whilst commonly used names will be taken at face value, it can be rejected if its use may be likely to mislead or confuse electors, or it is obscene or offensive
- Description field 4 options:
  - 1.) leave blank
  - 2.) Independent
  - 3.) a description not exceeding six words (parish only)
- 4.) party candidates can use party name or description authorised by a certificate issued by or on behalf of the Party's Nominating Officer

- ➤ 2 subscribers who must sign and print their names <u>AFTER</u> the name, address and description field have been completed.
- Legislation has reduced the number of required signatures for a District nomination paper from 10 to 2
- Please ensure that the subscribers are aware of what their personal data will be used for.
- Must be registered electors in the relevant electoral area i.e. the district ward, parish, or parish ward (if warded). Elector number request forms and register request forms will be available on our website and can be emailed to <u>candidates@n-somerset.gov.uk</u>
- ➤ We are only able to provide registers from Monday 27 March. If elector numbers are required sooner then please use the elector number request form.

#### Certificate of authorisation

To accompany the nomination of a candidate standing on behalf of a registered political party. (Note: candidates standing on behalf of two or more parties require a certificate from each party and each must allow the same registered joint description to be used).

This certificate must be issued by the registered Nominating Officer of the party or by a person authorised to sign on their behalf.

This certificate authorises the candidate to use a specific registered description or the name of the party as registered with the Electoral Commission, or to use 'any registered description or the party name as registered with the Electoral Commission'.

This authorised party name or description can then be included by the candidate on the nomination form. It is this which will appear as their description on the ballot paper. Party names and registered descriptions are listed on the Electoral Commission's website.

This form is only effective if delivered for a candidate standing on behalf of a political party to the Returning Officer by no later than 4pm on the last day to deliver nominations.

Candidates standing on behalf of more than one political party and using a joint description may choose one emblem from one of the parties that you are standing for. Please indicate the name of the party and the emblem name in the 'Emblem to be used' box above.

- Party candidates can ask for an emblem to be printed on the ballot paper
- Candidates who use a party description can have an emblem. Candidates must ask for it themselves, and should look at EC website and use the description of the one they want. The relevant ID number associated with that emblem is to be added to the form.
- > The candidate must give their full name and sign and date the form.

If no election agent is appointed, the candidate is deemed to be their own agent

- ➤ The Election Agent (only applicable at District elections) is responsible for the proper management of your election campaign, particularly its financial management.
- Notification of appointment must reach the Returning Officer by 4pm on Tuesday 4<sup>th</sup> April. The form is included in district nomination pack only.
- You will become your own agent by default if none is appointed.
- The form must include the candidates full name, the name and full address of the election agent, their office address and be signed by both the candidate and the agent.



# Access to electoral register/absent voting lists

Access by candidates – once you officially become a candidate:

- earliest, on Monday 27<sup>th</sup> March if you, or others declared yourself a candidate
- once you or others have declared yourself a candidate after this date / date you submit your nomination papers

Make written request to the ERO – request forms are available on our website.

We can supply elector numbers to enable you to complete your nomination paper – request forms are available on our website



# Informal checks of nomination forms


- > We will be offering an informal checking service, by appointment only
- ➤ This service provides an opportunity for any errors / omissions to be identified prior to formal submission
- Can be done in person, on Microsoft teams or over the telephone (if emailed in advance)
- Staff will only be checking to see that the nomination paper is in good form, and will not be able to offer any legal advice
- > Appointments can be made by emailing <a href="mailto:candidates@n-somerset.gov.uk">candidates@n-somerset.gov.uk</a>





# Submitting nomination forms

- We strongly advise that nomination papers are completed and submitted as early as possible during the nomination period, but no later than 4pm on Tuesday 4 April 2023
- ➤ Completed nominations must be delivered by hand to the Returning Officer at North Somerset Council, Town Hall, Walliscote Grove Road, Weston-super-Mare BS23 1UJ between 10am and 4pm on any weekday between Tuesday 21 March 2023 and Tuesday 4 April 2023. There will be a desk in the gateway dedicated to receiving them.
- This is the only place where nomination papers can be formally submitted
- Whilst the certificate of authorisation and emblem request form can be submitted by post, we will not be holding part papers on file.
- ➤ No prior appointment for submission is required. However, be prepared for a wait time in the event of queues. A receipt will be issued, which we advise should be safely retained
- There are no restrictions on who can deliver the nomination forms, nor on how many can be delivered at one time.
- Submissions will be processed strictly in receipt order and, if multiple, in bundle order
- ➤ We are cannot discuss any other nominations that have been handed in, so please don't ask!





### **Contested v Uncontested Elections**

- ➤ A poll will only be held should there be more valid nominations than there are number of vacancies (contested)
- ➤ Should we receive fewer nominations than there are vacancies then those candidates will be elected uncontested the Parish Council may then proceed to fill the remaining vacancies by co-option, provided there is a quorum (uncontested).
- ➤ If there are insufficient valid nominations to make a quorum then any validly nominated candidates are declared elected uncontested and the Returning Officer shall order a new election to fill any remaining vacancies within 35 working days beginning with the original day of the election (RPA1983 s39).
- ➤ It is suggested that there is to be a minimum of two re-runs of the election before North Somerset Council appoints persons to fill all or any of the vacancies until other councillors are elected and take up office. (s91 LGA 1972)



### Elections Act 2022 – summary of key changes


### In place for the local elections on Thursday 4 May 2023

- Introduction of photographic Voter ID for electors voting at polling stations
- Electoral Registration Officers (EROs) to issue free voter identification to anyone entitled following a valid application
- Accessible voting general responsibility to take reasonable steps to support electors with disabilities

### Phased introduction post scheduled May 2023 elections

- Restrictions on postal vote handling
- Online postal vote application service
- Overseas electors removal of 15-year rule
- EU Citizens end of automatic rights
- Voting System move to 'first past the post' for PCC elections
- Parliamentary oversight of the Electoral Commission

### Voter ID

### Requirement for photographic voter ID in polling stations

Electors will have to show an approved form of photo identification before voting.

No ID = No vote

No exceptions

A wide range of photographic identification will be accepted, including:


- Various concessionary travel passes
- PASS cards
- Ministry of Defence identity cards
- Photocard parking permits issued as part of the Blue Badge scheme
- Driver's licenses
- Passports

Expired ID will also be accepted (provided the photograph is of a good enough likeness)

If the elector cannot provide one of the required forms of identification, they will be able to apply for a free Voter Authority Certificate from their Electoral Registration Officer.

The online application process opened on 16 January 2023 accessed via the gov.uk portal.

The deadline to apply for a Voter Authority Certificate is 5pm on Tuesday 25 April 2023.






