The Covid-19 vaccination is now being rolled out.

It is our best defence against the virus used alongside effective social distancing, wearing a mask and washing your hands.

We are now looking for people who wish to play their part and join the Covid-19 Vaccine Team and there are several roles available.

About these roles

Covid-19 Vaccine Team opportunities include:

- Covid-19 Vaccination Programme Vaccinator
- Covid-19 Vaccination Programme Registered Health Care Professional (Immunisations)
- Covid-19 Vaccination Programme RHCP Clinical Supervisor (Immunisations)

In these crucial roles, you will work as part of a dynamic team in delivering a safe and effective service for the mass delivery of vaccinations of the COVID-19 vaccine(s). You will be responsible for administering or supervising the vaccine to citizens, working within a team of staff in vaccination sites.

Who are we looking for?

To perform in one of these roles:

- You do not need to be a current NHS healthcare professional, as full training will be provided.
- Please note, you will need healthcare experience for the Healthcare Professional and Clinical Supervisor roles only vaccine specific training is provided.
- You will need to show commitment and willingness to complete the appropriate learning and development courses
 as required, to demonstrate the right capabilities for the positions. This will include vaccine training, administration
 training and NHS statutory and mandatory training.
- Working as part of a team (including experienced clinicians) and as a strong communicator with good people skills, you will be able to discuss relevant information with service users, displaying empathy and reassurance at all times.
- You will also be expected to maintain and record accurate documentation of interactions between clients, colleagues, and other relevant agencies to ensure the smooth running of the service.

What will you be doing?

You will take part in comprehensive training including rigorous supervision and assessments for vaccinators. Once you are fully vetted and trained, with the relevant compliance and checks completed, you will be responsible for performing and/or supervising the following:

- Set up/configuration of the vaccination station
- Drawing up and preparation of the vaccine prior to administration
- · Vaccine administration, using the National Protocol
- Disposal of clinical waste and change of PPE as per national guidelines
- Adherence to infection control practices between individuals

Where will you be working?

These roles will be offered on a regional basis across England and, if successful, you will be given the opportunity to work at one or a number of local vaccination sites in your area.

When will the job start?

If you are successful in applying for one of these roles, you will be required to undergo pre-employment checks and a

What will you be paid and how long is the role for?*

- Covid-19 Vaccination Programme Vaccinator from £10.09 £11.19 p/hour (indicative)
- Covid-19 Vaccination Programme Registered Health Care Professional (Immunisations) from £12.74 p/hour (indicative)
- Covid-19 Vaccination Programme RHCP Clinical Supervisor (Immunisations) from £16.04 p/hour (indicative)

*Please note: for individuals working in London and areas just outside the pay rates will be supplemented with a high cost area supplement. Work undertaken on Sundays and public holidays will also attract an enhanced rate of pay.

These roles are based on a Fixed Term Contract for 3-6 months, but please be aware that due to the versatile nature of this programme, this term could be subject to change.

What is the application process?

Depending on the role you are applying for the process will include an application form, completion of vetting and work checks, occupational health screening and a short recorded video interview submission or clinical interview. You will be given access to complete all elements of the application process via the login process.

How do I apply for these roles?

Whatever role you are interested in, your contribution will be vital in fighting the pandemic in your community. You can read more about the roles on this website and if you believe you have the necessary skills and experience needed to perform one of these roles, you can apply by clicking on one of the job descriptions and then clicking the apply button which will take you to our dedicated National Vaccination Programme portal. Please note if you have previously filled in an Expression of Interest form, you do not need to apply again. We will keep you up to date about your application through the process.

As we are expecting to deal with a high level of interest in this programme, this website will be updated regularly with the latest information to help you with any questions you may have.

Prior to registration PLEASE NOTE the following:

- If you currently work for the NHS (substantively, via NHS Professionals, another bank provider or an agency) please do NOT apply. There will be an opportunity for you to support the vaccination programme but these roles will be available to you via your current NHS Trust who will be in touch at the appropriate time.
- If you have medical or healthcare experience that you feel is relevant but is not specifically referred to within the list of acceptable Registered Health Care Professionals you should apply for the Vaccinator level role.
- If you are not educated to NVQ Level 3/A-Level standard but have demonstrable and significant work experience in a healthcare setting we would like you to apply, but you will only be eligible for a Vaccinator level role.
- These roles are based in England. We can accept applications from individuals who do not live in England. Workers must live within a commutable distance of vaccination sites in England.
- If you realise you have made a mistake on your application after submission, please delete your profile and resubmit. Please note it may take up to 24 hours for your incorrect profile to be deleted before you can fill it in again and resubmit.
